Dear Director Mulvaney:

Today I approved a plan tasked by Congress in the National Defense Authorization Act for Fiscal Year 2017 (FY 2017 NDAA) that details a process for the Defense Security Service to assume responsibility for conducting background investigations for Department of Defense (DoD) personnel. The increasing backlog in background investigations is creating an unacceptable negative impact to DoD mission readiness and the acquisition of key weapon systems. It is thus my intent to develop and execute this plan as efficiently and effectively as possible.

Elements of the plan must be further developed and analyzed in close partnership with the National Background Investigations Bureau (NBIB) and the Security, Suitability, and Credentialing Executive Agents. Recognizing the complexity of such an undertaking, and the potential impacts across the Executive Branch. I have directed my staff to assemble a Cross-Functional Team of experts to expand on our existing work in a coordinated manner that does not disrupt the ongoing operations of NBIB. My intent is to look beyond the realm of incremental improvements and take full advantage of today's technology to alleviate the burdens of costly, time-intensive investigations that are hampering DoD mission readiness.

I have further directed my staff to work closely with NBIB and the Executive Agents to look for ways to reduce and mitigate the investigative backlog, while complying with national standards and promoting reciprocity across government. The Department recognizes that this issue not only affects the mission readiness of DoD, but that of the entire Federal Government. As options are developed and matured, they will be subjected to interagency review to ensure continued compliance with national policies, standards, and law.

I invite your attention and active participation in these efforts, for we cannot succeed without a close partnership with our colleagues from the Office of Management and Budget (OMB), Office of the Director of National Intelligence (ODNI), and Office of Personnel Management (OPM). My staff has established contact with counterparts in each agency and is ready to get to work.
