SUBJECT: Anthrax and Smallpox Vaccination of Embedded Journalists

- OSD (PA) has been working with the Joint Staff, U.S. Central Command and media bureau chiefs to embed about 400 journalists to deploying units if there is military action. Bureau chiefs have asked that DoD provide their journalists vaccinations not available to the general public.
- The ASD (HA), USD (P&R), and OGC have all concurred. OSD (ISP) and OSD (AT&L) have nonconcurred. They first want to prioritize all the individual requests DoD has received before approving our request.
- If the DoD is to embed reporters in combat units, journalists must be as ready as the troops with whom they deploy. While we understand the competing demands for available vaccines, it would be irresponsible to embed media with combat forces with a lesser level of protection. In the event media were to become casualties to an agent that our troops were inoculated against, they would encumber our combat forces and degrade their mission capability.
- Despite ISP and AT&L concerns, I endorse this vaccination request to provide force health protection measures on the same basis to embedded journalists.
- These vaccinations would be offered at no cost to the government. News
  organizations must agree to provide for indemnification for any adverse event
  arising from the use of these vaccines.

RECOMMENDATION: I recommend that you approve journalists' vaccination.

# MEMORANDUM FOR ASSISTANT SECRETARY OF DEFENSE FOR PUBLIC AFFAIRS

## SUBJECT: Vaccination of Embedded Journalists

The Department of Defense (DoD) supply of anthrax vaccine, smallpox vaccine, and vaccinia immune globulin is in limited supply and vaccination priorities are currently being developed for U.S. service members, other government agencies, Allies, and other foreign countries who have made requests for these products. Until a DoD decision is made regarding how to prioritize all of these individual requests, it is not possible to provide either vaccine or vaccinia immune globulin at this time.
