SUBJECT: Defense Intelligence Operations Coordination Center Establishment Directive

This memorandum directs immediate establishment of the Defense Intelligence Operations Coordination Center (DIOCC).

The DIOCC will integrate functions performed by the Defense Joint Intelligence Operations Center (DJIOC) and Joint Functional Component Command for Intelligence, Surveillance, and Reconnaissance (JFCC-ISR).

The first step in a broad effort to better coordinate defense and national intelligence capabilities and activities was the establishment of combatant command Joint Intelligence Operations Centers (JIOCs) and the Defense JIOC (D-JIOC) and their subsequent partnership with JFCC-ISR. The DIOCC represents the next evolutionary step to integrate those capabilities into a single, streamlined organization.

As DOD's lead organization for intelligence operations the DIOCC will plan, integrate, coordinate, direct, synchronize, and manage full-spectrum defense intelligence operations and capabilities, to include defense collection management and ISR, in support of the combatant commands to satisfy the priorities of the Department and the Nation. The integration of DJIOC and JFCC-ISR will streamline support to combatant commands by providing a consolidated defense intelligence interface. The DIOCC will facilitate shorter, more responsive decision cycles and will increase visibility across the defense intelligence enterprise.

The DIOCC will form a support relationship as an interagency partner with the National Intelligence Coordination Center (NIC-C). The DIOCC will align its operations with the NIC-C providing an integrated defense intelligence functional capability set that leverages the full range of Intelligence Community (IC), DoD, domestic, and coalition resources and activities.

At initial operational capability, DIOCC and JFCC-ISR will integrate functions and streamline processes to create unity of effort. At full operating capability (FOC) the DIOCC will be a fully integrated, functionally aligned organization executing extant

authorities. JFCC-ISR, as a U.S. Strategic Command (USSTRATCOM) functional component command, will integrate its functions while executing the Commander, USSTRATCOM's Unified Command Plan-assigned missions.

DIOCC will not fundamentally alter the authorities, responsibilities, and tasks assigned to combatant command JIOCs in the JIOC execute order (EXORD). The target date and appropriate criteria for DIOCC FOC will be directed by JS EXORD.
