Dear Secretary England:

I am writing to inquire about the status of federal funding to support development of the APIC Corporation's Mid-Pacific Photonics Prototyping Facility in Honolulu.

I recently visited the facility with members of my staff, and met with representatives of the APIC Corporation, the AIP Corporation, the ASML Corporation, and the Navy program manager in charge of military support for this initiative. We were introduced to state-of-the-art equipment being installed at the facility, including a Class 100 clean room, and were briefed on a variety of potential military and commercial applications utilizing this innovative technology.

If and when completed, I understand the Photonics Prototyping Facility will be unique in its capability to produce photonic integrated circuits on eight-inch silicon wafers. I also understand that the U.S. Army has already used this facility to produce a prototype sensor for biological applications. It seems to me that this type of "low environmental impact" technology appears ideally suited to support the continued growth and diversification of Hawaii's information technology industry.

Since 2003, the U.S. Navy has provided over \$11 million to help develop the Kaka'ako photonics facility, with additional matching funds from APIC, ASML, the Defense MicroElectronics Activity and the University of Hawaii. However, continued federal funding for this project has been eliminated from the FY06 national defense budget. This cutback could potentially terminate the development of the facility, and would appear to negate the substantial investments already made in this program.

I would appreciate your observations and comments on the current status of federal support for the APIC photonics project, as well as your recommendations on how best to advance this type of innovative technology in Hawaii.

Aloha Dr. Gates:

Hawaii's environment is our unique treasure, our heritage and the basis of our way of life. While inviting visitors from around the world to these islands, we also strive to protect them from invasive species carried by daily commerce and travel. One of the greatest threats to the environment of the Pacific islands is the spread of the brown treesnake.

Brown treesnakes were introduced to Guam following WWII as military equipment was moved to Guam from the snake's native Solomon Islands. Finding abundant food and few diseases or predators the snake population exploded. This snake is responsible for the extinction of 9 of Guam's native bird species, and also responsible for 1 in 1000 emergency room visits due to biting people, typically children. It climbs power lines causing frequent, costly power failures. The same disastrous consequences are expected to occur should brown treesnakes become established as a result of an introduction from Guam to Hawaii or any other Pacific island. We need to do our utmost to prevent this.

I want to thank you and the Department of Defense for your long history of support and cooperation in the programs to stop the spread of the brown treesnake from Guam. I am relying on this history of cooperation and good will to help bridge a funding gap that threatens to undermine the years of work we all have contributed to keep the brown treesnake from establishing in Hawaii.

Through the consistent efforts of Senator Inouye, funds have been secured for your Department to support the USDA Wildlife Service inspections of military flights and cargo leaving Guam. While the Continuing Resolution for 2007 included the funds that have supported the Wildlife Services staff in the past, the instructions authorizing their release were not included. I'm asking for your assistance in resolving this short-term problem by releasing the funds to Wildlife Services. I am also eager to work with you to find a long-term solution to this continuing funding need.

Finally, I also would like to thank you and your staff for your cooperation in providing access and facilities that allow Wildlife Services to carry out their critical operations on Guam. It is our sincere hope that we can find a short term solution to keep the Wildlife Services inspectors in place to protect Hawaii and other Pacific ecosystems. The health and well-being of the people, economy and environment in Hawaii is at risk.


