


## Issue Title (C2): F-002 FAY REPORT, Item 6b1, p109-110






## Issue Title (C2): F-003 FAY REPORT, Item 2, p109-110


### F-004 JIDC Chain of Command

#### (U) RECOMMENDATION/OBSERVATION

A decision was made not to run the JIDC as a unit mission. The JIDC was manned, led and managed by staff officers from multiple organizations as opposed to a unit with its functioning chain of command.

Responsibilities for balancing the demands of managing interrogation operations and establishing good order and discipline in this environment were unclear and lead to lapses in accountability.





# Issue Title (Safety of Soldiers and Detainees): F-005 FAY REPORT, Item 4, p111

#### (U) RECOMMENDATION / OBSERVATION:

Detention centers must be established in accordance with AR 190-8 to ensure safety and compliance with the Geneva Conventions. As a matter of policy, force protection concerns must be applicable to any detention facility and all detention operations. Protect detainees in accordance with Geneva Convention IV by providing adequate force protection.



# Issue Title (Procedures for Captured Persons): F-007 FAY REPORT, Item 6, p112

#### (U) RECOMMENDATION / OBSERVATION:

Screening, interrogation and release procedures at the tactical level need to be properly executed. Those detainees who pose no threat and are of no intelligence value should be released by capturing units within 72 hours. Those detainees thought to be a threat but of no further intelligence value should be sent to a long term confinement facility. Those detainees thought to possess further intelligence value should be sent to a Corps/Theater Interrogation Center.







### F-010 JIDC Planning, Personnel and Support

The JIDC was established in an ad hoc manner without proper planning, personnel, and logistical support for the missions it was intended to perform. Interrogation and analyst personnel were quickly kluged together from a half dozen units in an effort to meet personnel requirements. Even at its peak strength, interrogation and analyst manpower at the JIDC was too shorthanded to deal with the large number of detainees at hand..






#### Issues

- New doctrine will permit the Joint Force Commander to establish a Joint Strategic Exploitation Center as well as Joint Interrogation and Debriefing Center(s)




