On the 18th of September 2002 at approximately 21:30 as (b)(3); 10 USC §130b, (b)(6), (b)(7)(C) and I were relieving second shift (b)(2) block began to bang on their cells and yelling. They were inciting a disturbance by hitting, kicking, and throwing knotted towels against the walls and floors of their cells. The Detainees told us that they had heard (b)(2) Block become aggravated because the air conditioning in (b)(2) Block wasn't turned on. They also complained that the 1st & 2nd shift were harassing them. The Detainees also threw soapy water on me while I was walking through.

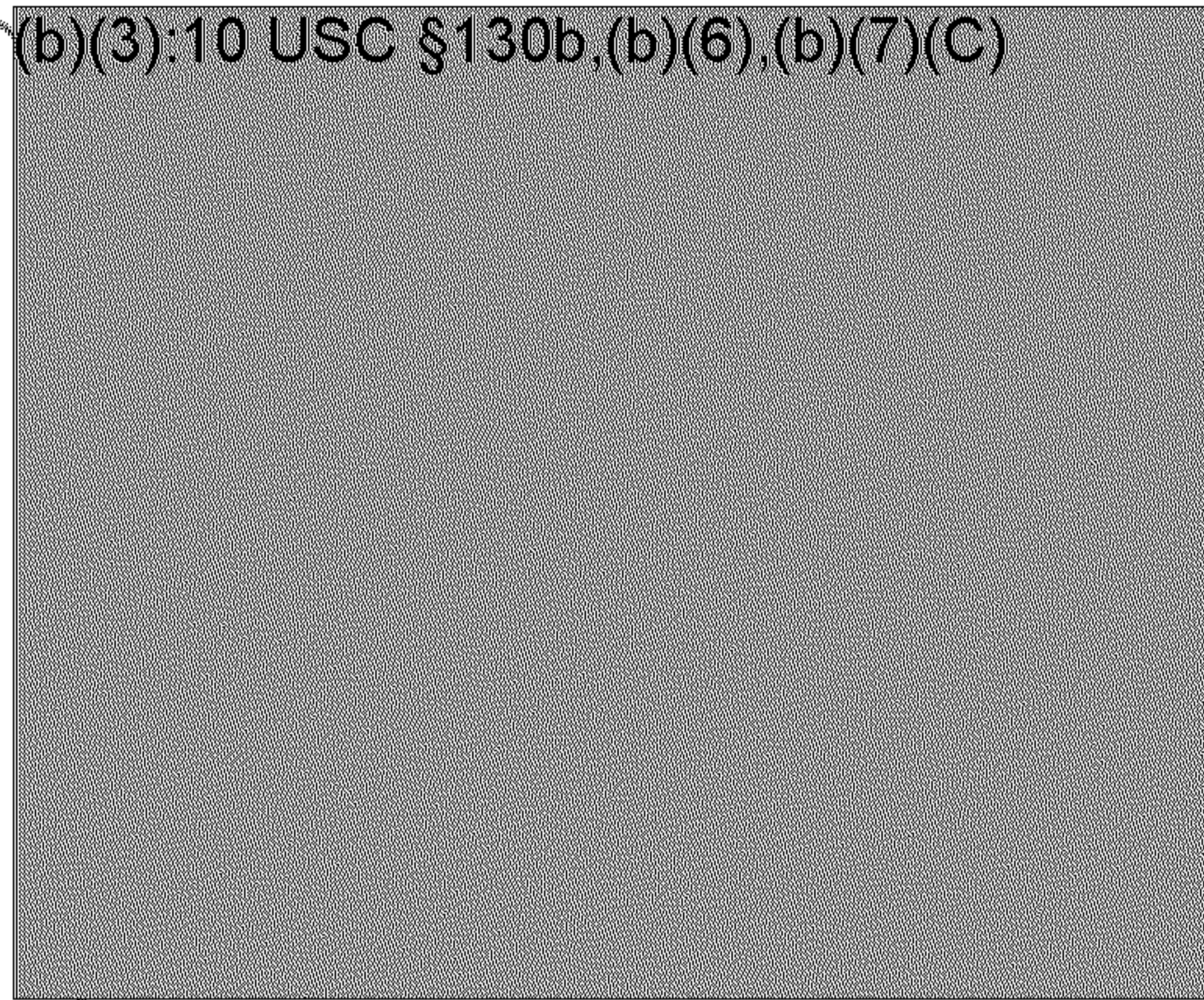

that on 17 Sep, 02 at approximately 2135 hours, (b)(2) Block at Camp Delta ONE began banging on their cells, yelling and inciting a disturbance. They would slam their hands on the cells, kick the cells and use towels tied with knots in them to hit the cells. They yelled and threw water also. Information gathered from detainees was that (b)(2) block had been told from (b)(2) Block that the air-conditioning at (b)(2) Block was turned off. (b)(2) Block became aggravated then (b)(2) block (b)(2) Block told this to (b)(2) Block who became even louder. (b)(2) Block detainees also complained of the First two shifts harassing them and that those actions along with the air being turned off at (b)(2) Block made them mad. (b)(2) Block detainees "apologized" to our shift for getting us mad because we are good MP'S and don't harass them. The water was cut off at 2135. // End of Statement. //
