At approx. 0035, 10JUN06, myself and (b)(3):10USC were dispatched to Camp Delta in response a medical emergency. When I arrived at Camp Delta the Army personnel at Sally Port 1 opened the gate and we parked near the trailer that the Army personnel directed us too. At this time USNH personnel also arrived at Camp Delta. I assisted medical with getting their equipment from the truck to the room where the victim was laying. Upon arrival into the building I saw an individual that seemed to be unconscious and was not moving laying on a bed already receiving medical attention from the Corpsmen that were inside Camp Delta. When myself (b)(3): (b)(3):10 USC and another Corpsmen from USNH arrived at the room, and another Corpsman immediately assisted the Corpsmen that were already inside with trying to revive the victim myself and (b)(3): (3):10 USC stood by close for extra assistance. As the Corpsmen were administering medical treatment there was a lot of running around into other rooms to assist with two other patients which I did not see. At this time an Army Colonel was at the location and was yelling for an emergency recall of all JTF personnel and went to a telephone to make phone calls. After several minutes of medical treatment the two USNH Corpsmen said that they needed a doctor and that the victim has to be transported to USNH so that a doctor can help. When they started to move the victim myself, (b)(3):10 USC and two Camp Delta Corpsmen assisted the USNH Corpsmen with the victim with getting him from the trailer to the truck and the two Camp Delta Corpsmen went inside the medical truck with them. After they loaded the victim into the truck myself and (b)(3): (b)(3):10 USC provided an escort for medical from Camp Delta to USNH. When we arrived at USNH the Corpsmen unloaded the victim and brought him inside USNH at this time I saw a doctor run out of USNH into another truck with another corpsmen on there way back to Camp Delta.
