The San Diego Pride coordinators recently announced on their website that "service members have received approval from the Office of the Secretary of Defense and their . commanding officers to march in the America's Pride Parade Military Contingent while wearing their uniforms."

This is not accurate. There is no such authorization for this parade.

The Office of the Secretary of Defense (OSD) Public Affairs will be addressing this misinformation with the SD Pride coordinators.

Accurate guidance from OSD is as follows: While wearing civilian clothes, in your personal capacity, military members may march or ride in nonpartisan parades.

Also, it is our command policy that any media participation that identifies affiliation with the Naval Service requires PAO approval to ensure the member receives proper training for media participation.

I will put out a generic reminder in a Command Note about parade and media participation but I need your help in communicating these requirements in an informative and supportive manner that will keep our sailors from running afoul of DOD and Navy policy during this weekend's event.

In fact, other military members are likely to join. Here's my question: Were these military members authorized to appear at this event in military uniform? If so, who authorized them to do so? Ves, the one commander that has said no is ^{(D)(G)} I need to get everyone off the idea that it is up to a local commander's discretion. By policy, events that are national in interest must be approved but OSD CPO and the authority is no longer up to the discretion of local commanders, we swoop down and decide. I now have an official request from AF and Navy on an opinion now and will ensure the Services know that this is an event that would allow uniforms so long as uniform policies are adhered to (i.e... no modifications to your uniform, etc..) Current policy would allow this. Since we have no requests for approval or support of a "troop formation" or a band or color guard, I do not plan to address that at all, only to say that individuals may wear their uniform and amplify the policy on that. I do think we have an update on numbers but I need to check on what they are and will get that to you.

Rene: This may be DBE now but wanted to follow up on our discussion about the SD parade. I came by early this morning but your door was closed so I talked to $\binom{(b)(6)}{(6)}$ since I couldn't be at the 0830 mtg. I still think a note to reiterate current guidance to the services, so we don't create news/controversy by having differences in the service participation (e.g. uniforms). However, we can't say service members can't be compelled to attend IF a unit has decided to support, as a unit. No different than support to other parades and events -- members of a unit that is providing official support can't "opt-in, or opt-out" (unless the unit commander approves their absence for whatever reason). And obviously individuals can't be compelled to participate outside the unit's official participation.

Does that make sense?

SUBJECT: Clarification of Guidance Regarding Service Members in Military Uniforms Participating in Parades

- References: (a) Memorandum, "Interim Guidance for Military Participation in Parades and Civic Celebrations," March 7, 2012
 - (b) DoD Directive 5410.18, "Public Affairs Community Relations Policy," May 30, 2007
 - (c) DoD Instruction 1334.01, "Wearing of the Uniform," October 26, 2005
 - (d) DoD Instruction 5410.19, "Public Affairs Community Relations Policy Implementation," November 13, 2001

This memorandum reiterates and clarifies my March 7, 2012, interim guidance regarding service members in uniform participating in parades, and extrapolates applicable policy.

Local commanders have unique knowledge of conditions in their communities. They generally are best positioned to evaluate the appropriateness and level of DoD participation in parades and other civic celebrations. Therefore, local commanders are authorized to use their discretion in determining service member participation in parades, provided their decision does not violate DoD policies regarding uniform wear or community relations activities.

However, any event that is likely to garner national or international interest or news media coverage shall be forwarded through command channels to the OASD(PA) for approval per reference (b). Approval shall be based upon program, sponsor, site, support criteria, and upon any recommendations offered by applicable commanders.

Pursuant to reference (c), the wear of the uniform by members of the Armed Forces (including retired members and members of Reserve components) is prohibited:

- during or in connection with furthering political activities, private employment or commercial interests, when an inference of official sponsorship for the activity or interest may be drawn.
- when wear of the uniform may tend to bring discredit upon the Armed Forces.
- when specifically prohibited by regulations of the Department concerned.



Pursuant to reference (b), community relations support must be confined to those activities that are of common public interest and benefit to a local, State, regional, national, or broadly representational community. Nonpartisan patriotic events open to the general public usually are of common interest and benefit.

In addition, support to events sponsored by organizations with a narrow membership base or interest, such as commercial enterprises, religious or sectarian organizations, ideological organizations, and political organizations and campaigns may occasionally be considered to be in the common public interest when it is clear that the support primarily benefits the community at large, rather than the sponsoring organization.

Key considerations in Reference (d) include:

- DoD personnel shall not support any event that provides a selective benefit to any individual, group, or organization, including any religious or sectarian organization, ideological movement, political campaign or organization, or commercial enterprise.
- When considering support to a non-Federal entity, commanders must be able and willing to provide similar support to comparable events sponsored by similar non-Federal entities.
- DoD personnel shall not officially endorse, or appear to endorse, any non-Federal
 entity event, product, service or enterprise, including membership drives or fundraising activities. Participation shall not be approved when support would endorse,
 promote or sponsor any private individual, group or venture, or gives the appearance
 of doing so.

Also, community relations support or participation is not authorized for events that:

- · are associated with partisan political activities.
- restrict admission, seating, or other accommodations based on race, creed, color, national origin, or gender.
- are sponsored by organizations whose constitution, bylaws, membership qualifications, or ritual are withheld from the general public.

Request widest dissemination of this memorandum to local commanders.

SUBJECT: Request for Guidance Regarding the San Diego Pride Parade

This is in response to requests from several Service components seeking guidance regarding service members in uniform participating in the San Diego Pride Parade on July 21, 2012, with the theme "America's Pride." We understand local commanders have been exercising their discretion on approval per current DoD Community Relations guidance; however, pursuant to DoDD 5410.18, OASD(PA) approval is being sought now since the event has garnered national media attention.

It is our understanding that the event organizers plan to have a portion of the parade that is dedicated to military members. Service members do not need approval to wear civilian clothes and march or ride in nonpartisan parades. However, we further understand organizers arc encouraging service members to seek their commander's approval to march in uniform and to display their pride.

Based on our current knowledge of the event and existing policies, we hereby are granting approval for service members in uniform to participate in this year's parade, provided service members (1) participate in their personal capacity and (2) ensure the adherence to Military Service standards of appearance and wear of the military uniform. This approval is applicable for individual participation in the 2012 San Diego Pride Parade only.
