SECTION I. PRIVACY ACT STATEMENT

AUTHORITY: Section 582 of Public Law (PL) 110-181 YELLOW RIBBON REINTEGRATION PROGRAM.

PURPOSE(S): To record events and activities to support the well-being of eligible individuals BEFORE, DURING, and AFTER periods of activation, mobilization, or deployment. Section 582 Public Law 110-181 requires State National Guard and Reserve Organizations shall provide to eligible individuals of the Guard and Reserve - a) one (1) event or activity BEFORE a period of activation, mobilization, or deployment, b) one (1) event or activity DURING a period of activation, mobilization, or deployment, and c) two (2) events or activities after a period of activation, mobilization, or deployment; to record EISA and post-assessment tier assignment; to record the mitigation information, services, and/or benefits the service member received based on the identified area of need.

ROUTINE USE(S): Disclosure of records are generally permitted under 5 U.S.C. 552a(b) of the Privacy Act of 1974, as amended.

DISCLOSURE: Voluntary; however, it may not be possible to initiate a warm-handover for Service Member if the information is not provided.
