SUBJECT: Policy and Strategy Committee

1. PURPOSE

Pursuant to the authority of the Under Secretary of Defense for Policy (USD(P)) by reference (a), this Instruction authorizes and establishes the Policy and Strategy Committee.

2. APPLICABILITY

This Instruction applies to the Office of the Secretary of Defense (OSD), the Military Departments, the Chairman of the Joint Chiefs of Staff, the Combatant Commands, the Office of the Inspector General of the Department of Defense, the Defense Agencies, the DoD Field Activities, and all other organizational entities in the Department of Defense (hereafter referred to collectively as the "DoD Components").

3. POLICY

- 3.1. It is DoD policy to foster and advance collaboration and coordination among the OSD Principal Staff Assistants and the Chairman and Vice Chairman of the Joint Chiefs of Staff and the Joint Staff Principals.
- 3.2. The Policy and Strategy Committee provides a valuable venue to initiate strategy and policy actions and coordinate and oversee related implementation matters.
- 3.3. The Policy and Strategy Committee shall advance the cohesion of the staffs of the OSD and Chairman of the Joint Chiefs of Staff on the broad range of policy and strategy matters at the discretion of the USD(P) and the Vice Chairman of the Joint Chiefs of Staff.

4. ORGANIZATION

The Policy and Strategy Committee:

- 4.1. Is organized as a DoD committee pursuant to DoD Directive 5105.18 (reference (b)). Staff support and operating costs shall be the responsibility of the co-chairs of the committee.
 - 4.2. Shall be co-chaired by the USD(P) and the Vice Chairman of the Joint Chiefs of Staff.
- 4.3. Permanent membership shall include the USD(P) and the Vice Chairman of the Joint Chiefs of Staff. Other members shall be determined by the co-chairs.
 - 4.4. Shall hold meetings at the call of the co-chairs.

5. RESPONSIBILITIES

The USD(P) and the Vice Chairman of the Joint Chiefs of Staff shall:

- 5.1. Not less than weekly, convene meetings of the Policy and Strategy Committee for the purposes of addressing:
- 5.1.1. Policy and strategy matters of mutual interest and providing a venue to collaborate on issues and provide coordinated guidance to the OSD and Joint Staffs.
 - 5.1.2. On-going and potential DoD operations and related issues.
- 5.1.3. Matters posed by the Secretary of Defense or the Chairman of the Joint Chiefs of Staff.
- 5.2. Inform or make recommendations to the Secretary of Defense, Chairman of the Joint Chiefs of Staff and other DoD officials on the matters addressed by the Policy and Strategy Committee, as they determine appropriate.

6. <u>EFFECTIVE DATE</u>

This Instruction is effective immediately.
