2. 🚅 AS REPORTED IN REFERENCE, GEN ERSOZ STATED HE HAD NOT SEEN LETTER AND NEITHER HAD CHIEF, TGS, ALTHOUGH HE KNEW IT HAD BEEN RECEIVED. SUBSEQUENTLY, INFORMATION WAS RECEIVED THAT LETTER HAD BEEN SENT TO FOR HIN AND THERE APPEARED TO BE SOME DISCUSSION REGARDING INTERPRETATION OF THIRD PARAGRAPH.

3. LET I HET HITH DEP HOD AT 1789 HOURS ON FRIDAY 21 FEB. GEN DLCAY STATED THAT HOD SANGAR WAS VERY HAPPY TO RECEIVE LETTER AND NOTED WITH PLEASURE THE SUBSTANCE OF SECDEF STATEMENTS, HE STATED THAT AN ANSWER TO SECREF WOULD BE DISPATCHED WITHIN A FEW DAYS.
