GENERAL, LEBANESE ARMED FORCES AND TWO SENIOR STAFF MEMBERS. ACCOMPANYING HE HERE AMBASSADOR DILLON, RADM JONES AND COLONEL GREEN.

AFTER INITIAL PLEASENTRIES AND EXPRESSIONS OF DEEP APPPECIATION FOR ALL PRESIDENT REAGAN AND YOU HAD DONE TO HELP HIS COUNTRY, HE MOVED QUICKLY TO REQUEST EXPEDITED DELIVEPIES OF EQUIPMENT, SOME OF WHICH IS ALREADY ON ORDER. DURING THE COURSE OF THE MEETING HE WENT BACK TO AND STRESSED THIS POINT A HUMBER OF TIMES EXPLAINING THAT THE EQUIPMENT WAS IMPORTANT FOR TWO REASONS:

1. THE HORALE OF THE ARMY (A MEASURE OF STATUS).

2. ENABLE THE ARMY TO CARRY OUT ITS MISSION.

AS YOU KNOW. THE LEBANESE HAVE REQUESTED A VARIETY OF

ITEMS BUT EMPHASIZED THE NEED FOR M113A2 ARMORED PERSONNEL

CARRIERS (THEIR FIRST PRIORITY), M198/155 MM HOWITZERS AND

ONE BATTALION'S MORTH OF M48A5 TANKS (APPROXIMATELY 35 TANKS).

THE LATTER HAVE NOT YET BEEN FORMALLY REQUESTED. HE ALLOWED

AS HOW IT WOULD SURELY BE DNLY A HINOR PROBLEM TO DIVERT THESE ITEMS FROM U.S. INVENTORIES!

THE PRESIDENT THEN LAUNCHED INTO AN EXPLANATION OF THE NEED FOR MITHDRAHAL OF ALL FOREIGN FORCES, IN PARTICULAR HIS DESIRE TO GET ALL ISRAELI FORCES OUT SO THAT THE LEBANESE ARMY COULD ACCOMPLISH ITS PEACE-KEEPING MISSION. HE IS VERY MUCH CONCERNED ABOUT ISRAELI FORCES IN THE BYABDA AREA AND IN ALEI WHICH IS LOCATED BETWEEN BEJRUT AND DAMASCUS. THEIR PRESENCE IN THESE AREAS IS PARTICULARLY UPSETTING AND IS MOISTURBING THE NATIONAL SECURITY BITUATION.

GENAYEL'S MEXT MAJOR POINT WAS THAT OUR SURVEY TEAM

(PROJECT NEW LIFE) HEADED BY BRIGADIER GENERAL BARTLETT HAD

CAUGHT THEM SOMEHHAT BY SUPPRISE. IN REALITY I THINK THEY

EXPECTED THAT THE TEAM WOULD ACCEPT WITHOUT QUESTION THEIR

SHIPPING LIST AND THAT WE WOULD START SHIPPING EQUIPMENT

IHMEDIATELY, HONEVER, RARTLETT IS REQUIRING (RIGHTFULLY SO)

THO LEBANESE TO THINK THROUGH THEIR NEEDS BEFORE WE MAKE MORE

DECISIONS AND COMMITMENTS. INCIDENTALLY, I MET WITH BARTLETT

BEFORE LEAVING LEBANON. HE WILL PROVIDE YOU BY MESSAGE IN A

COUPLE DAYS SUME OF HIS INITIAL IMPRESSIONS AS TO HOW WE

SHOULD PROCEED.

TO CLARIFY THIS DISCONNECT BETWEEN OUR TEAM AND THE LEBANESS, I DEFINED FOR THE PRESIDENT WHE FRAME OF REFERENCE UNDER HHICH THE TEAM WAS HORKING, NOTING THAT IT WAS MOST IMPORTANT THAT SOME FUNDAMENTAL ISSUES SUCH AS DRGANIZATION AND MISSION OF THE ARMY BE DECIDED BEFORE NE COULD ADVISE ON SPECIFIC EQUIPHENT (I DID NOT RAISE THE ISSUE OF SECTARIAN MIX WITHIN THE ARMY WHICH IS SURELY

ANOTHER FUNDAMENTAL PROBLEM WITH WHICH THE LEBANESE WILL HAVE TO DEAL).

THE PRESIDENT REACTED SOMEWHAT SHARPLY CLAIMING THAT THE MISSION WAS BOTH TWO FOLD AND CLEAR. THE FIRST -- AFTER WITHDRAHAL OF ALL FOREIGN ARMIES FROM LEBANON -- WAS TO BUILD A FORCE THAH WOULD REPLACE THE MANY ARMED GROUPS THAT HAD TERRORIZED THE COUNTRY. MY IMPRESSION WAS THAT HE WAS THINKING PRIMARILY OF USING THE ARMY FOR POPULATION-CONTROL TYPE ACTIVITIES IN THE URBAN AREAS. AS THE ARMY INCREASED IN SITE THIS MISSION WOULD EXPAND TO INCLUDE SIMILAR PEACE-KEEPING OPERATIONS THROUGHOUT THE COUNTRY. THE SECOND WOULD BE TO ORGANIZE AND TRAIN FORCES SUFFICIENTLY STRONG TO PROTECT LEBANON FROM BOTH TERRORISTS AND MILITARY INVASION BY UNFRIENDLY NEIGHBORS. BOTH HERE URGENT REQUIREMENTS.

AFTER SOHE BRIEF DISCUSSION OF WHAT KIND OF FORCES
MIGHT ACCOMPLISH THESE MISSIONS, I RAISED THE PROBLEM OF
PHS LEVELS AND THE DIFFICULTY THAT WE HAVE HAD WITH CONGRESS
IN THIS AREA. GEMAYEL ARGUED THAT WE WERE ABLE TO PROVIDE
BUBSTANTIAL AMOUNTS TO MANOTHER COUNTRY. PERHAPS SOME OF
THIS COULD BE BETTER SPENT TO REUNITE HIS DEVASTATED LAND.

SENAVEL'S FINAL MAJOR POINT, WHICH HE STRESSED IN VERY STRONG TERMS, WAS THAT LEBANON WOULD LIKE TO BE A PART OF DUR SECURITY SYSTEM IN THE AREA. HE SAID FOR YEARS DURING DIFFICULT TIMES LEBANON HAD STOOD BY THE U.S. EVEN WHEN OTHER COUNTRIES IN THE AREA HAD NOT. HE ADDED THAT THE LEBANESE PEOPLE ARE DEDICATED TO FREEDOM AND DEMOCRACY AND THAT LEBANON COULD AND HOULD PROVIDE HELP TO US AS AN ALLY. HE SAID OVER AND OVER "USE US, WE ARE IN A STRATEGIC POSITION, WE ARE A NATURAL ALLY AND WE DON'T COST MUCH." I STATED THAT WE WOULD ATTEMPT, WITH THE ASSISTANCE OF OUR CONGRESS TO DEVELOP A SPECIAL PROGRAM OF MELP (AFTER OUR SURVEY IS COMPLETE). I ALSO ASKED IF THE LEBANESE ARMY BT

ITS UNITS. GENERAL KHOURY BRUSHED THIS EQUIPMENT OFF AS

THAT THE PRESIDENT HAD OUTLINED. ALTHOUGH SOME UNITS ARE CURRENTLY AT ONLY 30 PERCENT FILL IN PEOPLE AND EQUIPMENT, THE LEBANESE IN THE NEAR TERM WANT TO RAISE AN ARMY OF 43,800 (7 BRIGADES) == EVENTUALL INCREASING TO 60,000 PLUS

WHEN PRESSED WHERE HE WOULD GET THE PEOPLE FOR 11 BRIGADES, GEMAYEL STATED THAT GENERAL KHOURY AND HIS SYAFF WERE STUDYING THIS BUT THAT THEY WOULD PROBABLY HAVE TO RESORT TO CONSCRIPTION. THIS WOULD BE ACCOMPLISHED GRADUALLY AFTER GETTING "THE SYSTEM" ORGANIZED. I INFERRED THAT THIS WAS A PRETTY LARGE ARMY FOR LEBANON. THE PRESIDENT STATED THAT THEY WOULD ALSO USE THE ARMY FOR "CIVIC ACTION" TYPE PROJECTS SUCH AS BUILDING SCHOOLS, ROADS, ETC.

COMMENT: GENAYEL'S PLANS AND EXPECTATIONS CLEARLY EXCEED HIS -- AND OUR -- GRASP, IT IS OBVIOUS HE IS REACTING VISCERALLY. QUITE A NORMAL THING FOR ONE WHO HAS HAD SUCH HEAVY RESPON-BIBILITY THRUST ON HIM BO SUDDENLY. HE IN EFFECT WANTS TO MORTGAGE HIMSELF AND HIS COUNTRY TO US, IN RETURN HE EXPECTS IMMEDIATE ACTION, PRINCIPALLY IN THE FORM OF EQUIPMENT TO ENHANCE THE PRESTIGE AND MORALE OF THE LAP. HE MAY BE RECEPTIVE TO OUR ADVISE ON SUCH ISSUES AS FORCE LEVELS, HISSION, ORGANIZATION AND TRAINING, BUT ONLY IF HE PERCEIVES US TO BE FORTHCOMING ON HIS CONCERNS. ARGUMENTS ABOUT OUR INTERNAL CONSTRAINTS WILL FALL ON DEAF EARS TO ONE WHO HAS SUCH VIVID IMAGES OF WHAT DUR MASSIVE EQUIPHENT DELIVERIES TO ISRAEL REPRESENT IN TERMS OF POWER AND AUTHORITY. IF WE CAN DO SO MUCH FOR IBRAEL, SURELY WE CAN HANDLE THE MORE HODEST TASK OF HELPING HIM PULFILL HIS MANDATE TO HEAL THE WOUNDS OF HIS SMALL COUNTRY. HE HAS A POINT.
