Implementation
of
De-Baathification Order
in
Electricity Commission

1. Attached is the spreadsheet illustrating the leadership positions of DG and higher within the Electricity Commission. There are seventeen position/incumbents, one interim DG, and one DG that was moved to a Chief Engineers position two weeks ago. Of the total nineteen employees, three were non-members, one never returned to work, nine were members (UDW Amil), and six high ranking Baath members.
2. I have submitted one exception for a UDW Amil (Dr. Hasan) and expect to submit eight other exceptions all whom are UDW Amil. I have not found any factual evidence from the interviews nor discussions with others of negative Baathist behaviors by these employees.
3. I will issue letters of removal to the high ranking Baath personnel on the spreadsheet by 7 June, 2003. I expect to publish for Commission employees the names of these employees three days after the individual letters are issued.
4. Presently, we are doing an investigation/review of all other leadership positions within the Commission for high ranking Baathists. Expectations are that we will complete this investigation within the next three weeks and issue letters of removal to these individuals
