


# Regional Team (Mosul)







# Regional Team (Kirkuk)




# Relations between Regional Team & MNF-I Central









# Regional Team (Basrah)

#### **Latest Transition News:**

- Transition Team Baghdad: John Holzman and his team have begun transition planning in Baghdad. Thrice weekly teleconferences with
- Interim embassy facilities: Initial contract to improve and renovate the interim embassy facilities awarded on schedule, on budget.

#### **Key Transition Issues:**

- National Security Presidential Directive (NSPD): NEA and L drafted NSPD to designate Mission Baghdad and NEA/Iraq as the successor to CPA to secure funds and key authorities for State. NSPD would also establish two temporary organizations. Draft circulating for comment in State.\*
- Interagency Operations Plan: State/DOD circulating draft combined USG Iraq transition plan. \*
- Funds: RM developing a financial strategy and a resource requirement
- Security: Per request of Secretary of Defense, DOD and State developing principles and assumptions for security for Mission Baghdad. A/S Taylor to meet with DoD counterparts next week.
- Ministry advisors: CPA recommends reduction from current total of 637 to 199 advisors in Iraqi ministries on 1 July, 155 from US.\* CPA to provide recommendations on extensions of incumbents for State review.
- Provincial Teams: Plan drafted for Provincial teams.\* Under discussion with DOD. Interagency meeting next week. Issue: In how many of the 18 provinces?
- CPA/W to State: Discussions begun on transferring functions/personnel from CPA Washington to State.

#### Iraq Transition Issues with Legal Dimensions

- 1. Transitional Administrative Law (TAL)
  - U.S. has an interest in what the TAL provides regarding ratification/adoption of agreements entered into by IGC, and entering into new binding legal agreements.

Absent provisions addressing these issues, we may confront difficulties in ensuring that agreements entered into with U.S. before transfer of power are legally durable, and that binding agreements can be entered into after transfer of power in a manner that serves our interests.

- 2. Security Agreement
  - Military Technical Agreement

There are numerous questions regarding freedom to operate, mutual cooperation, use of facilities without charge, command and control, rules of engagement, who should be parties to the agreement, how to address presence of other contributing nations, and the duration of the agreement.

• Status of Forces Agreement (SOFA)

Absent a SOFA (or UNSCR protection), after the transfer of power, U.S. forces in Iraq will be subject to Iraqi law for purposes of arrest and criminal prosecution, customs, taxes, environmental protection, civil claims, carriage and use of firearms, operation of vehicles and aircraft, etc.

• Article 98 Agreement

Absent an Article 98 Agreement, Iraqi authorities would be free to surrender U.S. personnel in Iraq to the ICC, depending on applicability of certain UNSCRs.

• Detainees

Any provisions regarding our authority to arrest and detain (or continue to detain) EPWs or other detainees after transfer of power, or to transfer them to Iraqi authorities, must take into

account our rights and obligations under the Geneva Conventions and conflict termination issues.

#### • UNSCR Authority Issue

It may be politically helpful for Iraqis for agreement to be premised on notion that authority for presence of U.S. forces operating in Iraq after transfer of power is not derived solely from this agreement but also from existing UNSCRs.

#### 3. Continuation of CPA Orders/Regulations

Absent special provisions allowing for the durability or ratification of CPA orders/regulations in the TLA or other instrument, existing CPA orders and regulations will expire when the CPA is dissolved. Many of these orders address issues of ongoing importance to the U.S. such as foreign investment in Iraq, the Iraqi criminal code, and the statute establishing the Iraqi Special Tribunal. Consideration should be given to which of these orders the U.S. would like to see continued in effect and how this is best accomplished as a technical/legal matter. There are also a number of additional CPA orders/regulations, particularly on economic issues, that we understand may be desired that will likely require legal drafting and input (including by Iraqis) prior to the transfer of power and that we would like to see continued after the transfer of power.

#### 4. UNSCR

#### • Development Fund for Iraq

Absent a new UNSCR, we could confront legal problems concerning disbursement of any funds remaining in DFI at transfer of power and dissolution of CPA (since UNSCRs provide that these funds are disbursed at direction of CPA in consultation with Iraqi interim administration). Note also that, absent UNSCR, IAMB may continue to oversee DFI, and any Iraqi funds identified in other countries must be returned to the DFI.

#### • Oil Exports

Absent a new UNSCR, Iraqi oil exports after the transfer of power may continue to be audited by accountants reporting to the IAMB.

#### • Arms Embargo

Absent a new UNSCR, restrictions in existing UNSCRs on exporting arms to Iraq will continue, and the exception for "material required by the Authority [CPA]" to serve UNSCR purposes may no longer be useful; this could result in legal issues concerning arms transfers to forces operating in Iraq that should be explored.

#### • UN Role

UN may take the position that a new UNSCR is required for UN to undertake activities in Iraq after the transfer of power (though it appears UN would have authority under existing resolutions for at least some activities).

#### UNMOVIC/IAEA

UNSCR provisions granting special authorities to UNMOVIC and IAEA in Iraq have not been suspended or terminated. Absent a new UNSCR, UNMOVIC or IAEA could assert a right to resume inspections. Similar issues may arise in connection with Iraqi obligations under nonproliferation treaties.

#### 5. U.S. Domestic Law Sanctions

Iraq remains on the terrorism list under U.S. law, but virtually all provisions of law that sanction Iraq by virtue of its support to terrorism have been suspended under special authority provided to the President in the Iraq Supplemental. Our position has been that the suspension is permanent but that could be challenged for the period after the September 30, 2005 date mentioned in the statute. In addition, there are certain other remaining domestic sanctions on Iraq that we should consider whether to lift after the transfer of power.

6. Establishing Diplomatic Relations with New Iraqi Government

A variety of issues will need to be addressed related to the means of establishing diplomatic relations, appropriate levels of privileges and immunities for U.S. diplomatic and consular personnel, and the acquisition of property.

Iraq's Treaty Obligations and ongoing UNSCR requirements

We need to identify and consider the relationship between Iraq's current or desired future treaty obligations, continuing UNSCR requirements, and ongoing U.S. security and other operations in Irag.
