SUBJECT: Pending Orders and Regulations

This memorandum forwards for your signature a cable that describes CPA's proposed legislative agenda for the remainder of the occupation. Specifically the attached cable:

- Explains the process by which orders and regulations are drafted and coordinated;
- Explains the principles CPA applies in prioritizing its orders;
- Groups the pending orders and regulations into three categories ("mission critical," "very important" and "important");
- · Briefly describes the orders and their current status; and
- Acknowledges the importance of carefully controlling the process whereby orders are coordinated with the Governing Council, in order to ensure continued meaningful review by that body.

Two matters were suggested yesterday as additional subjects of orders: an advisory board for the Prime Minister on reconstruction matters and a mortgage financing facility. The former concept can be incorporated into the Central Government Functions Order, and the latter can be included within the Banking Law and Regulations.

1. Summary. To date, I have issued 64 orders in my capacity as Administrator of the Coalition Provisional Authority (CPA). Under the laws and usages of war, and consistent with relevant U.N. Security Council Resolutions, including UNSCRs 1483 and 1511 (2003), these orders have the force and effect of law. The Transitional Administrative Law (TAL) recognizes these orders and continues their force and effect until rescinded or amended by duly enacted legislation. We have now completed a comprehensive review of all orders and regulations that CPA intends to promulgate during the remainder of the occupation. These initiatives will lay a proper legal foundation for a stable and free Iraq.

2. The CPA Office of General Counsel (OGC) oversees the drafting and coordination of all orders, regulations and other legal instruments promulgated by CPA.

a. Before any order is drafted, OGC carefully reviews extant Iraqi law to determine whether any revision is necessary and ensure that amendments are as narrowly drafted as possible, consistent with the CPA's obligations under occupation law. b. Draft orders generally are prepared by subject matter experts either within or in coordination with OGC, although the drafting of certain highly technical orders is accomplished by experts with U.S. executive agencies or other specialized organizations such as the N.Y. Federal Reserve. We are especially appreciative of consistently superb and timely support from the Offices of General Counsel in the Departments of Defense, Treasury and Commerce and the Office of the Legal Adviser, Department of State.

c. The drafting process entails close coordination with the relevant interim Iraqi ministers and their ministry staffs, and often includes sessions with Iraqi academic and business leaders.

d. Once drafted, proposed orders are staffed through an interagency process involving the Departments of Defense, State, Justice, Treasury and Commerce. The Coalition capitals in the United Kingdom and Australia also are provided copies for review and comment, and all commercial law reforms are staffed with the international financial institutions as well. Finally, most draft orders (including all economic and governmental reform orders) are coordinated with the Iraqi Governing Council.

e. Following the U.N.'s withdrawal from Iraq in August 2003, it has proven difficult to consult and coordinate with the U.N. on proposed CPA orders, where required under U.N. Security Council Resolution 1483. Accordingly, we request the assistance of the Department of State and the USUN in establishing a practice that will appropriately include the U.N. in the coordination process, consistent with U.N. Security Council Resolution 1483 and CPA's need to adhere to a firm schedule. In our view, such a practice cannot rely solely upon informal coordination in Iraq with the U.N. Secretary-General's Special Representative, due to the irregularity of his travel to Iraq. Another solution must be developed to ensure the strongest possible legal basis for CPA's commercial and government reform initiatives.

3. We have applied the following principles in prioritizing our efforts:

I

a. The highest priority is given to orders that create commissions, organizations or offices that will

require time to establish, staff and begin functioning;

- b. The next priority is accorded to those orders that contribute to transparency, honesty and accountability of the Iraqi government;
- c. The third priority includes those orders that contribute to a stable, free market economy and that promote economic reconstruction and the conditions for sustainable development.

4. Consistent with these principles, the pending orders and regulations have been grouped into three categories: mission critical, very important and important.

 a. There are 14 mission critical orders currently pending promulgation. Failure to enact these orders during the occupation could jeopardize our efforts to stabilize,
reconstruct, and transform Iraq.

- (1) CPA will soon begin drafting an Election Commission Order and a Political Parties Order. It is important that the Commission be established and that it promulgate election regulations by May 31, to ensure integrity and transparency during the campaign as well as fair and free elections that will be recognized as such by the Iraqis and the international community.
- (2) In view of the uncertainty regarding a status of forces agreement or a U.N. Security Council resolution, an order that provides adequate legal protection for military, diplomatic and contractor personnel after the occupation must be in place. In the same vein, a "housekeeping" order is also needed to provide for the transition on 30 June and bring all extant orders and regulations into conformity with the TAL.
- (3) In the national security arena, four orders will be needed. An order establishing the new Ministry of Defence is complete and in final coordination with the Governing Council now. Orders establishing a new Iraqi National intelligence service and regulations governing



the armed forces, including militias, are being drafted.

- (4) In the general governance arena we will reconstitute the Board of Supreme Audit as an independent public agency empowered to enhance the economy, efficiency, effectiveness and credibility of the Iraqi government. A completed draft is in coordination. We will also put in place an Organic Budget Order and Public Procurement Order. They are being designed to install budgeting and procurement mechanisms that are transparent, credible and embrace competition. Drafting is underway on both orders.
- (5) An Interim Governmental Powers Order has been drafted and coordinated, and will be signed this week. This order will clearly articulate the respective roles, authorities and responsibilities of interim Ministers, Governors and other local governing authorities.
- (6) An order is also needed to establish a new visa system as part of a broader border control program. This order is being drafted now by CPA.
- (7) Finally, a regulation is necessary to formally establish the Program Management Office (PMO) and prescribe its composition, authorities and program management and acquisition functions during the occupation (and facilitate its proposed transition to the Department of Defense). The PMO is currently operating without a specific and comprehensive enabling regulation. This regulation has been drafted and is in coordination.

b. Fifteen pending orders have been identified as "very important". These orders will enable Iraq to maintain momentum in its progress toward an open and stable society. Many focus upon economic and commercial reform, while others deal with communications, general governance and judicial reform.

 Drafting is underway on a revision to an earlier Banking Law that will facilitate commercial



banking operations and support true market reforms. Banking Regulations are also being written that set forth detailed guidance to implement the Banking Law.

- (2) Administrative Retail Registration instructions have been completed and are being coordinated with the Iraqi Ministry of Trade. These regulations will provide the procedures for foreign investors to register to do retail business in Iraq pursuant to CPA Order No. 39.
- (3) A Labor Law Order has been drafted and is being coordinated. This will provide greater flexibility for job creation, labor mobility and equal treatment for Iraqis and non-Iraqis.
- (4) A Bankruptcy Law modernizing Iraqi dissolution, liquidation and bankruptcy proceedings has been drafted. Coordination is ongoing.
- (5) A Secured Transactions Order has been drafted and is under coordination. This order will provide for a registry and specific protections for property rights.
- (6) Orders dealing with intellectual property matters including patents, trademarks, trade names and copyrights are being drafted and will soon be coordinated with Iraqi government officials prior to interagency coordination.
- (7) An order dealing with Competition Policy setting forth anti-monopoly rules will be drafted.
- (8) A Pension Reform Order will be drafted to permit private pension funds and update extant pension policies.
- (9) A Central Government Functions Order will create an infrastructure to support the Prime Minister and Council of Ministers. It will include the Iraqi Security Council, the senior governmental body that will establish national security policies and priorities. This order has not been drafted.



- (10) An order establishing an independent commission for licensing and regulating telecommunications, broadcasting and other media has been drafted and coordinated, and is expected to be signed this week.
- (11) An order establishing the Iraqi Broadcasting Network as Iraq's public services broadcaster also has been drafted and coordinated, and is expected to be signed this week.
- (12) A "Whistle Blower" Protection order has been drafted to protect those who come forward with evidence of corruption and official wrongdoing. Coordination is underway.
- (13) A draft revision of the order creating the Iraqi Civil Defense Corps (ICDC) has been completed; the revision would provide for the ICDC's participation in counterinsurgency operations. Coordination is underway.
- (14) An Omnibus Judiciary Order is needed to create the administrative structures to transfer the judicial support functions from the Ministry of Justice to the Judicial Council. This order has not been drafted.

c. Another 28 orders would significantly contribute to establishing a basic legal framework in Iraq. Again, most focus on commercial and economic reforms.

- Four commercial reform initiatives have been drafted and received interagency and international input: Reconstruction Levy Instructions, Consolidation of State Owned Enterprises, Disposition of Military Industrial Company Assets and Personnel, and Iraqi Interim Securities Law. All are being coordinated.
- (2) Five commercial reform initiatives are currently being drafted: an anti-money laundering law, a comprehensive revision of Securities Law, Commercial Agency Regulations, Public Debt Law, Consumer Protection and a comprehensive revision of Iraq's Company Law.



- (3) We have plans to prepare additional orders in the commercial reform arena dealing with Insurance Law, Social Security Law, Transportation Customer Funds, a National Oil Company Law, a Commercial Leasing Law, comprehensive revision of the Tax Law, a Funds Transfer Law and an International Trade Negotiation Law.
- (4) In the national security arena, we have completed a draft revision of the New Iraqi Army Order that authorizes Coalition Forces to exercise command and control of the IAF and permits its use in counterinsurgency operations. Coordination is underway.
- (5) An order establishing the Iraqi Radioactive Source Authority, a regulatory agency to monitor and enforce regulations governing ionizing radiation usage, has been completed. Coordination has not begun.
- (6) Drafting is underway for the Iraqi International Center for Science and Industry, an organization designed to employ Iraqi scientists, technicians and engineers who were employed in WMD programs.
- (7) A weapons registration order has been drafted to register and regulate the importation and possession of weapons by security companies and contractors.
- (8) An order decentralizing the power to appoint and remove academic officials will be drafted.
- (9) A Civil Service Order will be drafted including merit management and an oversight commission.
- (10) An order authorizing covert investigations with judicial oversight is being considered for drafting.
- (11) A traffic code is currently being drafted to ensure that regulation of motor vehicle operations is not a source of graft and corruption for lower level authorities.

5. Although this is a very ambitious plan, I am convinced we will be able to have all of these orders and regulations completed by 30 June. An area of particular concern is the Iraqi Governing Council's ability to absorb this extraordinary legislative agenda. Nonetheless, we recognize that coordination with the Governing Council is necessary to ensure the legal sufficiency and long-term viability of CPA's orders. We will carefully monitor this process and continue to accord the Governing Council an opportunity meaningfully to review and respond to the orders in a prioritized sequence, and at a rate that does not exceed its capacity.


