Purpose/Objective: Fund two priority requirements. First, \$20.8 Million to provide 7,500 Iraqi guards and US/expatriate management in direct support to Task Force Shield. Second, provide \$1.2 Million to contract Personal Security Details (PSD) for Ministry of Oil Director-Generals.

Justification: Terrorist threats against Iraqi oilfields, pipelines, pumping stations, refineries, oil workers and critical oil nodes have increased, inflicting significant damage to the Iraqi oil infrastructure. The Coalition Provisional Authority (CPA) through the Iraqi Oil Ministry provided initial funding in September 2003 to stand up an Iraqi Security Program consisting of a primarily Iraqi contract security force of 6,400 personnel.

a. As a consequence of the expanding insurgency and increased targeting against the oil infrastructure, a significant increase in force levels is required. Detailed analysis by security and intelligence staff indicates that an additional guard force plus up of 7,500 Iraqi guards and support expatriate management staff is required. Without the immediate funding of this requirement, fatalities against Coalition Forces and contract personnel will continue as well as attacks against oil infrastructure. In the last two weeks alone, KBR employees were attacked twice and sustained 1 KIA and 5 WIA. Oil will continue to be the main economic source of income for the government of Iraq. Without the ability of the CPA, Coalition Forces and the Oil Ministry to secure the critical oil infrastructure, production levels will never exceed pre-war levels. Estimated requirement: 20.8 Million.

b. Personal Security for Ministry of Oil Director-Generals (DGs). In early November, one of the Ministry of Oil DGs was the subject of an attack where he was wounded in the leg and his son killed. As terrorists become bolder and increasingly desperate, Oil Executives become more likely targets for violent acts. Services are required to provide personal security for the 8 DGs for a period of 6 months. The Ministry of Oil will be responsible for procuring funding to extend the period of the contract beyond that point. Estimated Requirement: \$1.2 Million.

This is in addition to the \$10 million already authorized for air surveillance.

Coordination: This requirement has been coordinated with the Senior Advisor to the Ministry of Oil, and with the Director of Studies and Planning for the Ministry of Oil.

Goods and Commodities: None; these are service contracts.

Project Implementation: Contract must be fully implemented within 30 days of being awarded.

### Description of Program or Goods To Be Purchased - Please See Above Instructions

1. Purpose/Objective: The purpose of the request is to obtain an audit of the State Oil Marketing Organization (SOMO). Specifically, the scope of work for SOMO consists two main issues. First, that an internal audit is conducted by independent public accountants to ensure that export sales of petroleum and petroleum products are consistent with prevailing international market best practices. Second, conduct an internal controls review. This assignment will include reviewing internal control systems, advising on best practices and reviewing measures to help prevent and detect fraud. If weaknesses exist, the audit should identify these issues and present remedies.

2. Justification: It is also critical to ensure all oil products are accounted for and recorded properly.

3. Coordination: We are coordinating this project with the CPA contracting office.

4. Goods and Commodities: The cost estimate provided above is based on industry norms for this type of engagement.

5. Project Implementation: We anticipate funding to be provided from the Development Fund for Iraq (DFI). We expect the financial services firm to complete the engagement within 25 working days from the time the auditing firm enters Iraq.

#### MEMORANDUM

#### Program Review Board (PRB)

Subject: De-Mining and Unexploded Ordinance (UXO) Removal from the North Al Rumaylah Oil Fields.

Purpose/Objective: To allow the safe access to all areas of the Al Rumaylah North Oil Field to the Iraqi repair workers.

Justification: Current infrastructure repair under the Corp of Engineers (TF RIO) removed only those mines and UXO from around the oil wells that needed immediate emergency repair. This work concentrated on getting the oil fields running and producing crude oil for export to raise the needed capital for Iraqi reconstruction projects. To maximize and improve the flow of oil and thus increase the amount of exported crude, repair and maintenance work will have to be done on the rest of the North Rumaylah fields. The ultimate result will be the increase in crude oil production and an increase in needed capital for Iraqi reconstruction.

Coordination: Coordination with the Iraqi Ministry of Oil and the Corps of Engineers has been done and will be ongoing throughout the life of the project. Coordination and support with the Iraqi Mine Action Center has been done and will be on-going.

Goods and Commodities: The Iraqi Mine Action Center has companies and support infrastructure in place to assist and coordinate the project.

Project Implementation: Via contract. The Iraqi Mine Action Center has contracts within the country now that will be leveraged. The disbursement of funds will be through the Ministry of Oil. The Iraq Southern Oil Company under the direction of the Ministry of Oil will monitor the project. From contract implementation to assessment will take 4 weeks. Actual de-mining and UXO removal will commence 2 weeks after the assessment. Anticipated life of the project is 8 weeks.

Cost Estimate: The requested cost estimate is based on an initial industry standard cost of \$20,000 US to clear (1) acre to a (4) foot depth. Initial surveys estimate the total area requiring clearing to be approximately 1000 acres.

The original estimate of \$120,000 provided to the PRB was based on general conversations with potential auditors about the client and the services requested. The Request for Proposal (RFP) included a far more detailed scope of work requirement than was used to obtain preliminary estimates. We made a conscious decision to describe the assignment in general terms to maintain a level playing field for all prospective bidders. The detailed scope of work outlined in the RFP was likely more time consuming than estimated, requiring more hours of work to complete the assignment – now likely to cost \$180,000.

#### MEMORANDUM

#### Program Review Board (PRB)

Subject: Life Support for the CPA- Fuel Supply Task Force based at the Basrah Airport.

Purpose/Objective: This Task Force is charged with the oversight and coordination of the various coalition efforts working to build the Iraqi oil infrastructure. The primary goal of the Task Force is to increase oil product flow from the ports and refineries in the south to the rest of Iraq. This increase will help to mitigate the shortage of heating, cooking, power and transportation fuel supplies throughout Iraq.

Justification: Currently there is only one contractor with lodging available right now at the Basrah airport. Al-Bahar and Bardawil (B&B) have two trailers available immediately for the (4) Task Force members. Other lodging in Basrah proper is not suitable and/or geographically undesirable. The majority of project work will be south and west of Basra city proper. Due to the security environment and the availability of escort services, the Task Force is more effectivel deployed out the Basrah airport grounds.

Coordination: Coordination with the Corps of Engineers, MND/SE and CPA South, has been done and will be ongoing throughout the life of the project.

Goods and Commodities: Requesting sole source contract to B&B lodging at the airport. Justification for sole sourceing is based on the need to move in quickly, get the offices up and running under a short time frame. Because of the winter fuel demands, this Task force cannot wait for the contract process. KBR and other contractors with similar lodging are full and have no room and will not have additional lodging available for several months. B&B has two trailers immediately available in move in condition: Lodging includes (3) meals a day,laundry services and internet connection/office facilities at \$120.00 USD per day per person. This price is cheaper than what TF RIO pays KBR and about the same as what TF RIE is paying their contractor for lodging.

Project Implementation: Via sole source contract. The disbursement of funds will be through the CPA, Ministry of Oil.

Cost Estimate: The requested cost estimate of \$86,400 is based on a four man team at \$120.00USD per day for 180 days. Funds will be dispursed on a monthly basis.

1. Purpose. To fund the emergency import of LPG, Benzene, Kerosene and Diesel through 1 May 2004.

2. Justification. The Iraqi domestic refining capacity has not yet been able to produce enough refined products to meet domestic daily needs for benzene, diesel, kerosene and LPG. Currently domestic production produces appoximately 8 million liters per day (lpd) of benzene vs a total daily requirement of 16.8 million lpd; approximately 11 million lpd of diesel vs a total daily requirement of 17.5 million lpd; approximately 8 million lpd of kerosene vs a total daily requirement of 18 million lpd (15 million lpd during the spring); and, approximately 2500 tons per day (tpd) of LPG vs a total daily requirement of about 5700 tpd. Coalition Forces have been attempting to import the balance through contracts executed by Task Force RIO, and through the Ministry of Oil (via SOMO) on both barter and cash contracts. TF RIO is currently under the operational command of CPA-Oil.

In addition to importing fuel to meet the national demand, there is a requirement to build reserves to offset increasing demand. This request includes enough imports to continue to build a 15 day supply of LPG, benzene, kerosene, and diesel.

The Defense Energy Support Center (DESC) shall be awarding contracts to deliver fuel to the Iraqi people, commencing performance 1 April 2004. Funding in this request shall be utilized to reimburse costs associated with DESCs contracts during the first month. \$40 million is requested for SOMO to contunue their import attempts.

3. Coordination. The requirement has been coordinated with the Director of Oil Policy, the Director General of the Iraqi Ministry of Oil, the Ministry of Finance, and Ambassador Bremer.

4. Goods and Commodities. Benzene, Kerosene, and Diesel are delivered primarily by truck from Kuwait, Jordan or Turkey. LPG is delivered by truck from Turkey and Kuwait and via barge at the Khor Zubayr terminal. The monthly cost for all fuel deliveries based on forecasted production rates and projected imports by both RIO and SOMO are as follows:

Funds for RIO will be allocated through an Economy Act Order to the US Army Corps of Engineers to be obligated against current and competitively bid future fuel import contracts.

5. Project Implementation. The project manager is the USA Corps of Engineers, Task Force RIO, opconned to the PCA Ministry of Oil. The RIO imports are executed through the RIO contractor, Kellog, Brown and Root (KBR). On 1 April 2004, DESC will execute that portion of the import mission currently assigned to KBR. The hand-off is currently underway to ensure a smooth implementation. As SOMO increases their share of the imports, funds will be reallocated from the RIO share of this request into the SOMO share. The total funding required for the import mission shall remain basically the same as we transition from KBR to DESC execution, and then ultimately on to SOMO executing the mission-minus the difference in the efficiencies between SOMO and RIO execution.

1. Purpose: Emergency Response Pipeline Repair Operation (ERPRO)

A contract is being awarded to provide the technology, tools, equipment, training, and personnel to implement a suitable ERPRO for quick response and restoration of pipeline service for all pipelines in the Central and Northern regions of Iraq.

The intent is to implement the ERPRO contract on an immediate basis while training local Iraqi technicians and operators to transfer technical capability and responsibilities with minimal foreign ex-patriate supervision or labor within a practical transitional period and contract timeframe. This capability will eventually be transferred to the Ministry of Oil (MOO) under one of the designated operating companies, and funded under the MOO operating budget.

Contract is for two teams, one located near Bayji refinery in the north, and the other in the vicinity of the Oil Pipeline Company yard at the Al Daurah refinery, Baghdad.

The initial cost estimate was for \$25M, but included a significant requirement on the Government's behalf to provide security, heavy airlift transportation, and additional contract services for local equipment and personnel. Under a competitive bid process, the low bidder structured their proposal within this cost estimate but included a number of significant open ended obligations for the Government to pay at a later date. The other bidder's proposal cost was 99M Euros. (\$124.38M at 02/5/04 rate of 0.795945 dollars /euro.)

The contracting activity determined that it could not obligate to an unspecific open ended obligation and requested the contractor define the additional requirements under a firm fixed price environment. The contractor defined these costs which will require additional funds to award.

2. Justification.

Continued reduction in refinery output due to pipeline sabotage. For example, Daurah refinery was recently reduced to 50% of capacity due to sabotage of the pipelines supplying crude oil. Bayji is currently at reduced capacity due to a reduced crude flow and the inability to remove residual fuel oil from the refining process due to a recent sabotage event East of the Al Fatah crossing. Reduction in the length of time pipelines are non-operational will significantly reduce the losses (directly affecting crude exports and volume produced for petroleum product imports). Rapid repair will also make the pipelines a less lucrative target for saboteurs by minimizing the impact of the breaks. Rapid repair capability can also restore current inoperative pipelines and increase the revenue to export, and increase the production of the refineries with a corresponding decrease in refined fuel import costs.

The initial RIO cost estimate was \$25M based on limited market research and order of magnitude pricing data. At the time, security, transportation, life support, and contract support workers was not specifically addressed. When the initial proposals came in, these items were excluded from the proposal but were required to be supplied by the Government.

This PRB request is for the "delta" of \$34.4M that funds the items not included in the original cost estimate and not addressed in the statement of objectives—but is still required for successful execution of the project. The Government could elect to provide contract support, security, air transportation, and work site life support as a separate obligation or with military assets. This request will make the contractor fully responsible for all aspects of the operation and not overburden an already strained set of assets that are needed for combat support.

3. Coordination. The requirement has been coordinated with the Director of Oil Policy and the CPA Chief Operating Officer. The initial contract proposal was approved by AMB Bremer.

4. Goods and Commodities.. N/A

5. Project Implementation. The current contract proposal has gone through a competitive bid process, has been evaluated as the superior technical proposal, and even with the cost growth due to the incorporation of prior Government support items is below the next competitive bid, and can be directly awarded by the CPA contracting office.

The item that stands out in this proposal is the IMMEDIATE mobilization of worldwide personnel, equipment, manpower and support services to directly execute the mission of restoration of the pipeline network and capability to repair any sabotage or attack on the pipeline. Partial capability to execute this mission is attained in weeks after notice to proceed. Full capability is expected in 7 weeks after NTP will complete heavy repair and training capability.

With the contract evaluation and the competitive bid process, this proposal is considered fair and reasonable by the CPA contracting office now, and is evaluated as technically sufficient now.

1. Purpose. Iraq holds more than 112 billion barrels of oil – the world's second largest proven reserves. Iraq also contains 110 trillion cubic feet of natural gas. Overall, only about 2,000 wells reportedly have been drilled in Iraq (of which about 1,500-1,700 are actually capable of producing oil). Iraq's main export crudes come from the country's two largest active fields: Rumaila and Kirkuk. Oil industry experts generally assess Iraq's sustainable production capacity at no higher than about 2.8-2.9 million bbl/d, with net export potential of around 2.3-2.5 million bbl/d. In comparison, Iraq was producing 3.5 million bbl/d in July 1990.

Iraq's southern oil industry was decimated in the Gulf War, with production capacity falling to 75,000 bbl/d in mid-1991. The largest producing oil field in this region is Rumaila. The war resulted in destruction of gathering centers and compression/degassing stations at the Rumaila field. Other problems at Iraqi oil fields include: years of poor oil reservoir management; corrosion problems at various oil facilities; deterioration of water injection facilities; lack of spare parts, materials, equipment, etc.; damage to oil storage and pumping facilities; and more. World economic experts estimate that Iraq could reach production capacity of 4.2 million bbl/d within three years and 4.5-6.0 million bbl/d within seven years.

2. Justification. The South Oil Company's oil production is now close to its pre-war limit. Further oil production increases can be expected after water injection rehabilitation and repairs of existing wells (workover and well completion operations). However, it is not feasible to achieve long term production increase and sustainability without drilling new wells. SOC plans a 60-well drilling campaign to address the long term stability of crude oil production. The drilling program covers wells that can be easily tied to the existing oil infrastructure with negligible cost (South Rumaila, Buzurgan, Jabal Faqui) or with minimum expenditures for expansion of the oil facilities (South Rumaila Mishrif, Majnoon, Nahr Umar, West Qurna).

Further production enhancements can be expected in conjunction with the new drilling program. The South Oil Company plans to execute a well intervention program. For instance, there are 15 wells which are former producers from the Zubair formation in the south that once returned to production would yield 4,000 per well. Similar actions can be taken in the northern fields.

3. Coordination. The requirement has been coordinated with the Director of Oil Policy, the Director General of the Iraqi Ministry of Oil, the Ministry of Finance, and Ambassador Bremer.

4. Goods and Commodities. A drilling campaign in conjuction with a planned workover program would help substain and actually increase crude oil production from existing oil fields. The return on expenditures would be realized from the replacement of production that has been shutin due to well problems, sabotage, or from natural decline. Additional incremental revenues would be realized as new/repaired Gas Oil Separation Facilities come on line or as new export points become available.

5. Project Implementation. The Ministry of Oil has capital improvement projects that have been in the planning stages for the past year pending receipt of funds to continue. In addition to the above, there are currently 3 construction/improvement projects where the Ministry is soliciting tenders for construction. The Ministry would be responsible for gathering and reviewing the tenders and selecting the most responsive bidder. The Ministry will oversee all work. Project includes:

Purpose/Objective: This Task Force is charged with the oversight and coordination of the various coalition efforts working to build the Iraqi oil infrastructure. The primary goal of the Task Force is to increase oil product flow from the ports and refineries in the south to the rest of Iraq. This increase will help to mitigate the shortage of heating, cooking, power and transportation fuel supplies throughout Iraq.


Justification: Currently there is only one contractor with lodging available right now at the Basrah airport. Al-Bahar and Bardawil (B&B) have two trailers available immediately for the (4) Task Force members. Other lodging in Basrah proper is not suitable and/or geographically undesirable. The majority of project work will be south and west of Basra city proper. Due to the security environment and the avaiability of escort services, the Task Force is more effectivel deployed out the Basrah airport grounds.

Coordination: Coordination with the Corps of Engineers, MND/SE and CPA South, has been done and will be ongoing throughout the life of the project.

Goods and Commodities: Requesting sole source contract to B&B lodging at the airport. Justification for sole sourceing is based on the need to move in quickly, get the offices up and running under a short time frame. Because of the winter fuel demands, this Task force cannot wait for the contract process. KBR and other contractors with similar lodging are full and have no room and will not have additional lodging available for several months. B&B has two trailers immediately available in move in condition: Lodging includes (3) meals a day, laundry services and internet connection/office facilities at \$120.00 USD per day per person. This price is cheaper than what TF RIO pays KBR and about the same as what TF RIE is paying their contractor for lodging.

Project Implementation: Via sole source contract. The disbursement of funds will be through the CPA, Ministry of Oil.

Cost Estimate: The requested cost estimate of \$86,400 is based on a four man team at \$120.00USD per day for 180 days. Funds will be dispursed on a monthly basis.

MEMORANDUM

Program Review Board (PRB)

Subject: De-Mining and Unexploded Ordinance (UXO) Removal from the North Al Rumaylah Oil Fields.


Purpose/Objective: To allow the safe access to all areas of the Al Rumaylah North Oil Field to the Iraqi repair workers.

Justification: Current infrastructure repair under the Corp of Engineers (TF RIO) removed only those mines and UXO from around the oil wells that needed immediate emergency repair. This work concentrated on getting the oil fields running and producing crude oil for export to raise the needed capital for Iraqi reconstruction projects. To maximize and improve the flow of oil and thus increase the amount of exported crude, repair and maintenance work will have to be done on the rest of the North Rumaylah fields. The ultimate result will be the increase in crude oil production and an increase in needed capital for Iraqi reconstruction.

Coordination: Coordination with the Iraqi Ministry of Oil and the Corps of Engineers has been done and will be ongoing throughout the life of the project. Coordination and support with the Iraqi Mine Action Center has been done and will be on-going.

Goods and Commodities: The Iraqi Mine Action Center has companies and support infrastructure in place to assist and coordinate the project.

Project Implementation: Via contract. The Iraqi Mine Action Center has contracts within the country now that will be leveraged. The disbursement of funds will be through the Ministry of Oil. The Iraq Southern Oil Company under the direction of the Ministry of Oil will monitor the project. From contract implementation to assessment will take 4 weeks. Actual de-mining and UXO removal will commence 2 weeks after the assessment. Anticipated life of the project is 8 weeks.

Purpose/Objective: Expand the current ERINYS International Guard Force contract, and provide personal security for Ministry of Oil Director-Generals.

. . .

Justification: Terrorist threats against Iraqi oilfields, pipelines, pumping stations, refineries, oil workers and critical oil nodes have increased, inflicting significant damage to the Iraqi oil infrastructure. The Coalition Provisional Authority (CPA) through the Iraqi Oil Ministry awarded a contract to ERINYS International in September 2003 to stand up an Iraqi Oil Security Program. This contract mandated that ERINYS International hire, train and equip 6,400 Iraqi guards and 40 roving patrols to protect 175 oil facilities to include critical nodes along the 7,000 kilometer pipeline.

a. As a consequence of the expanding insurgency and increased targeting against the oil infrastructure, a significant increase in force levels is required. Detailed analysis by security and intelligence staff indicates that an additional guard force of 7,500 Iraqi guards and support expatriate management staff is required. Without the immediate funding of this requirement, fatalities against Coalition Forces and contract personnel will continue as well as attacks against oil infrastructure. In the last two weeks alone, KBR employees were attacked twice and sustained 1 KIA and 5 WIA. Oil will continue to be the main economic source of income for the government of Iraq. Without the ability of the CPA, Coalition Forces and the Oil Ministry to secure the critical oil infrastructure, production levels will never exceed pre-war levels. Estimated Requirement: \$20.8 Million.


b. Personal Security for Ministry of Oil Director-Generals (DGs). In early November, one of the Ministry of Oil DGs was the subject of an attack where he was wounded in the leg and his son was killed. As terrorists become bolder and increasingly desperate, Oil Executives become more likely targets for violent acts. Services are required to provide personal security for the 8 DGs for a period of 6 months. The Ministry of Oil will be responsible for procuring funding to extend the period of the contract beyond that point. Estimated Requirement: \$1.2 Million.

This is in addition to the \$10 million already authorized for air surveillance.

Coordination: This requirement has been coordinated with the Senior Advisor to the Ministry of Oil, and with the Director of Studies and Planning for the Ministry of Oil.

Goods and Commodities: None; these are service contracts.

Project Implementation: ERINYS International can commence implementation immediately and will have completed implementation within 90 days.

1. Purpose/Objective: To fund critical oil infrastructure security requirements.

**Detailed** Description:

a. Air Surveillance. In response to the increasing threat to the oil infrastructure, specifically pipelines, we propose to add aerial surveillance capabilities to the contracted security force. Erinys can provide dedicated support with the Air Scan system, which they have used before in other similar situations. The Air Scan system is a low-light television sensor mounted in a two-engine commercial aircraft. A relay aircraft provides the downlink to the associated ground station. This system can provide the needed imagery with near-real time analysis and dissemination. Estimated Requirement: \$10 Million.

2. Justification: The most significant impact of not providing this funding is continued reduction in refinery output due to pipeline sabotage. For example, Daura refinery was recently reduced to 50% of capacity due to sabotage of the pipelines supplying crude oil. The Erinys air surveillance will significantly reduce the frequency and severity of pipeline sabotage incidents.

3. Coordination: The requirement has been coordinated with the Director of Oil Policy and the Director General of the Iraqi Ministry of Oil.

4. Goods and Commodities: Not applicable.

5. Project Implementation: It is our intent to accomplish this by modification of an existing contract.

#### Description of Program or Goods To Be Purchased - Please See Above Instructions

1. Purpose. To fund the emergency import of LPG, Benzene, Kerosene and Diesel.

2. Justification. The Iraqi domestic refining capacity has not yet been able to produce enough refined products to meet domestic daily needs for benzene, diesel, kerosene and LPG. Currently domestic production produces appoximatley 6.7 million liters per day (lpd) of benzene vs a total daily requirement of 16 million lpd, approximately 10.4 million lpd of diesel vs a total daily requirement of 17 million lpd, approximately 10.7 million lpd of kerosene vs a total daily requirement of 12.0 million lpd and approximately 1072 tons per day (tpd) of LPG vs a total daily requirement of about 5200 tpd (production amounts update from last report to reflect lower values; consumption amounts updated from last request to reflect higher winter demands). The Coalition Forces have been attempting to import the balance through contracts executed by Task Force RIO, and through SOMO on both barter and cash contracts. TF RIO is currently under the operational command of the OCPA, Oil Ministry.

In addition to importing fuel to meet the national demand there is a requirement to build reserves to offset increasing demand for the winter months. This request includes enough imports to build a 15 day supply of LPG, benzene, kerosene, and diesel.

\$100 million is being reserved for SOMO in this request.

3. Coordination. The requirement has been coordinated with the Director of Oil Policy, the Director General of the Iraqi Ministry of Oil, the Ministry of Finance, and Ambassador Bremer.

4. Goods and Commodities. Benzene, Kerosene, and Diesel are delivered primarily by truck from Kuwait or Turkey. LPG is delivered by truck from Turkey and Kuwait and via barge at the Khor Zubayr terminal. The monthly cost for all fuel deliveries based on forecasted production rates and projected imports by SOMO are as follows:

Funds for RIO will be allocated through an Economy Act Order to the US Army Corps of Engineers to be obligated against their fuel import contract.

5. Project Implementation. The project manager is the USA Corps of Engineers, Task Force RIO, opconned to the OPCA Ministry of Oil. The RIO imports are executed through the RIO contractor, Kellog, Brown and Root (KBR). Other options, including using existing Defense Energy Support Center (DESC) contracts, are being explored.

Discussions are currently underway to turn the mission over to DESC, so that further imports may be conducted using funds from the Supplemental Appropriation. It will take some time to put appropriate contracts in place in accordance with the Law, as well as to have an orderly transition of the operational supervision of the import mission. It is expected that this transition can be complete no earlier than the end of January. All parties coordinated with have concurred in this recommended course of action.

The current amount allocated to imports through TF RIO by PRB#551 (\$125,000,000) will be exhausted on or about 15 DEC 03. This request will fully fund imports through 31 JAN 04.

It is the intention of the Director, Oil Policy to begin to reduce imports, in conjunction with expected increase of domestic refining capacity. Current projections are to significantly reduce the import of LPG via truck by the end of December 2003 and rely primarily on the imports via barge through the end of March, 2004. The import of benzene will continue through the end of January, 2004, due to the scheduled maintenance shut down of the Bayji Refinery in November through December. Quantities will be reduced, however, as stocks are built up and refinery capacity increases. Diesel and Kerosene imports will continue through the end of March, 2004 but at reduced levels after December, 2003. This schedule, however, has been impacted by repeated oil pipeline breaks and electrical power shortages and by the smuggling of diesel. We continue to monitor the requirement a month at a time.

Dear Jerry,

I absolutely regret not being able to see you before I departed from Baghdad this morning, but I understand exactly what important work on the Transitional Law you are trying to accomplish. I hope you are soon successful on this effort.

I wanted to reiterate what I've said to you in the past and that is how much I was honored to be a part of your team. You are of course making history here and I feel that, when the dust finally settles, Iraq and the world will be better off by what you've done. So please accept my congratulations for a job well done.

I've attached a couple of things. The first is today's RIO SitRep. I've had four or five major objectives that you and I agreed on when I came as follows:

• Production and exports were about 1.8 and 1.1 million barrels a day respectively when 1 arrived back in September and today they set new highs of 2.54 and probably 1.9 million barrels a day. Both of these are near or at pre-war levels, and while the numbers are probably not completely accurate due to the lack of metering in the country, they are still indicative of a continually upward trend. They also fulfil two important April 1<sup>st</sup> milestones for CPA.

Two of my most pursued goals were to get the IT line back in operation and to get the Khor al Amaya terminal open again. Both of those, at least today, are open and are key to continuing the upward trend in production and exports.

• Through a magnificent effort that doesn't get near the credit it deserves, Iraqis made it through the winter in better shape, relative to fuel products, than they've enjoyed in a long, long time and it was done without any civil disobedience to speak of. You should, when you have the time, pause to reflect on the great humanitarian effort you authorized and directed.

Our major effort now has to be to make SOMO and the rest of the Oil Ministry capable of continuing this effort post-June 30<sup>th</sup>. And this training is well-organized and underway. SOMO's import performance is already improving, if you judge the SitReps recently.

• We basically have an effective oil security force in place and they will continue to get better. I feel strongly that it is at least in part because of this increased capability that attacks on our infrastructure are down and we have finally gotten a few weeks of oil being put in the IT pipeline.

Again, one of our main jobs is to ensure that this security force is sustained pass June  $30^{th}$  and that the oil ministry is truly capable of assuming the command. This effort is also well-organized and underway.


• We have made progress in getting the ministry restructured and operating under very high standards of conduct. But if I have a disappointment, it is that this effort is not further along. I feel strongly that, among all your other priorities, you need to help Mike Stinson and the team get over the hump here, even if it means taking some unilateral actions such as imposing a structure on the minister or getting directly involved in personnel actions. You certainly don't need me to point this out, but if we get this right, it will be one of the key building blocks in achieving the Coalition's goals in this country.

Note that I have started the PRB paperwork, in consultation with Rodney Bent, to procure \$200 million for the Oil Ministry's capital budget. You and I have discussed this many times and you will recall that we agreed we would provide this money to them when they began to make significant progress towards reform. While they are not there yet, I wanted to have this taken care of so that it would be available when you and Mike Stinson agree on the exact timing for providing it to them.

I didn't mean to get this long-winded, but wanted to say again how much I appreciated your faith in me by asking me to take this job on. I will always remember it as a highlight of my life and oil industry career.

Finally, I'll end on a lighter note. I've attached a picture of you that appeared in the Houston Chronicle in mid-September, just days after I accepted the Sr Advisor position and as I was packing for Baghdad. It was the first time I'd ever seen your face. At the time, I thought that the camera angle made it look like you were kissing some guy with a white beard and a turban, so I was going to bring the picture to tease you a little bit (assuming I got to know you well enough to do so). Of course, among all the other things I've learned since I've been here, I found out you really WERF kissing the guy. Go figure!

Anyway, Jerry, I wish you good luck and safe passages. You deserve a medal for what you've done and are continuing to do. I hope our paths cross once again. If you ever peed to get in touch with me, my Houston email address is (b)(2)

# Powell lauds rebuilding effort in Iraq

#### 'Deeply impressed' by progress seen on visit

BAGHDAD, Iraq - Secretary of State Colin Powell said Sunday that he was "deeply impressed" by the progress of the U.S.-led effort to reconstruct Iraq and guide the country toward self-rule despite continuing attacks on American forces and critical infrastructure.

Powell, the highest-tanking American to visit Iraq since Saddam Hussein's gov-erament was toppled in April, arrived aboard a C-130 military transport and spent the day meeting with U.S. military speak the cay meeting with U.S. minitary commanders, reconstruction officials and members of Iraq's Governing Council. He also attended a session of the Baghdad City Council and had funch with Iraq's newly appointed foreign minister.

Although Powell speat the day in a high-security bubble and met only with Iraqis who had been vetted by the U.S. occupation authority, he expressed satis-faction with the pace of the American re-construction effort, which has been criticized as too slow by many ordinary lengis. - (S) The OSD-led interagency group dealing with Iraqi oil issues recommends that you designate the Army as Executive Agent for this program. You directed CENTCOM and my office to develop contingency plans for continuity of oil production and sales. If these plans are to be executed there needs to be an overall executive agent that will be responsible for planning, coordinating and administering the execution. If you approve the recommendation, General Franks will retain overall responsibility to develop and execute plans in the context of a US military occupation of Iraq. The Army will have responsibility for planning, coordination and execution of the operation for the Iraq oil industry including but not limited to the following tasks:
  - Establish and coordinate program requirements with the Joint Staff and USD(P);
  - Budget for program execution in coordination with USD (Comptroller);
  - Establish a program office as soon as possible;
  - Coordinate acquisition strategy with USD(AT&L);
  - Negotiate, but not award, a contract for execution with the developer of the plan that can be awarded as soon as the Army receives direction to execute the plan;
  - Coordinate policy matters with USD(P); and

- 18) The OSD-led interagency group is now refining a draft Contingency Support Plan for repairing and operating the Iraqi petroleum industry. We expect the plan will be ready for your review by mid-January 2003. To be poised to execute the plan immediately if directed to do so, we need to engage the right organizations to budget for and manage the execution phase of the plan. As a new program, this effort has no owner and no funding. Best to worst case estimates for the execution phase range from \$0.8 billion to more than \$3.5 billion.



# **Guiding Principles**

Certain principles should guide any temporary US/coalition administration of Iraqi petroleum resources, including:

- Iraq's oil resources are an asset that belongs to all the Iraqi people.
- Any temporary administration of Iraqi oil production and marketing:
  - Will seek to minimize disruptions and promote confidence and stability in world markets;
  - Should involve existing Iraqi personnel and organizations whenever possible to ease future transition;
  - Should work with the international community to build support for our policies;
  - Will respect Iraqi contracts previously approved by the United Nations (NB: Just service contracts, no development contracts);
  - Will be conducted transparently and accountably, in accordance with applicable legal norms and prudent industry practices, for the benefit of the Iraqi people;
  - Will prepare for the return of production and marketing responsibility to a stable Iraqi authority as soon as practicable.
- The initial goal should be to bring Iraqi petroleum production up to pre-hostility capacity of about 3.1 million barrels/day, consistent with sound business considerations.
- Any increase in production levels and capacity should serve the interest of maximizing revenues for the people of Iraq.

# **Public Diplomacy--Main Themes**

- Iraqi petroleum resources are a national asset of all the Iraqi people, i.e., the nation as a whole, and not of any regional entity.
- We want to work with the Iraqis themselves and the international community in administering petroleum proceeds for the benefit of the Iraqi people.
- Interim administration decisions will be based on prudent, accountable, best practices to prepare for the return of the sector and its management to responsible Iraqi authorities.
- We will act, through our administration, so as not to prejudice Iraq's future decisions regarding:
  - Its oil development policies.
  - Its relations with international organizations.
  - The future ownership structure of the its oil industry.
- US/Coalition will fulfill its responsibility to the Iraqi people to create conditions of stability and well-being for the people of Iraq, but we will not administer oil assets on a long-term basis.
- Petroleum proceeds will be handled transparently and used for the benefit of the Iraqi people.
- We will respect the legitimate interests of all countries in the reconstruction period.
- We will respect Iraqi contracts previously approved by the United Nations.

# **Contingency Plans for Repair**

- OUSD(P)/Energy Infrastructure Planning Group ("EIPG") manages planning.
- EIPG guidance to the Army contractor:
  - Plan for full range of damage scenarios: Little or no damage, to major disabling damage by Iraqi forces to key choke points (e.g., gas and oil separation plants, marine terminals, pumping stations).
  - Fight over 1,000 well fires, if necessary.
  - Repair priorities:
    - First, restore current *production* of about 2.4 million barrels per day as soon as conditions permit.
    - Second, restore current *capacity* of about 3.1 million barrels per day.
- Plan (draft) calls for modular components for major facilities (e.g., gas-oil separators, pumping stations) wherever needed, to restore production ASAP.
- "Best case" = No infrastructure damage, just safety repairs needed.
  - 6 mos. to 2.4 million b/d, 9 mos. to 3.1 million b/d.
  - Cost: appro. \$0.8 Billion.
- "Worst case" = Major, disabling damage throughout infrastructure.
  - -20 mos. to 2.4, 30+ mos. to 3.1.
  - Cost: \$7 to \$8 Billion (oil only). Refineries and gas plants add another \$4-\$5 Billion.

      - Would continue to warrant good title to buyers.
      - Would help reassure markets, reduce likelihood of later disputes about validity of sales.





## **Organization and Management**

- Deputies agreed to recommend establishing an organization dedicated solely to managing Iraqi petroleum industry.
  - Corporate organizational model ("Iraqi Oil Temporary Administration" -- "IOTA") drawing on current Iraqi Oil Ministry structure.
- To "internationalize," appoint:
  - Chairman
    - American.
    - Current or former statesman.
  - Chief Executive Officer.
    - British or other international.
    - Former chairman or CEO of oil company.
  - Vice Presidents for each functional sector within current Ministry.

  - Board of Advisors.
    - Advisory only, non-binding on management.

- Recommend: Chairman reports to top civil administrator; CEO reports to Chairman.


### **Petroleum Proceeds: Possible Uses and Availability**

### secret//NOFORN Funding Enhancement: Borrow Against Future Oil Revenues?

• Major issues:

- Recent Iraqi oil revenues may not support major loans (i.e., billions of dollars) without new development contracts in place to back them up.
- Who would borrower be during temporary administration? Iraqi Central Bank? Would it still exist and function?
- New lender(s) likely to demand subordination of pre-existing debt and third-party guarantors (other governments?).
- Likely to require rescheduling Iraq's existing foreign debt (about \$82 billion at end 2002 assuming 6% interest rate).
- Iraq also owes \$27 billion in unpaid claims awarded by UN Compensation Commission for Gulf War damages.

## Iraqi Production Goals: Initial Objective

Bring production up to prewar capacity level of about 3.1 million barrels/day (b/d).

We have contingency plans to do this (see Slides 5 and 6).

- Current actual production: 2.4 million b/d.
  - Annual revenue with \$18-28/barrel average price range: \$16-25 B.
- Current production *capacity*: 3.1 million b/d (CIA).
  - Some in private sector say sustainable capacity closer to 2.8 million barrels/day (b/d), with significant rehabilitation needed to reach 3.1.

### Increasing Iraqi Production: Considerations

### Advantages

- Speeds Iraqi rehabilitation and stability.
- Supported by many in Iraqi opposition.
- Puts long-term downward pressure on price.
- Helps consumers.
- Diversifies/increases global oil supply and spare production capacity in long-term, if no price war.
  - Strengthens global economic security.
  - Only 3.7 million b/d of global spare capacity (CIA), or 5% of demand.
  - Saudis have 2/3 of global spare capacity.

### Disadvantages

- Politically controversial, especially if new fields are developed.
- Might trigger a price war, which would likely decrease Iraqi oil revenues and could drive out higher-cost producers, thus reducing diversity of supply.
- Some would argue that new Iraqi government should decide.

• Existing deals: IOTA should observe contracts previously approved by UN. Query whether should observe those made in hopes sanctions eventually would be lifted?

- Four "fee-for-service" maintenance contracts (three Russian companies, one Turkish) currently approved by UN under OFF. (See Back Up Slide).
- Iraq has signed about four capacity expansion contracts (Chinese CNPC, Petro Vietnam, Tunisian ETAP, maybe Syrian Oil Co.), which await lifting of UN sanctions.
  - French Total Fina Elf initialed but reportedly not yet signed.
  - Iraq recently abrogated Russia's Lukoil contract.
- Over 60 foreign companies pursued various stages of oil negotiations since sanctions were imposed.
- Iraqi opposition opposed to honoring deals made by Saddam unless clearly in Iraqi interests.
  - Better to defer these for new Iraqi government to decide.
- US and British companies were not allowed to do this.


• New deals: As a rule, should be based only on economic return, open competition, and sound business practices.

- IOTA will likely need to contract with foreign companies -- whether to expand production capacity or to maintain existing capacity.
  - Repairs from war damage, safety upgrades, normal operations and maintenance.
- Should be governed by sound business decisions unless compelling reasons otherwise.
- Generally let IOTA management run it like a business.

#### SUBJECT: Hillman Paper

- You asked (Tab A) for my view of Jerry's Hillman's proposal for an oil deal involving the Iraqi Pipeline in Saudi Arabia (IPSA). IPSA is:
  - An Iraqi asset built during the Iran-Iraq war to ship 1.1 million barrels/day from southern Iraq to the Red Sea via Saudi Arabia. Besides pipeline/terminal, several pump stations exist along with ten 1 million barrel storage tanks.
  - Pipeline displacement approximately 11.1 million barrels. At current prices approximately \$275 million.
  - It has not been used since 1990; estimated time to restore pipeline/terminal unknown. Iraqi Oil Ministry concerned about possible radioactivity at pump station ISPA2A. Pump station was reported destroyed during Desert Storm by spent uranium rounds.
  - Saudis expropriated the part on Saudi territory in June 2001.
- Hillman proposed a swap whereby a Saudi-led consortium would pay upfront (perhaps \$2.25 B) for Iraqi oil that will be delivered via IPSA at some later date.
- IPSA could serve as a backup to current Iraqi export routes.
- However, it might take time to resolve the Iraqi-Saudi legal dispute over the pipeline, and Hillman's swap could add to Iraqi debt.
- On October 7<sup>th</sup>, Paul Bremer discussed the issue of reopening the IPSA pipeline with Mr. Ibrahim Bahr al-Uloum, the Iraqi Oil Minister and Robert McKee, the new CPA Oil Advisor. Mr. Ibrahim Bahr al-Uloum was asked to take a first look at the issue and then discuss with Robert.

#### Recommendation

• Do nothing at this time. Wait and see what action plan develops out of CPA Oil and the Iraqi Oil Ministry before making any decision.

SUBJECT: Recommendations for Comprehensive Subsidy Reform

You have asked us to combine our efforts and prepare for you a plan for comprehensive subsidy reform. We have met and discussed this issue at length and we have considered and incorporated the earlier contributions of Phil Carroll's group including (b)(6) and (b)(6) and (b)(6) a July 18 paper by the World Bank, papers by (b)(6)

(b)(6) and others, and the opinions of several subsidy policy experts including (b)(6) (b)(6) and (b)(6) of the World Bank and (b)(6) of the Center for Strategic and International Studies. These are our recommendations:

#### Separation of Certain Reforms

Four broad areas of reforms should be addressed separately. They are:

- <u>The Food Basket</u> A reform policy for the food basket has already been determined and is in the process of being implemented making it difficult to incorporate into other subsidy policy reform.
- **Energy** Energy subsidies in the form of below market fuel and electricity prices are a large and critical area requiring near term reform. These subsidies are interconnected and require a comprehensive policy.
- <u>Agriculture</u> Agricultural subsidies are significant, but create less critical distortions in the economy than the food basket and energy subsidies. The agricultural sector will be significantly affected by the monetization of the food basket and energy subsidy reform. We recommend agricultural subsidy reform be treated separately and be left for later consideration when the impact of other reforms on the agricultural sector are known and the political effects of agricultural subsidy reform are better understood.
- <u>Other Subsidies</u> There are other subsidies of a less critical nature on isolated goods and services which we recommend be addressed separately and not be included as part of a more comprehensive policy.

As a result of this separation of subsidy reform, we are only addressing energy policy at this time as the food basket is decided and underway, agricultural reform should wait, and other subsidies can and should be treated individually.

#### Energy Subsidy Reform Recommendations

We agree on the following recommendations to you:

- Energy subsidies should be reformed all at once and not in a series of small steps. Most energy subsidy reforms have been implemented in small steps because governments rarely have the political confidence to implement reforms in one move. However, most experts believe that if the political will exists, the political cost and risk associated with reform is less if the reforms are implemented in one move. These experts say at the same time, however, that single step reform should not be a sneak attack. It must be well communicated and publicly debated in advance. A second reason for recommending a one time move is that in a discussion with the Governing Council we may be forced into a compromise including implementation in several steps. If we start with a proposal for a single move we can go to two or more steps, but it would probably not be possible to go from several steps to a single move.
- A single step liberalization of energy prices must include a concurrent compensatory payment of cash to cover the increased cost of fuels. Liberalization of energy prices will increase the costs of energy to consumers. This burden will fall disproportionately on lower income Iraqi's. To be fair and politically acceptable, a compensating payment should be made to everyone in an amount as yet undetermined, but it should be no less than the amount by which the typical lower income Iraqi's fuel costs rise.
- A cash compensation payment to ease the burden of increased energy prices should be structured to be temporary. The cash compensation payment should be fixed in amount, not indexed, and should contain other features to assure it does not become a permanent subsidy.
- Fuel subsidy reform should be implemented by having the Ministry of Finance impose a fee at the refinery equal to the regional parity price of crude oil plus appropriate delivery costs. All operations would be required to operate without any financial subsidy and would be required to earn and remit a return on capital, thereby forcing them to price all oil related products at or near market prices.
- Electricity subsidy reform should be implemented by raising electricity prices to regional free market rates. Rates for all consumers of electricity should be raised at the same time as fuel prices, but enforcing payment by residential customers at the new rates should be introduced gradually taking into account political factors and changes in demand on the electrical grid resulting from increased fuel costs.
- Two interdepartmental task teams should be staffed with fulltime people to implement the food basket monetization program and energy subsidy reforms. Properly implementing both subsidy reform programs will be challenging. We believe it will best be done by two dedicated teams. The food basket team would take-on responsibility for implementing the monetization payment system for both subsidy

reform programs. The food basket monetization team would report to OMB. The energy subsidy reform team would report jointly to the Directors of Economic Policy, Private Sector Development, and OMB, with OMB serving as the primary report on implementation matters.

• A number of implementation challenges should be addressed soon and aggressively. To ensure successful reform implementation a number of challenges with long lead times must be addressed soon. The most important of them are:

- Determine the details of the energy reform proposal including the implementation date, the amount of the compensatory payment, and other requirements for its implementation.
- Begin consultation with the Governing Council in November and, as soon as possible thereafter, announce the plan for public comment.
- Develop a means for making a compensatory payment by the implementation date.
- Begin working with the Ministry of Oil, Electricity Commission and others to prepare for the impact of subsidy reform. For example, developing stockpiles in anticipation of demand fluctuations, ensuring that opening of new retail outlets for fuel is unrestricted, developing means for addressing the lack of volume measuring equipment at many retail outlets, and managing the significant influx of cash revenues and changes to many Ministry budgets that will result.
- Initiate study of legal/regulatory impediments that constrain competition in refined oil markets – wholesale, retail, and import markets – in order to improve competition and influence scope for consumer price increases.

An open issue we have decided to leave for you to consider is the timing of energy subsidy reform. We believe the feasible options are to implement it March 1 or concurrently with the monetization of the food basket on July 1. We have identified pros and cons for each, but as a group had no strong opinion either way. The advantages of each as we see them are the following:

#### Advantages of a March 1 Implementation:

- Earlier implementation eliminates market distortions four months sooner.
- Not implementing at the same time as the food basket will result in less potential for too much happening all at once and the risk of resulting implementation problems.
- Cooler weather in March presents less external irritation than July weather and provides 4-8 weeks of milder weather during which adverse political reactions can be addressed.

#### Advantages of a July 1 Implementation:

- Doing everything at once may consume the least long term political capital.
- Allows four additional months to prepare for energy subsidy reform including implementing the compensatory payment system.
