Performance Work Statement for Near East South Asia Center for Strategic Studies Language Services 1. General: The contractor shall provide a team of approved personnel to provide language services (interpretation and translation) in support of the Near East South Asia Center for Strategic Studies (NESA).

Work performed under the contract will be performed at government owned facilities or government leased facilities in the CONUS and OCONUS locations to include hotel contracted for NESA events. Rented or leased spaces will be considered NESA Center facilities for the purpose of the contract. The NESA Center is currently located at the U.S. Coast Guard Headquarters, 2100 Second Street, S.W, Suite 4308, Washington, DC 20593. The contractor will perform support services and technical assistance at the NESA offices and other sites as designated by program needs. Contractor offices must be located in the greater Washington, DC, metropolitan area.

- 2. Background: The Near East South Asia Center for Strategic Studies (NESA), is responsible for developing civilian and military specialists in defense and security matters by providing graduate level programs in defense/security planning and management, executive leadership, civilian-military relations and interagency operations. The Center conduct: programs in the United States and in the NESA region and academic research as well as maintains contact with graduates and provides curriculum-related assistance and continuing education through the Internet and other informational and educational tools. Further information on the NESA Center can be found at their website (www.ndu.edu/NESA).
- 3. Scope: The contractor will assist the government team in providing language services that will enable the NESA Center to conduct its current programs and other programs that will be developed. The NESA Center's programs will include, but are not limited to those listed at Annex A.
- 4. Approach: The contractor will respond to the Contracting Officer's Representative (COTR), for policy and program guidance. The contractor will conduct business in a fashion that is consistent with Federal and DoD regulations. The contractor shall provide technically qualified, experienced linguist to support the detailed planning, organizing, coordinating and execution of numerous conferences, seminars and international programs as well as operation of the ongoing policy and outreach missions as specified in this Performance Work Statement. Experience working with senior government and military personnel is required and experience working within the Department of Defense is preferred.
- 5. Objective: This Performance Work Statement (PWS) provides the Near East South Asia Center for Strategic Studies, government-site and contractor-site, linguistic services. These services support Near East South Asia Center programs from 1 August 2006 through 31 July 2007, and four one-year option periods, if exercised. The contractor will provide an experienced project manager, and appropriately skilled personnel as required meeting the NESA Center's objectives. The calendar of planned events is at Annex B

Task 1—Simultaneous interpretation (CLIN1)

Performance Objective No. 1: Contractor to provide simultaneous certified interpreters

Performance Measurement No. 1: Simultaneous Interpretation services.

Performance Standard No. 3: English/Arabic/English; English/French/English; Dari/English/Dari

The COR will identify interpreting requirements 60 days before the event and will provide the contractor a draft "Language Agenda" (Annex C). The default Language Agenda is three Arabic/English/Arabic Interpreters; two French/English/French Interpreters and two Dari/English/Dari Interpreters. COR will work with the contractor to determine when the Language Agenda must be finalized for the event. Once it is finalized NESA Center guarantees the interpreting services will be used as stipulated on the agenda for the full time of the event, if the event is less than two weeks, 10 working days. If the event is more than 10 working days NESA Center guarantees 10 days of interpretation services in accordance with the Language Agenda. NESA Center inform contractor as soon as possible once NESA Center knows the composition of the participants and final interpreter requirements.

Interpretation is required to and from English, Arabic, French and Dari. If other languages are required contractor will be notified 60 days before the event. Programs requiring language services may be in CONUS or in the NESA region.

Most sessions require continuous effort. Sessions requiring interpreters usually begin at 0800 and last until 1130 or 1200 depending on daily schedule. A 1-½ or 2-hour break is generally given for lunch. Afternoon sessions usually begin at 1300 and end before 1700. The COR reserves the right to make changes or adjustments to the actual start time of the workday. Holidays most likely will not be seminar session days, but Government reserves the right to use the interpreters on a holiday as an emergency seminar day such as make up for a snow day. NESA Seminar or other group site visits may be scheduled during the week or on a weekend. If interpreter support will be required for site visits during an event, NESA will notify the contractor at least five (5) working days prior to the event.

The contractor will submit a complete assignment schedule to the COR prior to the commencement of each workweek covered by the contract and stipulated in the Language Agenda. The contractor will submit necessary or unforeseen changes of personnel in writing to the COR. The assignments may be either half day or full day. Interpretation services may also be required for official dinners, lunches, evening events, and weekend tours.

The contractor will ensure that all interpreters have an acceptable certification. Certification shall be as a court interpreter, through the Department of State Interpreters Examination or accreditation as an interpreter from a school of languages and linguistics. It is desirable that all interpreters be familiar with defense-related terms. The Contracting Officer reserves the right to require that the contractor remove and replace, within one working day, an interpreter who, in his judgment, is not qualified or who does not maintain the highest standards of professional conduct.

The COR reserves the right to require that interpreters assist in translation and editing services, if they are not serving as interpreters for the entirety of the eight-hour (full-day) or four-hour (half-day) assignment. (Example: If an interpreter is needed for interpretation services for only two hours during a four-hour assignment, the COR can require that the remaining two hours of the assignment be utilized in translation and/or editing services).

The contractor will be responsible for maintaining government-provided interpretation equipment, security of and daily maintenance of equipment for the duration of the seminar. Maintenance includes inspection, preparation and distribution, and replacement of batteries. The contractor will be responsible for the orderly and efficient storage of equipment. The contractor will be responsible for the day-to-day good order of the equipment room, interpreters' booth, and all other assigned working spaces.

Contractor will be required to set up at training location portable equipment, if national emergency dictates changed location and on local trips such as to Capitol Hill or field trips. The contractor will be responsible for the preparation and transportation of equipment required for off-site lectures, visits, and tours. The contractor will notify the COR as soon as possible if any equipment malfunctions or is inoperative.

If NESA does not have sufficient interpretation equipment for the program contractor will provide within 10 days notice.

The contractor shall assign a language supervisor on site who has had substantive experience in personnel management, logistics planning and administration in a seminar environment. Fluency in the Arabic language is desirable. The language supervisor shall display the highest standards of personal deportment and judgment; possess demonstrated organizational abilities and excellent communication skills. It is essential that the language supervisor have a working knowledge of the Washington, DC diplomatic and military organizations and the ability to interact with senior foreign representatives. The language supervisor acts as the single point of contact for all activities pertaining to interpreters, and interpretation equipment for the NESA COR.

When the language supervisor is not one of the interpreters, the language supervisor's hours will be on a part-time basis, up to 1/4 of total requirement, providing documentation of effort is provided.

7. Task 2 - Normal Translation Services (CLIN 2)

Performance Objective No. 2: Translation of materials from one language to another

Performance Measurement No. 2: Normal Translation services.

Performance Standard No. 2: Material required in more than 5 working days.

The contractor will translate various materials from English to Arabic and/or French/Dari/Kurdish, and from Arabic and/or French/Dari/Kurdish to English and edit to ensure smooth reading in translated language.

Contractor will deliver final product in hard and soft copy, MS-Windows compatible, CD-ROM or by electronic e-mail.

The principal point of contact at NESA for each article submitted for translation will be COR who will refer the translator to the SME for that particular article.

Task 3 - Expedited Translation Services (CLIN 3)

Performance Objective No. 3: Translation of materials from one language to another.

Performance Measurement No. 3: Expedited Translation Services.

Performance Standard No. 3: Material required in less than 3 working days.

The contractor will translate various materials from English to Arabic and/or French/Dari/Kurdish, and from Arabic and/or French/Dari/Kurdish to English and edit to ensure smooth reading in translated language.

Contractor will deliver final product in hard and soft copy, MS-Windows compatible, CD-ROM or by electronic email.

The principal point of contact at NESA for each article submitted for translation will be COR who will refer the translator to the SME for that particular article.

9. Task 4 Other Direct Costs (CLIN 4)

Contractor will be reimbursed for travel costs (see item 11, below). The contractor will work with the COR to ensure the contractors travel requirements are forecasted 90 days in advance. Contract personnel who travel to countries where danger pay is authorized will receive danger pay at the same rate as a government employee.

- 13.1. The Center's "core" operating hours are from 0700 to 1800 hours. The core working hours can be negotiated with the COTR and placed in writing in an emergency situation. Contractor personnel will take leave in coordination with the NESA and Federal legal holiday schedule. The contractor will establish regulations related to personnel time off

and monitor accordingly. Overnight travel may be required and travel cost will be in accordance with the rates established in the JTR.

15. Standard Definitions

- 15.1. Contracting Officer (KO). A person duly appointed with the authority to enter into and administer contracts on behalf of the U.S. Government.
- 15.2. Contracting Officer's Technical Representative (COTR or COR). An individual designated in writing by the Contracting Officer to perform as an authorized representative of the Contracting Officer to perform specific contract administrative functions within the scope and limitations as defined by the Contracting Officer.
- 15.3. Government Furnished Property (GFP). Property in the possession of, or directly acquired by the Government and subsequently made available to the contractor.
- 15.4. Government Property. All property owned or leased to the Government or acquired by the Government under the terms of the contract. Government property includes both Government furnished property and contractor acquired property as defined in FAR 45.101.
- 15.5. Government Furnished Material (GFM). Material in the possession of, or directly acquired by, the Government and subsequently made available to the contractor.
- 15.6. Government Material. All material that may be incorporated into or attached to a deliverable end item or that may be consumed or expended in performing a contract, i.e., raw and processed materials, small tools, supplies component parts, raw and processed materials.
- 15.7. Quality Assurance (QA). Those actions taken by the Government to assure services meet the requirements of the Performance Work Statement (PWS) and all other service outputs.
- 15.8. Quality Control. Those actions taken by a contractor to control the performance of services so that they meet the requirements of the PWS.
- 16. Government Furnished Property and Services
- 16.1. The NESA Center will provide working space and equipment, as listed below, only to the contractor employees who are directly assigned to perform tasks required or specified by the contract. The NESA Center will provide office supplies, materials, and equipment, to include access to telephones, copying machines, and desktop personal computers. Other administrative and communications support will be provided as required to perform the contract tasks.
- 16.2. The NESA Center will provide access to those documents and files that are relevant to the project and that are required to perform the tasks specified in the contract. Documents include studies, reports, plans, syllabi, agendas, and databases.
- 16.3. NESA Center government personnel will provide such assistance and information as is appropriate and necessary for liaison functions, and for the contractor's performance of the contract, e.g. review of schedules, preview of materials, orientation briefings, and walk-through of spaces.
- 16.4. Parking space will be available consistent with the policies and procedures that pertain to Government employees.
- 17. Quality Control

- 17.1. Quality Control Plan. The contractor shall establish and maintain a complete Quality Control Plan to ensure that the requirements of the contract are provided as specified. One copy of the contractor's Quality Control Plan shall be provided to the contracting officer at the time of proposal submission. An updated copy must be provided to the Contracting Officer as changes occur. The Quality Control Plan shall describe the methods for identifying and preventing problems before the level of performance becomes unacceptable.
- 17.2. Quality Assurance. The government will evaluate the contractor's performance under this contract using the method of surveillance specified in the PWS and based on adherence to guidelines established in Deliverables. When an observation indicates defective performance, the COR will obtain the contractor's representative's initials on the record of the observation. The COR will then submit a Contract Discrepancy Report.
- 18. Contractor Furnished Items and Services

Except for those items or services specifically stated to be Government furnished in paragraph 16, the contractor shall furnish everything required to perform this contract.

19. Invoices:

Monthly invoices will be allowed and will be paid within 30 days of receipt. Invoices will be submitted to the COR for approval and certification prior to submitting to the corresponding DFAS office. The COR is responsible for submitting a DD250 to certify the invoices.

A copy of the final paid invoice should be forwarded to the Issuing Office's address in Block 6 and the COR as designed in the Performance Work Statement (PWS).



If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. Records relating to appeals under the disputes clause or to litigation or the settlement of claims arising under or relating to this contract shall be made available until such appeals, litigation, or claims are finally resolved.
- (3) As used in this clause, records include books, documents, accounting procedures and practices, and other data, regardless of type and regardless of form. This does not require the Contractor to create or maintain any record that the Contractor does not maintain in the ordinary course of business or pursuant to a provision of law.

- (a) Minimum order. When the Government requires supplies or services covered by this contract in an amount of less than \$100.00, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.
- (b) Maximum order. The Contractor is not obligated to honor:
- (1) Any order for a single item in excess of \$500,000.00;

- (e) If the Government urgently requires delivery of any quantity of an item before the earliest date that delivery may be specified under this contract, and if the Contractor will not accept an order providing for the accelerated delivery, the Government may acquire the urgently required goods or services from another source.
- (f) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after August 1, 2011.

52.217-8 OPTION TO EXTEND SERVICES (NOV 1999)

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 30 days.

No legal liability on the part of the Government for any payment may arise for performance under this contract beyond 30 September 2006, until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.
