The DARPA Contracts Management Office has received a valid and properly funded requirement (ARPA Order T465/00) for a research effort in support of DARPA/IPTO's Learning Applied to Ground Robots Program.

The proposed contractor, Net-Scale Technologies, Inc., has submitted a proposal, entitled "Energy Based Models for End-to-End Learning of Ground Vehicle Navigation," in response to DARPA/IPTO's Broad Agency Announcement No. 04-25 to provide the required support.

Whereas the Contracting Officer has determined that incurrence of costs prior to the effective date of the contract is necessary to ensure compliance with the proposed contract delivery schedule, the Government and the Contractor, pursuant to the requirements of FAR 31.109 and 10 USC 2326, agree as follows:

THIRD AND LAST: It is the intention of the Government to award subject contract to the proposed Contractor subject to final agreement as to contractual terms, specifications and price, and to incorporate this agreement therein. It is understood and agreed by both parties that this agreement deals with the treatment of precontract costs in the event of contract award.
