Material components, parts, subassemblies, and semifabricated materials, which are of commercial design, will be specified in metric units only when economically available and technically adequate or when it is otherwise specifically determined to be in the best interest of the Department of Defense. Bulk materials will be specified and accepted in metric units when it is expedient or economical to do so.
- (f) Technical reports, studies, and position papers (except those pertaining to items dimensioned in U.S. customary units) will include metric units of measurement in addition to or in lieu of U.S. customary units. With respect to existing contracts, this requirement applies only if such documentation can be obtained without an increase in contract costs.
- (g) Use of the dual dimensions (i.e., both metric and U.S. customary dimensions) on drawings will be avoided unless it is determined in specific instances that such usage will be beneficial. However, the use of tables on the document to translate dimensions from one system of measurement to the other is acceptable.

H-10 Ontion for Additional Line Items

The options for CLINs 0003 through 0010 may be exercised at any time before expiration of the contract provided written notice is furnished to the Contractor of the Government's intention to exercise the options at least 30 days in advance.

H-11 Information Technology (IT) Resources

- (a) Performance of this contract will require use of IT resources including hardware and computing services, as detailed in the Contractor's proposal referenced in Article C-1. Acquisition of these resources (or equivalents) is hereby authorized for the base contract period and each option, when exercised.
- (b) The costs incurred by the Contractor in acquiring the IT resources listed in paragraph (a) above shall be considered allowable costs under the contract provided that the total net amount of the IT resources does not exceed \$1,996,688 (base + options). The Contractor shall have no obligation to acquire IT resources and the Government shall have no obligation to reimburse any amount for IT resources in excess of the amount set forth above unless the contract is amended to increase this amount.
- (c) The IT resources listed above shall be considered. Government Property and shall be subject to the provisions of FAR 52.245-05, incorporated by reference in Section 1.
- (d) The Contractor shall not use Contractor acquired property listed above for work other than that performed pursuant to this contract unless so authorized in writing by the Contracting Officer.

(e) This authorization is subject to the Contractor's compliance with the approvals and screening requirements set forth in DFARS Subpart 239.73.

H-12 Incremental Funding

This contract shall be subject to incremental funding with \$8,679,000 presently made available for performance under this contract. It is estimated that the funds presently available are sufficient to permit the Contractor's performance through May 31, 2006. Except in accordance with the Section I clause FAR 52.232-22, "Limitation of Funds," no legal liability on the part of the Government for payment of any money in excess of \$8,679,000 shall arise unless and until additional funds are made available by the Contracting Officer through an amendment to this contract.

H-13 Precontract Costs

The extent of allowability of costs incurred by the Contractor prior to the effective date of the contract shall be governed by the advance agreement listed in Section J as Attachment 1.

H-14 Subcontracting Plan

The Contractor's Subcontracting Plan Goals for Proposal No. ECU 05-011 rev. 2, dated August 23, 2005, prepared in accordance with its most recent Master Subcontracting Plan approved by DCMA Northern California, are incorporated herein by reference and made a part of this contract.

H-15 Intellectual Property Rights

All technical data, computer software and other items, components, processes (and rights therein) to be delivered under this contract shall be provided to the Government with unlimited rights.

H-16 Human Subjects

Contract funds may NOT be used for research involving human subjects that is covered by 32 CFR part 219.

H-17 Title to Equipment: Nonprofit.

In accordance with FAR 35.014, "Government Property and Title," title to equipment purchased with funds available for research and having an acquisition cost of \$5,000 or more shall vest in the Contractor.

- (c) The Contractor shall include the substance of this clause in all subcontracts under this contract that meet the applicability requirement of FAR 15.408(k).

FAR 52.222-39 Notification of Employee Rights Concerning Payment of Union Dues or Fees (DEC 2004)

(a) Definition. As used in this clause-

"United States" means the 50 States, the District of Columbia, Puerto Rico, the Northern Mariana Islands, American Samoa, Guarn, the U.S. Virgin Islands, and Wake Island.

Under certain conditions, the law permits a union and an employer to enter into a union-security agreement requiring employees to pay uniform periodic dues and initiation fees. However, employees who are not union members can object to the use of their payments for certain purposes and can only be required to pay their share of union costs relating to collective bargaining, contract administration, and grievance adjustment.

If you do not want to pay that portion of dues or fees used to support activities not related to collective bargaining, contract administration, or grievance adjustment, you are entitled to an appropriate reduction in your payment. If you believe that you have been required to pay dues or fees used in part to support activities not related to collective bargaining, contract administration, or grievance adjustment, you may be entitled to a refund and to an appropriate reduction in future payments.

- (c) The Contractor shall comply with all provisions of Executive Order 13201 of February 17, 2001, and related implementing regulations at 29 CFR part 470, and orders of the Secretary of Labor.
- (d) In the event that the Contractor does not comply with any of the requirements set forth in paragraphs (b), (c), or (g), the Secretary may direct that this contract be cancelled, terminated, or suspended in whole or in part, and declare the Contractor ineligible for further Government contracts in accordance with procedures at 29 CFR part 470, Subpart B-Compliance Evaluations, Complaint Investigations and Enforcement Procedures. Such other sanctions or remedies may be imposed as are provided by 29 CFR part 470, which implements Executive Order 13201, or as are otherwise provided by law.
- (c) The requirement to post the employee notice in paragraph (b) does not apply to-
 - (1) Contractors and subcontractors that employ fewer than 15 persons;
 - (2) Contractor establishments or construction work sites where no union has been formally recognized by the Contractor or certified as the exclusive bargaining representative of the Contractor's employees;
 - (3) Contractor establishments or construction work sites located in a jurisdiction named in the definition of the United States in which the law of that jurisdiction forbids enforcement of union-security agreements;
 - (4) Contractor facilities where upon the written request of the Contractor, the Department of Labor Deputy Assistant Secretary for Labor-Management Programs has waived the posting requirements with respect to any of the Contractor's facilities if the Deputy Assistant Secretary finds that the Contractor has demonstrated that-
 - (i) The facility is in all respects separate and distinct from activities of the Contractor related to the performance of a contract; and
 - (ii) Such a waiver will not interfere with or impede the effectuation of the Executive order, or
 - (5) Work outside the United States that does not involve the recruitment or employment of workers within the United States.
- (f) The Department of Labor publishes the official employee notice in two variations; one for contractors covered by the Railway Labor Act and a second for all other contractors. The Contractor shall-
 - (1) Obtain the required employee notice poster from the Division of Interpretations and Standards, Office of Labor-Managem ent Standards, U.S. Department of Labor, 200 Constitution Avenue, NW, Room N-5605, Washington, DC 20210, or from any field office of the Department's Office of Labor-Managem ent Standards or Office of Federal Contract Compliance Programs;
 - (2) Download a copy of the poster from the Office of Labor-Managem ent Standards website at http://www.alms.dol.egu; or
 - (3) Reproduce and use exact duplicate copies of the Department of Labor's official poster.
- (g) The Contractor shall include the substance of this clause in every subcontract or purchase order that exceeds the simplified acquisition threshold, entered into in connection with this contract, unless exempted by the Department of Labor Deputy Assistant Secretary for Labor-Management Programs on account of special circumstances in the national interest under authority of 29 CFR 470.3©. For indefinite quantity subcontracts, the Contractor shall include the substance of this clause if the value of orders in any calendar year of the subcontract is expected to exceed the simplified acquisition threshold. Pursuant to 29 CFR part 470, Subpart B-Compliance Evaluations, Complaint Investigations and Enforcement Procedures, the Secretary of Labor may direct the Contractor to take such action in the enforcement of these regulations, including the imposition of sanctions for noncompliance with respect to any such subcontract or purchase order. If the Contractor becomes involved in litigation with a subcontractor or yendor, or is threatened with such involvement, as a

result of such direction, the Contractor may request the United States, through the Secretary of Labor, to enter into such litigation to protect the interests of the United States.

Submission of Commercial Transportation Bills to the General Services Administration for Audit (JUN 1997) (Applicable when contract or first-tier subcontract will authorize reimbursement of transportation as a direct charge to the contract or subcontract)

- (c) Any original transportation bills or other documents requested by GSA shall be forwarded promptly by the Contractor to GSA. The Contractor shall ensure that the name of the contracting agency is stamped or written on the face of the bill before sending it to GSA.
- (d) A statement prepared in duplicate by the Contractor shall accompany each shipment of transportation documents. GSA will acknowledge receipt of the shipment by signing and returning the ocpy of the statement. The statement shall show—
 - (1) The name and address of the Contractor,

- (2) The contract number including any alpha-numeric prefix identifying the contracting office;
- (3) The name and address of the contracting office;
- (4) The total number of bills submitted with the statement; and
- (5) A listing of the respective amounts paid or, in lieu of such listing, an adding machine tape of the amounts paid showing the Contractor's voucher or check numbers.

ADVANCE AGREEMENT TO AUTHORIZE INCURRENCE OF PRECONTRACT COSTS

The DARPA Contracts Management Office has received a valid and properly funded requirement (ARPA Order V003) for a research effort in support of DARPA/IPTO's Global Autonomous Language Exploitation (GALE) Program.

The proposed contractor, SRI International, has submitted Proposal No. ECU 05-011 rev. 1, entitled "NIGHTINGALE: Novel Information Gathering and Harvesting Techniques for INtelligence in Global Autonomous Language Environments," in response to DARPA/IPTO's Broad Agency Announcement No. 05-28 to provide the required support.

Since the Contracting Officer has determined that incurrence of costs prior to the effective date of the contract is necessary to ensure compliance with the proposed contract delivery schedule, the Government and the Contractor, pursuant to the requirements of FAR 31.109 and 10 USC 2326, agree as follows:

FIRST: In the event that a contract is awarded, precontract costs, not to exceed \$2,339,500, shall be an allowable expense, provided that the individual costs therein shall be --

- (a) otherwise allowable, reasonable and allocable,
- (b) incurred no sooner than 1 SEP 2005, or after 30 NOV 2005, and
- (c) incurred specifically to accomplish work described in Year 1 of the proposal referenced above, including travel, converting source language from acoustic (spoken) into symbolic (written) form, augmenting language data with structural and meta-information, and converting non-English data to English while potentially preserving relevant source-language attributes and annotations. The Contractor may also begin performing analysis and interpretation of data over longer time spans and multiple sources and selecting salient information and generating relevant responses to user queries.
 - SECOND: Contractual terms, specifications and price shall be agreed to by the earlier of --
- (a) the end of the 180-day period beginning on the date on which the Contractor submits a qualifying proposal to definitize the contractual terms, specifications and price; or
- (b) the date on which the amount of funds obligated or expended under this advance agreement is equal to more than 50% of the negotiated overall ceiling price for this advance agreement.

THIRD AND LAST: It is the intention of the Government to award subject contract to the proposed Contractor subject to final agreement as to contractual terms, specifications and price, and to incorporate this agreement therein. It is understood and agreed by both parties that this agreement deals with the treatment of precontract costs in the event of contract award. This agreement does not require the Contractor to incur such costs and any costs incurred are at the risk of the proposed Contractor pending execution of a definitive contract.
