1. CURRENTLY, THE UNITED STATES ARMED FORCES ARE ENGAGED IN COMBAT OPERATIONS IN AFGHANISTAN TO DISRUPT AND DEFEAT AL QAIDA/TALIBAN FORCES AND ELIMINATE THEIR ABILITY TO CONDUCT OR SUPPORT TERRORIST ACTIVITY. THE CAMPAIGN AGAINST GLOBAL TERRORISM
