INFORMATION PAPER

SUBJECT: Future Challenges for Guantanamo Bay and Detention Operations (U)

1. Purpose: (U) To provide an overview of the Periodic Review of Guantanamo Detainees and the Future of U.S. Detention Policy

2. Periodic Review of Guantanamo Detainees:

a. (U) Executive Order (EO) 13567 (7 March 2011) directed the Department of Defense to develop periodic review procedures for detainees held at Guantanamo that would commence within one year of the order.

b. ~~(S//NF)~~ Directive Type Memorandum (DTM) 12-005 was approved by the Secretary of Defense on 9 May 2012 after significant interagency collaboration to develop the process and to include new requirements required by the FY2012 NDAA. It defines the Periodic Review Board as the "organization responsible for issuing determinations for each detainee's case." A Periodic Review Secretariat (PRS) will provide overall administrative control of the review process.

c. ~~(S//NF)~~ Each interagency partner has been tasked to provide personnel to support the Analytic Task Force, which will assemble information on each detainee for the PRB's consideration. The Director, National Intelligence, will be asked to provide analytic augmentation and access to related detainee information from the Intelligence Community.

d. ~~(S//NF)~~ OCJCS is designated as one of six voting members. The Secretary of State, Attorney General, Director, National Intelligence, and Secretary of Homeland Security have been tasked to provide a senior representative to join the Periodic Review Board as a voting member. The voting member representing the Joint Staff should be the DJ-3 or "another senior officer or expert with knowledge and experience (DTM 12-005)."

e. (U/~~FOUO~~) The PRS, an organization responsible to the Deputy Assistant Secretary of Defense for Rule of Law and Detainee Policy, is currently refining the periodic review procedures and soliciting the nomination of interagency voting members. The PRS has not announced a date for the first Periodic Review Board.

e. (U//~~FOUO~~) In a September 2011 speech, Mr John Brennan, the Assistant to the President for Homeland Security and Counterterrorism stated, "In the end, the Obama Administration's approach to detention, interrogation and trial is simple. We have established a practical, flexible, results-driven approach that maximizes our intelligence collection and preserves our ability to prosecute dangerous individuals. Anything less-particularly a rigid, inflexible approach-would be disastrous."

f. (U//~~FOUO~~) Therefore, it is unlikely a long-term law-of-war detention facility will be identified until there is a pressing operational need.
