Background: At 1428 L hrs on 08SEPT12, detainee Adnan Farhan Abd Al-Latif (M-000156DP) was found unresponsive in cell. CPR was attempted but detainee remained unresponsive. Detainee was transferred to the hospital and was pronounced dead at 1448 L hrs.
