DAD will develop an updated position description to be used by J3 Reserve Affairs to solicit replacement candidates.

~~(S//NF)~~ DRB EXCEPTION TO POLICY: DAD is coordinating CJIAF 435's request for an extension of the exception to policy that permits suspension of DRBs for detainees who are scheduled for transfer to the Government of Afghanistan. The exception would enable CJIAF 435 to continue its focus on preparing detainee files which will be transferred to the Afghan Technical Committee (ATC). CJIAF 435 requests this temporary exception until 9 March 2013. JSAP 12-04637 applies.

~~(S//NF)~~ POST 2014 DETENTION OPERATIONS REQUIREMENTS: DAD coordinated on a policy paper regarding Post 2014 Detention Operations Requirements in Afghanistan. OUSD(P) wrote the paper which outlines detention issues as we transition towards a train/advise/assist mission. JSAP J-3A 00664-12 applies.
