Within three hours of Latif's death, I participated in the first Defense Connect Online (DCO) planning session with the DHRMO team consisting of representatives from (b)(1),(b)(5),Sec. 1.4 (a) we completed our final DCO session and TRANSCOM repatriated the remains to Sana'a on Saturday.
