EXECUTIVE SUMMARY

1. This investigation was initiated on 10Aug04 after [REDACTED] USMC, [REDACTED], 1st Force Service Support Group Deployed Marines (1stFSSGDM), Camp Al Taqddum, IZ, reported [REDACTED] USMC, and [REDACTED] USMC, were posing for photographs while holding their M-16 service rifles at close proximity of [REDACTED] Civilian, on 09Aug04. [REDACTED] was an Enemy Prisoner of War (EPW) receiving medical attention at the Shock Trauma Platoon-4 (STP-4), Camp Al Qaim, IZ, for a single gunshot wound to his lower back area.

2. [REDACTED] and [REDACTED] were assigned to guard [REDACTED] while [REDACTED] was in the STP-4 area. The camera used to photograph [REDACTED] and [REDACTED] was seized by command and delivered to NCIS. Interviews of the STP-4 personnel were conducted concerning the incident. [REDACTED] and [REDACTED] were searched and evidence was collected. [REDACTED] and [REDACTED] both provided signed sworn statements admitting they took the photographs in question. Attempts to locate [REDACTED] were unsuccessful due to operational obstacles in the Operation Iraqi Freedom II combat theater.

NARRATIVE

NARRATIVE

1. This investigation is being conducted pursuant a suspected violation of Article 92 (Disobeying a lawful order) and Article 128 (Assault) of the Uniform Code of Military Justice.

2. This investigation was initiated on 10Aug04, after [REDACTED] reported [REDACTED] and [REDACTED] were posing for photographs while holding their M-16 service rifles at close proximity of [REDACTED] on 09Aug04. [REDACTED] was an Enemy Prisoner of War (EPW) receiving medical attention at the Shock Trauma Platoon 4 (STP-4), Camp Al-Qaim, IZ, for a single gunshot wound to his lower back area. [REDACTED] and [REDACTED] were assigned duties to guard [REDACTED] while he was at the STP-4 area.

3. On 12Aug04, [REDACTED] USN, was interviewed and provided a sworn statement. [REDACTED] related [REDACTED] USN, came to him on 09Aug04, and informed him she thought some of the Marines were photographing a detainee patient. [REDACTED] went to the tent and saw [REDACTED] and [REDACTED] in the tent as the guards over [REDACTED] related he was talking to [REDACTED] when [REDACTED] looked down at a medical supply can. [REDACTED] related he looked down as well and saw the camera and he took it into custody. He then verbally counseled everyone in the tent. After he left the tent he reviewed the images and discovered three images of [REDACTED] and one image of [REDACTED] pointing their weapons towards [REDACTED] Exhibit (1) pertains.

4. On 12Aug04, [REDACTED] was interviewed and provided a sworn statement. [REDACTED] related she saw a flash of light coming from the medical recovery tent. [REDACTED] related she believed the flash was from a camera. She related she went inside of the tent and asked if everything was okay. The personnel in the tent answered in the affirmative. She then went out of the tent and stood near the entrance. [REDACTED] then observed more flashes at which time she informed [REDACTED] of her suspicions. Exhibit (2) pertains.

5. On 13Aug04, [REDACTED] USN, was interviewed and provided a sworn statement. [REDACTED] related on 09Aug04, during the treatment of [REDACTED], [REDACTED] observed [REDACTED] place the butt of his rifle in his shoulder. [REDACTED] asked [REDACTED] what he was doing and then he saw a flash of light he believed was from a camera. [REDACTED] related [REDACTED] came into the tent and took the camera from [REDACTED] Exhibit (3) pertains.

6. On 13Aug04, [REDACTED] USN, was interviewed and provided a sworn statement. [REDACTED] related on 09Aug04, while checking the vital signs of [REDACTED], [REDACTED] exposed a photograph of [REDACTED] related he saw a flash of light and saw [REDACTED] putting a camera down. Then he saw [REDACTED] with his rifle

7. On 12Aug04, [REDACTED] USN, was interviewed. A sworn statement was not obtained due to operational commitments of [REDACTED]. [REDACTED] related a policy was in place at Camp Al-QAIM not allowing the photographing of EPWs. [REDACTED] related [REDACTED] was verbally counseled on this matter and also present during a formation when [REDACTED] again reinforced the "no photography" policy. Exhibit (5) pertains.

8. On 13Aug04, [REDACTED] USMC, was interviewed. A sworn statement was not obtained due to operational commitments of [REDACTED]. [REDACTED] related on 09Aug04, [REDACTED] and [REDACTED] were assigned to guard [REDACTED]. [REDACTED] related he knew there to be a policy of no-photographs of EPWs. [REDACTED] also related he had provided training to the Marines concerning keeping a weapon pointed at an EPW at all times. Exhibit (6) pertains.

9. On 12Aug04 and 13Aug04, sketches of the scene on 09Aug04, were obtained from [REDACTED] and [REDACTED]. Exhibit (7) pertains.

10. On 12Aug04, the camera [REDACTED] took from [REDACTED] was seized as evidence. At the request of [REDACTED] USMC, Senior Trial Counsel, Camp Al Taqaddum, the camera was not sent to NCISFO Bahrain Evidence Repository immediately. On 17Aug04, [REDACTED] granted permission for the search of the camera. During the search, three images of [REDACTED] and one image of [REDACTED] were discovered. The images depict both [REDACTED] and [REDACTED] aiming weapons at [REDACTED]. On 31Aug04, the camera was forwarded to the NCISFO Bahrain Evidence Repository via Registered Mail number RA 044 140 505 US. Exhibit (8) pertains.

11. On 17Aug04, [REDACTED] was requested to grant permission for a search of his person and property; however, [REDACTED] declined to grant permission. On 17Aug04, [REDACTED] was served with a Command Authorization for Search and Seizure. He and his property were searched. During the search twelve videocassette tapes were seized along with a video camera. The videocassette tapes were reviewed and no material of evidentiary value was discovered pertaining to this investigation. The video camera and tapes were returned to the command. Exhibit (9) pertains.

12. On 17Aug04, [REDACTED] granted permission to conduct a search of his person and property. During the search a memory stick, digital camera, and digital camera memory sticks were discovered and reviewed. Nothing of evidentiary value was discovered on these items and they were returned to [REDACTED]. During the interrogation of [REDACTED] he related he also owned a computer hard drive. The hard drive was seized as evidence. At the request of [REDACTED] the hard drive was not immediately sent to the NCISFO Bahrain Evidence Repository. During the review of the hard drive a photographic image of [REDACTED] pointing a pistol at an unidentified EPW was

discovered. Also on the hard drive was a video clip of the movement of EPWs in military trucks. While [REDACTED] was filming the movement, an individual [REDACTED] identified as [REDACTED] USMC, (NFI), told [REDACTED] he should probably not be filming the EPWs, but since he got away with it, [REDACTED] wanted a copy of the video. Exhibit (10) pertains.

13. On 17Aug04, [REDACTED] was interrogated and admitted to posing for a photograph while pointing his weapon at [REDACTED]. He also admitted to photographing [REDACTED] while he pointed his weapon at [REDACTED]. [REDACTED] related he did not know about the policy prohibiting the photographing of EPWs. [REDACTED] related he posed for a different photograph while pointing a weapon at an EPW. He also related pointing a weapon at an EPW was in compliance with training provided by [REDACTED]. [REDACTED] did not realize photographing EPWs was a problem, especially since [REDACTED] requested a copy of the video he had taken of the transporting of EPWs. Exhibits (11) and (12) pertain.

14. On 17Aug04, [REDACTED] was interrogated and admitted to posing for photographs while pointing his weapon and making hand gestures at [REDACTED]. [REDACTED] related he was aware of the policy prohibiting the photographing of EPWs. [REDACTED] related [REDACTED] provided training pertaining to the aiming of keeping a weapon aimed at EPWs. Exhibits (13) and (14) pertain.

15. On 07Sep04, [REDACTED] USMC, Sergeant Major, CSSG-15, was apprised of the results of this investigation. This investigation is pending the administrative/judicial action against [REDACTED] and [REDACTED].

STATEMENT

[redacted] make the following free and voluntary statement to Special Agent [redacted] whom I know to be a Representative of the United States Naval Criminal Investigative Service. I make this statement of my own free will and without any threats made to me or promises extended. I fully understand that this statement is given concerning my knowledge of suspected detainee abuse. [redacted]

For identification purposes, I am a [redacted] male standing about [redacted] inches tall and weighing about [redacted] pounds. I have [redacted] hair and [redacted] eyes. I was born on [redacted], in [redacted] and my social security number is [redacted]. I am assigned to Naval Medical Center Balboa, San Diego, CA, but I am currently attached to 1st Medical Battalion, 1st Force Service Support Group, Camp Al-Qaim, Iraq. [redacted]

My knowledge of this incident began around the second week of Jul04, here at Camp Al-Qaim. On that occasion, we were receiving an Iraqi citizen who was disembarking a UH-60 (Blackhawk) helicopter on a medical litter sometime around dusk to early evening. While receiving that patient, I observed [redacted] USMC, with a camera in his hand. It appeared as though he was going to take a picture of the patient as he was preparing his camera at the time. I'm not too sure but I believe [redacted] duty was to be a litter-bearer and assist with taking the patient from the helicopter. As the patient was being search is when I observed [redacted] actions. I approached [redacted] and instructed him to put the camera away and explained to him that it was not appropriate to take pictures of the detainee patients. I believed the situation to have been taken care of and didn't think anything else of the matter. [redacted]

About a week later at night, I was in the treatment tent and observed [redacted] with a video camera filming some of the detainee patients we had at the time. I approached [redacted] and began to verbally counsel him for his videotaping and that he should not, again, take any pictures of the detainees. I instructed him to erase the images that he had just taped and I stood there while watching him erase it. He did this by recording over the images while he aimed the camera at the walls and floors of the tent. As I counseled [redacted] I had [redacted] USMC, standing there with me. I informed the two that the next time this occurred it would result in a "charge-sheet". The next day, we had our normal formation and I took the opportunity to remind everyone that there is not to be any photo taking of the detainee patients for any reason. In the past, we have been informed that we could take photographs of the U.S. military patients who wish to have photographic documentation of their injuries and we could photograph patients to assist with identification of those who had none. I didn't want there to be any confusion and I made sure to inform the personnel that there is not to be any photograph taking of any detainee. Due to different duty assignments, I cannot say for sure that [redacted], USMC, was in the formation or not, but I made sure [redacted] was in the formation. I know he was because I specifically remember him breaking eye contact and looking towards the deck as I looked at him during my lecture. [redacted]

[REDACTED] know that [REDACTED] USN, who is our [REDACTED], was aware of this because he observed me counseling [REDACTED] about the video camera the night before and we discussed the information to be passed before the formation began. [REDACTED] supported me with this matter because we know the seriousness of these circumstances. [REDACTED]

Around 2130-2200, 09Aug04, we received an Iraqi citizen patient who I do not know the identity because we rarely have the identification of the Iraqi patients. He had a lower back injury that was suspected to be shrapnel but turned out to be a bullet wound. During treatment, [REDACTED] has the duty of being the primary guard. Once they are recovering, we move into a "watch bill". We wanted to give security a real high priority because we understood that particular patient as being injured by counter-battery fire due to him allegedly firing mortars in a local surrounding area. It was determined a couple of days later that he was actually shot by somebody. [REDACTED]

During his recovery, [REDACTED] and [REDACTED] were assigned the guard duties for that patient. Sometime within a few minutes after 2300, 09Aug04, I was at my desk when one of our doctors, [REDACTED] USN, approached me and whispered to me something to the effect of, "I think some of your Marines are taking pictures in the other tent". I immediately got up and walked over to the tent at which time I observed a flash of light, that appeared to be a camera flash, shine through the small openings of the tent. I immediately entered the tent and approached [REDACTED]. I approached him because of the consistent problems I've had with him and cameras. I began to counsel him. He immediately looked down towards a medical supply (AMMAL) can and I looked in the same direction. I observed a camera in the AMMAL, which was on. As soon as [REDACTED] noticed that I seen the camera, he reached down and picked it up. At that time, I seized the camera from him. Although I did not asked his permission, I believed he would have deleted any pictures he had taken if he had the chance. I believed that due to his past track record of taking pictures and my informing him that he was going to get a "charge sheet" the next time he took pictures of a detainee. I knew that if there were any incriminating pictures on the camera, I had to protect them so he could not delete them. Although I was standing in front of [REDACTED] I began to look around the room and made eye contact with the others present to include them with the counseling. Also present was [REDACTED] JSN, and [REDACTED] USN. I then exited the tent with the camera. At one point in time, I remember [REDACTED] entering the tent but I do not recall if he entered at the time I did or, the time I was counseling the group. [REDACTED] b7c

After exiting the tent, I stood there for a moment to calm down and then went to my [REDACTED] to inform him that we need to do a charge sheet. I instructed him to go get witness statement from [REDACTED] and [REDACTED], which were to be used against [REDACTED]. I did not view any of the images on the camera that night. I gained familiarity with [REDACTED] camera the next morning and was able to review the recorded images. There were four images on the camera from inside the tent from the previous night. One of them had [REDACTED] holding his M-16 service rifle from his hip and aimed in the direction of the detainee patient. In that image, [REDACTED] was holding his other hand up and had his fingers configured to where he was giving "the bird" gesture. The other two images were similar in that [REDACTED] was standing next to the detainee patient again gesturing "the bird". The fourth image was with [REDACTED] standing next to the detainee patient with his M-16 service rifle aimed at his head with the flash suppresser about 3 feet away from his head. Also, in the images was [REDACTED]

on August 12, 2004

[REDACTED] who appeared to be applying gauze bandages to the patient. Per his word, the other corpsman, [REDACTED] was out of view of the camera but administering care and focused on other areas of medical treatment. [REDACTED]

After viewing the images, I realized that the situation was much bigger and that [REDACTED] would, also, be included in the "charge sheet". Initially, I was going to request charges for dereliction of duty and disobeying an order but it has, obviously, grown much larger. [REDACTED]

I do not recall if the patient was awake while I was in the tent and the images on the camera were too small for me to notice his eyes but his face is plainly on the images. I did not download any images from the camera and maintained it in my custody until I released it to [REDACTED] USMC, CSSG-15, who escorted [REDACTED] and [REDACTED] back to Camp Al-Taqaddum, IZ. I maintained a chain of custody and had [REDACTED] sign for the camera on 11 Aug 04. While in my custody, the camera was in my cargo pocket unless I was in my living quarters, which has no identify markings. While in my living quarters, I was there, as well, and it was locked in my wall locker. [REDACTED]

Because of the pending questioning both Marines were advised of their rights in writing at approximately 4:20 on 10 Aug 04.
I do not know if the detainee patient was aware of the photographs being taken but I do know that he had strong doses of morphine as a result of his injuries. To the best of my knowledge, the patient was transferred out that night as a mater of routine. [REDACTED] **67**

My direct knowledge of [REDACTED] and [REDACTED] posing in pictures while aiming their weapons at detainee patients comes from some events that took place during the evening of 09Aug04. Sometime around 2200, on 09Aug04, we received an Iraqi Enemy Prisoner of War (EPW) with a wound to his right flank meaning his right lower back area. I was not involved in his actual treatment but I did observe while doing the documentation for his treatment. Later that night around midnight, I was walking by the treatment tent where he was recovering. I noticed a bright flash shining from around the cracks of the tent zipper door. I stepped inside for a moment and saw [REDACTED] placing his rifle over his shoulder, like he was putting it to "sling arms". As the detainee was laying on a litter in the center of the room with his head towards the door and his feet away from the door, [REDACTED] and [REDACTED] was to the left of the detainee. Also, [REDACTED] and [REDACTED] were in the tent as well. They were standing to the right of the detainee near his feet. I believe they were doing treatment care to the detainee. I remember asking aloud if everything was "OK" and the group generally nodded in the affirmative and, I think, [REDACTED] said, "Yes". I stepped back outside of the tent and zipped the door shut. I waited a couple of seconds and saw about three to four more flashes of light. I believe all the flashes I saw were from a camera but I did not see a camera for the brief moments I was in the tent's door opening. [REDACTED] b7c

After seeing the flashes, I immediately went to the tent next door and found our [REDACTED] and told him, "I think our Marines are taking pictures of the EPW". [REDACTED] immediately got up and went to the treatment tent. I then went and sat down at a lounge area just outside of the treatment tent, which was about fifteen to twenty feet away. I heard [REDACTED] voice yelling from inside the tent. Although I could not understand much of what he was saying, I do recall hearing him say something to the effect of, "now give me that camera". I am a Corpsman assigned to the Shock Trauma Platoon-4, Camp Al-Qaim, IZ. Around 2230, on the night of 09Aug04, I was performing duties as a litter bearer when we received a wounded Iraqi citizen. We set the litter and patient on the ground in front of the vehicle headlights so, he could be searched before we carried him into the resuscitation/treatment tent. Once we carried him into the tent, the doctors began to evaluate his injuries and determined that the patient needed to go to an Alpha Surgical Company for X-Rays and surgery. The doctors put bandages on the patient. I was assigned to stay with the patient from 2300-2400 and get him prepared for a medivac flight to Al-Asad IZ. [REDACTED] was assigned the watch after mine if the patient did not get medivac'd out by the end of my watch. [REDACTED] was supposed to be the Corpsman to fly with the patient so, he stayed to assist me with my duties. The two of us believed the medivac was going to occur soon so, we immediately began to prepare the patient. I believe [REDACTED] and [REDACTED] were assigned duties as security over the patient [REDACTED] b7c

At one point in time, I remember [REDACTED] was attempting to get the last set of vital signs for the patient the "pro-paq" had been shut down. I remember what the vital signs were so, I walked over to the [REDACTED] and provided them to him. As the patient lay on his back on the litter with his head pointing towards the main tent door and his feet towards the opposing end, [REDACTED] was standing to the right hand side of the patient's feet. I was standing to at the end of the litter at the patient's feet. I then returned to preparing the patient for the flight. Part of that preparation involved the need to use the litter straps to secure the patient to the liter. The straps on that particular litter were missing so, I decided to get a roll of gauze, called a "Kerlix roll", from a medical supply can, called a AMAL can, and use that as a strap. After getting the Kerlix roll, I returned to the patient's left hand side at about his waist area and [REDACTED] was still at the patient's right side of his feet area. [REDACTED] moved up towards the left side area of the patient's head. I do not recall where [REDACTED] was at that moment. As I began to open and use the Kerlix roll, I noticed that [REDACTED] had placed the butt of his M-16 rifle in his right shoulder. I remember saying to him, "hey, what the hell are you doing?" At that moment, a flash of light brightened the area. I believe the light was from a camera that came from the direction of my left side. Before I had a chance to do or, say anything else, [REDACTED] entered the tent and began to yell at all of us. I remember he inquired as to whom was taking pictures and [REDACTED] affirmed that he took some pictures [REDACTED]

[redacted] instructed [redacted] to give him the camera. [redacted] was the only one who had a camera at the time. [redacted] then departed the tent with the camera and told us that we were all going to get a counseling for taking pictures. He, also, wanted [redacted] to go and wait for him in the tent next door [redacted]

I do not recall any other pictures being taken that night. Just before that picture was taken, I had gone to the tent next door to ask about the timeframe of the patients departure so, [redacted] and I could know how long we had to finish getting the patient prepared for his medivac flight [redacted]

I do not know of any other circumstance wherein anyone was doing such acts as abusing patients or posing in such a way with detainee patients other than about two weeks earlier. I had asked [redacted] if I could use his external hard drive from his computer so, I could look at and save some of his pictures that he had taken since being in Iraq. I connected his hard drive to my computer and began to browse through his photographs. While doing that, I came across a photograph of [redacted] holding his weapon in his shoulder while aiming it at another detainee patient. I did not save that photograph. I do not recall if the magazine was inserted into the weapon while I was looking at that picture. On the night of 09Aug04, I do not recall if [redacted] magazine was inserted into the weapon when he aimed it at the patient. I do know they are supposed to have the magazine inserted if they were standing watch [redacted]

Sometime during the late night of 09Aug04, I was a litter bearer for an Iraqi citizen that was being brought in because he was injured. I do not remember the specific time but I do recall it being later at night. [REDACTED] and [REDACTED] were also litter bearers. I'm not sure who the fourth bearer was. We placed the patient on the ground in front of the vehicle headlights so he could be searched. I'm not exactly sure but I think [REDACTED] searched him while [REDACTED] held security over the patient while he was searched. The patient was "zip tied" with his hands in front of him. I'm not sure if he was already "zip-tied" or if we did it then. We then carried him into the resuscitation tent so he could be treated. During his medical evaluation, the doctors determined that he needed to be medivac'd out to Al-Asad, IZ, for X-Rays and surgery [REDACTED] b7c

While [REDACTED] began to prepare the patient for medivac, I went to my living area to get some things I might need for the trip because I was supposed to fly with the patient. After returning from my living area, I was in the evacuation tent while I waited for the medivac flight. [REDACTED] wanted me to get some vital signs before the patient left. About ten minutes later, I went over to the resuscitation tent with [REDACTED] to get the vital signs of the patient. Also in the resuscitation tent were [REDACTED] and [REDACTED], who were standing security guard over the patient [REDACTED]

As I walked into the tent, the patient was lying on his back and on a litter with his head towards the entrance I came in and his feet in the opposite direction. There are two entrances to the tent and it can get rather confusing as to which is the front and back doors. [REDACTED] was standing near the patient's head and [REDACTED] was down past the patient's feet. At one point in time, after I entered the tent, both [REDACTED] and [REDACTED] had moved and changed places. [REDACTED] was moving around the patient as though he was preparing him for the medivac. I walked over to a bedside stand by the patient's feet on the right side. I was attempting to get the vitals from the paperwork because the "pro-paq" had been turned off already. After asking [REDACTED] what the last vitals were he approached me and told me the patient's last vitals. [REDACTED] then went back to doing whatever he was doing at the time and I don't recall what everyone else was doing because I was focused on getting the information for [REDACTED]. I, then, noticed a flash of light coming from my right side area. I looked up and saw [REDACTED] with a camera in his hand. He then put the camera down and into the folds of his uniform blouse that was already setting on the [REDACTED]

[REDACTED] I knew that taking pictures was a really touchy subject and I didn't want anyone taking pictures at patients while I'm in the area. Before I had a chance to say anything, [REDACTED] had entered the tent just after saying, "what the fuck's going on?" and began to yell at all of us. It was at that time [REDACTED] had quickly hid the camera in his uniform blouse. [REDACTED] had gone straight to [REDACTED] and inquired if he had a camera. He continued to yell at [REDACTED] and he took the camera from [REDACTED] who had retrieved it from his uniform blouse. [REDACTED] then left the tent and informed us all that we were going to get a counseling for this and told [REDACTED] that he was going to get in trouble. I do not have any knowledge of anyone ever abusing patients or aiming their weapons in threatening manner [REDACTED]

RESULTS OF INTERVIEW OF [REDACTED] USN

1. On 10Aug04, [REDACTED] USMC, [REDACTED] 1st Force Service Support Group (1FSSG), Camp Al Taqaddum, IZ, reported [REDACTED], USMC, and [REDACTED] USMC, were aiming their weapons at and taking unauthorized photographs of a detained enemy prisoner of war (EPW), [REDACTED] civilian, while [REDACTED] was receiving medical attention at the Shock Trauma Platoon - Four, Camp Al-Qaim, IZ.

2. On 12Aug04, [REDACTED] USN, was interviewed concerning any knowledge he may have of [REDACTED] and [REDACTED] taking photographs of detained EPWs.

3. Since his arrival in Iraq, [REDACTED] has had no knowledge of any official policy regarding the taking of photographic images in his work environment. Upon his initial arrival in Iraq, a journalist has traveled through the Camp Al-Qaim area while taking photographs. [REDACTED] stopped the journalist from taking photographs. [REDACTED] could not recall the identity of the journalist. After inquiring about a photograph taking policy, [REDACTED] could not identify any policy. The day after the journalist's visit during late April of 2004, [REDACTED] briefed his new photograph policy. The policy allowed the exposing of photographic images of the general movements of medical treatment as long as the patient's identity is protected. However, the identity did not have to be protected if the patient gave their permission for the photographs.

b7c

4. [REDACTED] began to relate that photographs of detained EPWs were not permitted, but he then recanted and indicated part of the policy may not have been specific. [REDACTED] became confused about his policy and indicated photograph taking of detained EPWs was permitted for medical briefing purposes.

5. [REDACTED] recalled an occasion around mid-Jul04, when [REDACTED] was recording medical proceedings with his video camera. While [REDACTED] was approaching [REDACTED] USN, contacted [REDACTED] and began to counsel him about his video camera. The next day, [REDACTED] was present for a scheduled formation when [REDACTED] reinforced [REDACTED] photograph policy and related that photographs of detained EPWs is not allowed. [REDACTED] believed it was clear, at that time, no one was allowed to take photographs of detained EPWs.

RESULTS OF INTERVIEW OF [REDACTED] USMC

1. On 10Aug04, [REDACTED] USMC, [REDACTED], 1st Force Service Support Group (1FSSG), Camp Al-Taqaddum, IZ, reported that [REDACTED], USMC, and [REDACTED], USMC, were aiming their weapons at and taking unauthorized photographs of a detained enemy prisoner of war (EPW), [REDACTED], civilian, while [REDACTED] was receiving medical attention at the Shock Trauma Platoon - Four, Camp Al-Qaim, IZ.

2. On 13Aug04, [REDACTED] USMC, was interviewed concerning any knowledge he may have of [REDACTED] and [REDACTED] taking photographs of detained EPW's. [REDACTED] is the senior Marine present for all Marines assigned to the Shock Trauma Platoon - Four, 1st MedBn, 1stFSSG, Camp Al-Qaim, IZ.

3. On 09Aug04, [REDACTED] stood security watch over a detained EPW while he was being received from a medical flight. The EPW was identified as [REDACTED]. The receiving procedures included a physical search and medical treatment. [REDACTED] held his weapon at the ready while in "weapons condition three". [REDACTED] defined "weapons condition three" as having the magazine inserted into the weapon, bolt forward on an empty chamber, ejection port closed and the weapon on safe.

4. After the detained EPW was medically evaluated and waiting for a medical evacuation flight, he posted [REDACTED] and [REDACTED] as security watch over [REDACTED]. [REDACTED] informed both Marines that [REDACTED] was "zip-tied"; meaning his hands were bound by "flexi-cuffs". [REDACTED] further reminded them of their duties as being: 1) Do not fall asleep; 2) Watch the detained EPW; 3) Maintain weapons in "weapons condition three;" 4) Notify the duty watch if something was to happen. [REDACTED] did not review any details involving photographs because the policy was clear and commonly known as everyone was briefed. [REDACTED] understood the policy to be that no photographs were to be exposed of any detained EPW.

5. [REDACTED] did not have any knowledge of anyone, to include [REDACTED] and [REDACTED] aiming their weapons in a negative manner towards any detained EPW prior to this investigation. [REDACTED] indicated the security team members were authorized to be ready to fire during the initial search and while standing guard. [REDACTED] related he presented a class to the Marines and taught them to maintain a weapon pointed at any EPW at all times.

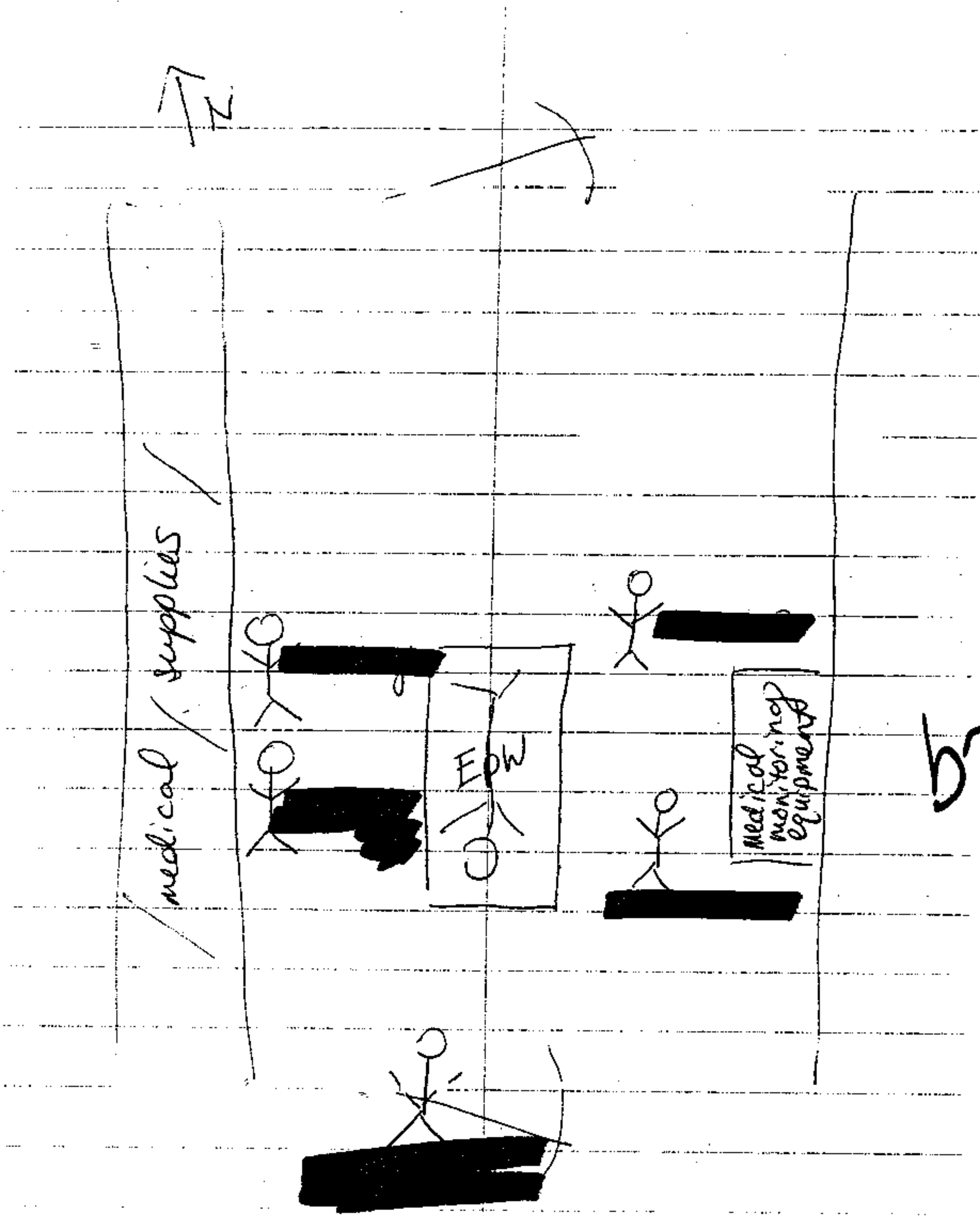

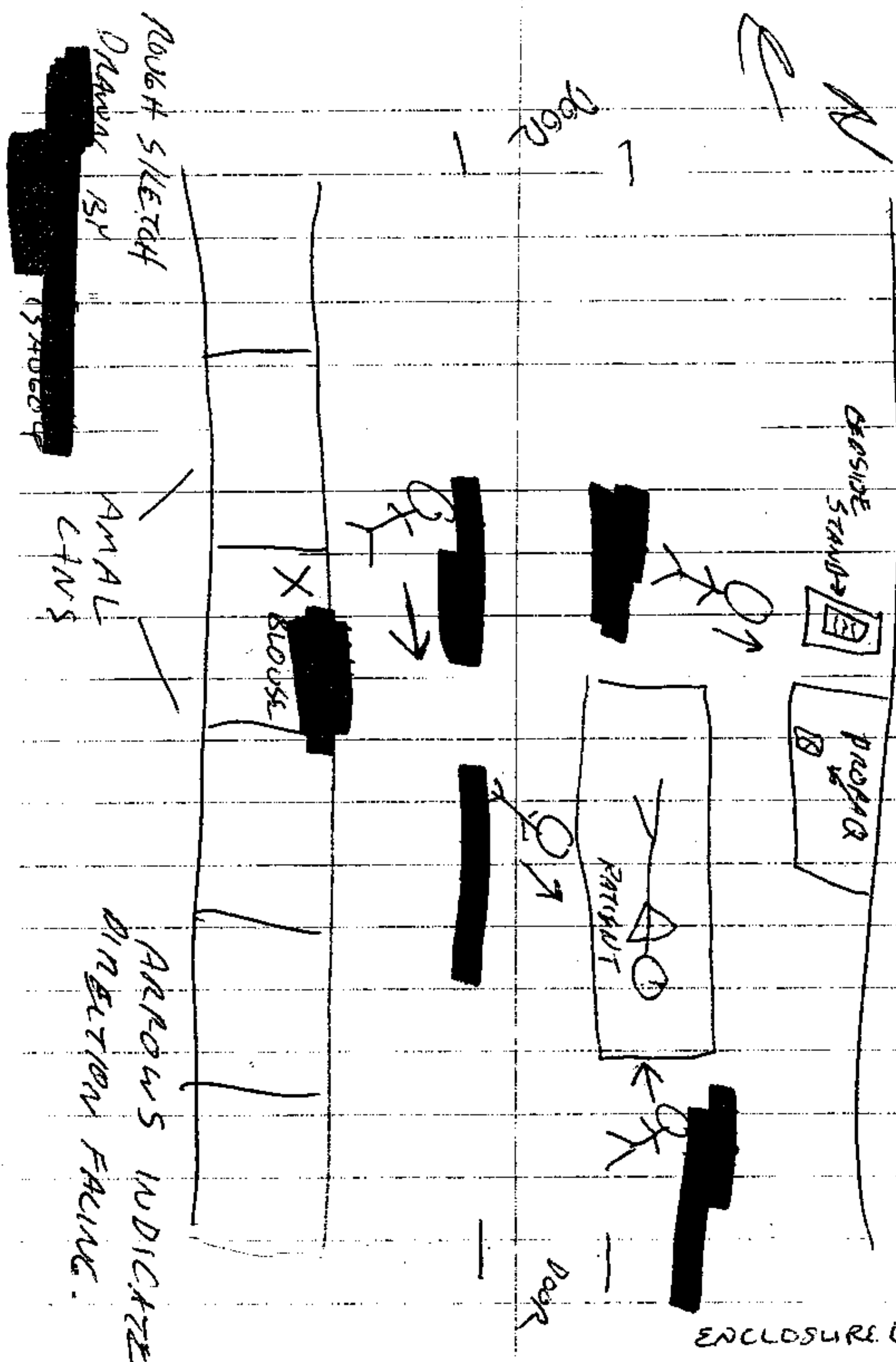

I, [redacted], make the following free and voluntary statement to Special Agent [redacted] whom I know to be a Representative of the United States Naval Criminal Investigative Service. I make this statement of my own free will and without any threats made to me or promises extended. I fully understand that this statement is given concerning my knowledge of suspected detainee abuse.

For identification purposes, I am a [redacted] male standing about [redacted] inches tall and weighing about [redacted] pounds. I have [redacted] hair and [redacted] eyes. I was born on [redacted] in [redacted] and my social security number is [redacted]. I am currently assigned to 1st Medical Battalion, 1st Force Service Support Group, Camp Al-Taqaddum, IZ, where I have been assigned duties with the Shock Trauma Platoon-4 since my arrival at Camp Al-Qaim, IZ, on 05Mar04.

Since my arrival in Iraq, I've posed for two photographs wherein I have a weapon drawn. The first time I have ever done this was sometime around Jun04. We had received four wounded Marines and an Enemy Prisoner of War (EPW). They were wounded from a grenade blast because an Iraqi had thrown a grenade and one of the Marines, [redacted] USMC, had jump on top of the grenade while throwing his Kevlar helmet over top of the grenade. I was videotaping the Marines and one of our doctors [redacted] had come up to me and said something to the effect of, "hey, cut the video... he's dying". After hearing that, I stopped taping. [redacted] was not upset at me for taping but rather upset that the Marine was dying. I believe anyone should be able to hear [redacted] on my video because I was still taping at the time he told me that. That recording, along with other photographs of Marines posing with their weapons, should be stored on my external hard-drive for my computer.

About two hours before the incident I have just explained, I had posed for a photograph with one of the EPW's that had been brought in with the four Marines. In that photograph, I was standing in my desert digital uniform with my blouse removed. I was leaning on some medical supply boxes, called AMAL cans, with my left arm. I had my right wrist rested on my right hip. In my right hand, I was holding an M-9 9mm pistol that I borrowed from [redacted] USMC. I positioned myself behind the patient and he was unconscious. [redacted] was present but out of sight of the cameras view. I believe [redacted] USMC, and I were the only ones that had our picture taken on that occasion. I'm not sure, exactly, who took the picture but it was either [redacted] USMC, or [redacted] USMC.

The second time I ever posed with a weapon on an EPW was on 09Aug04. That night, we had received an EPW sometime around 2130. I was a litter bearer along with [redacted] USN, [redacted] and [redacted]. We sat the EPW down on the ground in front of a "997 Ambulance" so; we could use the headlights to search the EPW. [redacted] searched the EPW while [redacted] stood guard over him with his M-9 9mm pistol. We then carried the EPW to the resuscitation tent where the medical staff evaluated him. I remember hearing the EPW moan as we sat him down. At that moment, the group of people in the tent collectively told the EPW to, "shut up".

"the fuck up!" That group included an Iraqi interpreter [REDACTED], USN [REDACTED], USN [REDACTED], USN [REDACTED]. There was a lot more people in the tent and I can't recollect who else said that to the EPW. However, I do recall [REDACTED] USMC [REDACTED] USN [REDACTED] and other people were present but did not say anything derogatory. I was standing in the back of the tent and did not say anything. I don't recall hearing [REDACTED] saying anything either. During the examination, I heard other comments such as, "shut up" and "why the fuck did you mortar us" [REDACTED]

After the examination, I was posted as guard along with [REDACTED] I believe [REDACTED] [REDACTED] USN, and [REDACTED] was in the tent preparing the EPW for a medivac flight. After about an hour, [REDACTED] came into the tent to check the vital signs of the EPW. While doing that, he made a comment to the effect of, "did you ever hear of Guantanamo Bay, Cuba? They eat fuckers like you up. I bet you didn't hear about our anti-mortar systems". After talking to the corpsman about the vitals, he left while instructing the corpsman to get him when the helicopter was ready [REDACTED]

Before [REDACTED] came into the tent, I took three photographs of [REDACTED] posing. In the first photograph, I think [REDACTED] back was facing me and it was blurry. The second photograph was with [REDACTED] just standing next to the left side of the EPW's head with his hand raised while making a gesture with his right hand. The next day, [REDACTED] told me that he was gesturing his middle finger so that he was "shooting a bird". The third photograph should have [REDACTED] posing with his M-16 rifle somewhere on his side as he had it slung on his shoulders [REDACTED] b7c

After taking that third photograph, I changed places with [REDACTED] I moved from the EPW's far left side from his feet up to just behind the left side of his head. [REDACTED] moved from the left side of the EPW's head to the location from where I moved. I raised my M-16 rifle and placed the butt in my right shoulder. I aimed the muzzle just to the right of the EPW's head. After having my photograph taken, I lowered my rifle. Both [REDACTED] and myself had our rifles in "weapons condition 3", which means; magazine inserted, bolt forward, no round in chamber and safety on. This occasion on 09Aug04, was the first time I had ever been assigned the duty to guard an EPW. Prior to that, I was told by [REDACTED] to keep my weapon on him at all times. Unless I was walking around to the other side of the EPW to pull his blanket back on him or replace the feet "flexi-cuffs" because they were too tight, I kept my weapon on him like I was told. I would, also, lower my weapon when [REDACTED] guarded him and I took a break. [REDACTED]

I would like to say that at no time did I intend to harm or kill any of the two EPW's. I just wanted to pose in some photographs to keep as a souvenir for what I did while here in Iraq. I didn't think that anything was wrong because I have some photographs that were given to me by some Marines who were out here in the war last year. I just wanted to have something to show what I did here in Iraq. I guess I now know that those particular photographs could be perceived as being abusive. Again, I didn't mean for that to happen. I've been taking photographs since I arrived here in Iraq. Most of the photographs were by the approval of [REDACTED] and I gave him copies for his medical briefings. Usually, just about everyone has cameras and when I'm asked not to take photographs I don't. [REDACTED]

on August 17, 2004

I remember an occasion when [REDACTED] was videotaping a group of Marines. A "1stSgt" was with them and became upset that [REDACTED] was videotaping the wounded Marines. I believe I recall the 1stSgt being mad because someone was recording his Marines who were hurting. [REDACTED] began to yell at [REDACTED] and made him erase the videotape. I've been told that we were informed not to photograph EPW's. I, personally, do not recall being told that or, ever hearing that information prior to this incident. I could have been on duty at that time. After this incident, [REDACTED] and I were talking and he informed me that he was counseled for taking photographs and instructed not to do it anymore. I was upset at him and sarcastically told him, "Well, I wish you would have told me". If I had known that, I would not have taken the photographs. Although I would like to have souvenirs, I don't want to jeopardize my career for a picture.

After talking with Special Agent [REDACTED], I understand the problems that these kind actions can cause but I don't understand why [REDACTED] and I are getting in trouble. I know [REDACTED] may have violated an order if he was told not to take any more photographs but people need to understand that taking these kind of photographs are very common at the STP and it is excepted by everyone. As an example, I was taking a videotape of a couple of 7-ton trucks loaded with EPW's. I remember [REDACTED] telling me something like, "I don't think you should be taping that because they might not like it". After the convoy left, [REDACTED] USMC, told me, "Well, now that you got away with it, I would like a copy". Anyone should be able to hear the conversation on the video because the camera was still recording. About ten minutes later, I was in my living tent and [REDACTED] came up to me and gave me his thumb drive. I copied the video for him and gave it back to him.

I would like to apologize for my actions and say that I will never do anything like that again nor, will I allow myself to be put in a position for that to happen. I just wish I used a little more common sense at the time. I just got caught up in circumstances where I thought it was accepted because I didn't mean any harm. I didn't think how the EPWs would feel if they were conscious or, how the public would view those images.

I, [REDACTED] USMC [REDACTED] make the following free and voluntary statement to Special Agents [REDACTED] and [REDACTED] whom I know to be a Representative of the United States Naval Criminal Investigative Service. I make this statement of my own free will and without any threats made to me or promises extended. I fully understand that this statement is given concerning my knowledge of suspected detainee abuse. [REDACTED]

For purposes of identification, I am a [REDACTED] male, about [REDACTED] inches tall, [REDACTED] pounds, with [REDACTED] hair and [REDACTED] eyes. I was born on [REDACTED], in [REDACTED]. My social security number is [REDACTED]. I am currently assigned to Medical Battalion (MedBn), Combat Service Support Group (CSSG) 15. Prior to 11 Aug 04, I was assigned in Al Qaim, IZ, working as a radio operator, a litter bearer, and security for medical casualties. I had been at Al Qaim since early March of 2004. I was reassigned to Camp Al Taqaddum after an incident of photographing an Enemy Prisoner of War (EPW)/Detainee on 09 Aug 04. [REDACTED]

In my duties as a guard for EPWs, I have been taught to always maintain my weapon pointed at the EPW. I was taught this by [REDACTED] USMC. We are also supposed maintain our weapons in Condition 3. A Condition 3 weapon has a magazine inserted, the bolt forward on an empty chamber, ejection port cover closed, and the weapon on safe. A Condition 4 weapon has no magazine inserted, the bolt forward on an empty chamber, ejection port cover closed, and the weapon on safe. I did not receive any written or formal training on how EPWs are supposed to be handled and watched. Prior to getting to Iraq, [REDACTED] taught a class on searching an EPW. The class included muzzle awareness of the Marine covering the EPW, how to search an EPW's clothing, and how to restrain and EPW if needed. The class lasted about fifteen minutes. [REDACTED] b7c

While I was assigned at Al Qaim, I have posed for photographs while aiming a weapon at an EPW on two occasions. During July of 2004, the first occasion I posed for a photograph occurred. An EPW was in the evacuation tent at Al Qaim and I was assigned as a guard for him. I had my digital camera with me and I gave it to [REDACTED], USN, and asked him to take a picture of me guarding the EPW. My digital camera is a Olympus Stylus 300 digital camera. In the picture, I was pointing my M16 at the EPW. The butt stock of the rifle was in the area of my right shoulder. For some reason, I remember having my weapon in Condition 4 during this picture. I was standing between the EPW and the door. I was about three feet away from the EPW. I was standing at about chest level to the right of the EPW. [REDACTED] took the photograph of me. He then gave my camera back to me and I put the camera in my cargo pocket. [REDACTED] b7c I HAD JUST RELIEVED THE FOLLOWING POST

The second incident of me posing for photographs over an EPW was on 09 Aug 04. I was guarding an EPW with [REDACTED] USMC, in resuscitation tent. I had my digital camera with me. The other people in the tent were [REDACTED] and [REDACTED] USN. [REDACTED] and [REDACTED] were monitoring the EPW's vital signs. I asked [REDACTED] to take a picture of me with the EPW. He took three pictures of the EPW and me. The EPW was unconscious. I stood between the EPW and the door about three feet away from the EPW. I was at about shoulder [REDACTED]

on August 17, 2004

level with the EPW and to his right. I think in two of the photographs, the butt stock of my M16 was at my side and in the other photograph, the butt stock was in my shoulder. I was pointing my M16 at the EPW. My weapon was in Condition 3. In one of the photographs, I flipped my middle finger at the EPW. After the three pictures, [redacted] gave me back my camera. I then took on photograph of [redacted] and the EPW. [redacted] was in about the same position I was in his photograph. I do not remember where the butt stock of his M16 was located, but I know his weapon was pointed at the EPW. [redacted] also had a Condition 3 weapon. When we took the pictures, no one in the tent said anything to us. After taking the pictures, I put the camera down on top of a box. A few minutes later, [redacted], USN, asked something to the effect of "where's the camera." I pointed at my camera on the box and he grabbed my camera. [redacted] told me to go into the patient unloading tent. I did as he told me. As I was leaving the resuscitation, [redacted] also told me I was going to get charged. He said, "write him up."

When I was in the patient unloading tent, [redacted] USN, asked me for identification information. Something was printed out, but I do not know what it was. I did not sign anything on 09Aug04.

During the treatment of the EPW on 09Aug04, several individuals were making comments to the EPW. [redacted] USN, told the EPW to "shut the fuck up" when the EPW moaned. [redacted] USN, made a joke about the EPW forgetting about the anti-mortar. [redacted] USN, related he did not want to work on the EPW because the supplies should be saved for Marines. He did not say this in front of the EPW; he was in another tent. [redacted] related she wanted to know how to say "die Iraqi die" in Arabic. She said this in another tent away from the EPW.

During my time at Al Qaim, I photographed and video taped many incidents involving patients. This included EPWs. It was a common practice and many other people would use cameras and record things that were happening. Individuals I observed photographing or video-taping include [redacted] USN, a navy officer from the Battalion Aid Station (BAS). He is a very tall and thin black male. [redacted] USMC, the camp commandant has photographed an EPW. [redacted] USN, has photographed medical procedures. If I was not a litter bearer, I would video-tape the landing of the evacuation helicopters, the off loading of the patients, and their transport to the medical facility. I would video-tape the search procedures for EPW patients. I would go into the medical tent and video tape some of the procedures. The navy officer from BAS asked me to copy a tape for him. I told him I did not have the equipment to copy the tape for him. A few other individuals have asked me for copies as well, but since I do not have the proper equipment, no copies have been made. A few months ago, during one night, I was video-taping an incident going on and someone told me to stop recording the incident. I stopped my camera.

About two weeks before 09Aug04, I was video-taping the doctors working on an EPW in the resuscitation tent. [redacted] told me to stop recording the procedure. He also told me to record over what I had just recorded. I did as [redacted] instructed and recorded over the procedure on the EPW. The next morning during a formation, [redacted] told the formation there would be no more filming or photographing of EPWs. I do not know if [redacted] was present during this formation. Even after [redacted] passed this information, people from various units were still taking pictures of medical procedures.

on August 17, 2004

During July of 2004, I began having problems with [redacted] over minor things. I would do little annoying things and then be threatened with ridiculously large amounts of working parties and extra military instruction (EMI). Some of the things I got in trouble for were skateboarding in the tent and drinking a Diet Coke that was in the refrigerator. Generally, the sodas are marked with someone's name. This Diet Coke did not have a name on it. [redacted] asked me if I drank the Diet Coke and I told him I had drunk it. [redacted] threatened me with a working party and told me to get him another cold Diet Coke one way or another. I got him a Diet Coke. [redacted] had gotten a skateboard. Several of us rode the skateboard in the tent. After I rode the skateboard in the tent, [redacted] came up to me and told me if I ride the skateboard in the tent again he will give me three weeks of EMI. A few days later, I was in the tent and bored. [redacted] was using his computer. I stood on his skateboard and told him I was getting good at gaining speed while riding the skateboard. I did not go anywhere on the skateboard in the tent. I simply stood on the skateboard. About ten minutes later, [redacted] called [redacted] and I over to him. [redacted] told me I had three weeks of EMI. I tried to tell him I was only standing on the skateboard and not riding it. [redacted] told me I was dismissed. I left and [redacted] stayed and talked to him. [redacted] then came to me and asked what happened. I told him. [redacted] then went back to [redacted]. A few minutes later, [redacted] came out and told me not to worry about the EMI. As problems with [redacted] mounted, things also became more difficult with [redacted] and [redacted] are buddies. The incidents of me getting into trouble for filming things did not start until after problems developed with [redacted]. Also, it seemed as though [redacted] was disappointed [redacted] was involved in taking and posing for pictures on 09Aug04. I felt as though he wished it would have been me involved and no one else.

I believe I did not do anything wrong by pointing my weapon at the EPW. I was instructed to keep a weapon pointed at an EPW while on guard. However, I was wrong in posing for a picture while on duty because I was not paying proper attention during the photography. I also should not have made hand gestures in the picture with the EPW. At no time did I ever harm an EPW.

1. This investigation was initiated on 10Aug04 after [REDACTED], 1st Force Service Support Group Deployed Marines (1stFSSGDM), Camp Al Taqddum, IZ, reported [REDACTED] and [REDACTED] were posing for photographs while holding their M-16 service rifles at close proximity of [REDACTED] Civilian, on 09Aug04. [REDACTED] was an Enemy Prisoner of War (EPW) receiving medical attention at the Shock Trauma Platoon-4 (STP-4), Camp Al Qaim, IZ, for a single gunshot wound to his lower back area.

2. [REDACTED] and [REDACTED] were assigned to guard [REDACTED] while [REDACTED] was in the STP-4 area. The camera used to photograph [REDACTED] and [REDACTED] was seized by command and delivered to NCIS. Interviews of the STP-4 personnel were conducted concerning the incident. [REDACTED] and [REDACTED] were searched and evidence was collected. [REDACTED] and [REDACTED] both provided signed sworn statements admitting they took the photographs in question. Attempts to locate [REDACTED] were unsuccessful due to operational obstacles in the Operation Iraqi Freedom II combat theater.
