INVESTIGATIVE SUMMARY:

On 2 Aug 04, this office received Request for Information (RFI) 0367-04-CID001 from the United States Army Criminal Investigation Command, 6010 6<sup>th</sup> Street, Fort Belvoir, VA 22060 (USACIDC), which requested this office investigate allegations Mr. [REDACTED] was assaulted by a black, male soldier.

Investigation determined there was insufficient evidence to prove or disprove Mr. [REDACTED] allegations that he was abused by U.S. Forces during his interrogation. Mr. [REDACTED] alleged a black male wearing a desert combat uniform (DCU) (NFI) who interrogated him, stepped and ground his foot on a previous gunshot wound to his left thigh.

Coordination with MAJ [REDACTED] 800<sup>th</sup> Military Police Brigade, Sugar Notch United States Army Reserve Center, 140 Stewart Road, Asley, PA 18706,

revealed if Mr. [REDACTED] had been initially processed at Camp Cropper, IZ, the assigned Internment Serial Number (ISN), would be different or linked to the current ISN. A query of Mr. [REDACTED] detainee file revealed no additional ISN for Mr. [REDACTED]

Coordination with 3/505<sup>th</sup> Parachute Infantry Regiment (PIR) and 1/505<sup>th</sup> PIR revealed Iraqi detainees were never interrogated at the Forward Operating Base (FOB), but were instead sent to the Baghdad Central Confinement Facility for intelligence exploitation.

Coordination with the 313<sup>th</sup> Military Intelligence Battalion revealed only biographical questioning was conducted on detainees while they were in the custody of the 1/505<sup>th</sup> and 3/505<sup>th</sup> PIR. They stated no interrogations were conducted at the unknown facility alleged by Mr. [REDACTED]

Further investigation revealed there was insufficient evidence to prove or disprove Mr. [REDACTED] allegations as previously documented. Mr. [REDACTED] was released from confinement before the allegations were reported to USACIDC, therefore an interview by USACIDC of Mr. [REDACTED] was never conducted. Further, no medical records pertaining to Mr. [REDACTED] were located in Iraq or the detainee medical records archives in Fort Sam Houston, Texas. No witnesses or possible suspects were able to be identified as a result of poor detainee file documentation. Due to the danger in locating and interviewing Mr. [REDACTED] and other possible Iraqi witnesses, the interviews were not conducted. The investigation did not diminish the integrity or credibility of Mr. [REDACTED] allegation.

## DETAILS

**BASIS FOR INVESTIGATION:** On 2 Aug 04, this office received a Request for Investigation (RFI) 367-04-CID001 from the United States Army Criminal Investigation Command (USACIDC), 6010 6<sup>th</sup> Street, Fort Belvoir, VA 22060, which requested this office investigate allegations Mr. [REDACTED] Internment Serial Number (ISN) [REDACTED] was assaulted by a black male soldier (NFI).

About 0900, 6 Aug 04, SA [REDACTED] coordinated with Major [REDACTED], 800<sup>th</sup> Military Police Brigade, Sugar Notch United States Army Reserve Center, 140 Stewart Road, Ashley, PA 18706, who was the former Detainee Processing Officer in Charge of Camp Bucca from Apr 03 to Dec 03. MAJ [REDACTED] stated the Detainee's Internment Serial Number would directly correlate to the location where the Detainee was first input into the system and detained. MAJ [REDACTED] related the 100000 series numbers originated from Baghdad Central Confinement Facility (BCCF) and Camp Bucca, IZ. MAJ [REDACTED] stated the 200000 series numbers originated from Baghdad International Airport Internment Facility and the number 300055 had originated from the Detainee Processing Center on the USS Comfort. MAJ [REDACTED] stated the Iraqi Detainee would retain this number in the Detainee records and always be associated with it in some way even if recaptured or inprocessed at another camp.

About 0900, 26 Aug 04, SA [REDACTED] BCCF, Abu Ghraib, APO AE 09342 (AGAA), coordinated with the Magistrate Cell, BCCF, AGAA, and obtained the Detainee file and the Interrogation Reports for Mr. [REDACTED] (See Detainee File and Interrogation Reports of Mr. [REDACTED] for details.)

Agent's Note: SA [REDACTED] conducted the activity in 0247-04-CID259-80281. A review of the documentation revealed 1/505th PIR and 3/505th PIR were listed as capturing units. All interrogations and allegations of abuse came from the Interrogation Reports taken by Military Intelligence units stationed at BCCF. A search of the file did not reveal other ISN's for Mr. [REDACTED]. The Magistrate's Cell related Mr. [REDACTED] was released on 20 Apr 04 with no contact or forwarding information.

About 1300, 23 Oct 04, SA [REDACTED] coordinated with CPT [REDACTED] Office of the Staff Judge Advocate, Camp Victory, Iraq, APO AE 09342 and briefed him on the aspects of this investigation. CPT [REDACTED] opined there was insufficient evidence to prove or disprove the offenses had been committed.///Last Entry///

### DETAILS

About 1300, 27 Sep 04, this office received a Request For Assistance (RFA) from the 3<sup>rd</sup> Military Police Group (CID), 22<sup>nd</sup> Military Police Battalion (CID)(FWD), Detainee Abuse Task Force, Baghdad, Iraq APO AE 09342, to locate and interview all individuals from the 1<sup>st</sup> Battalion, 505th Parachute Infantry Regiment (PIR), 82<sup>nd</sup> Airborne Division, Fort Bragg, NC 28310 (FBNC), who might have conducted interrogations or interrogated Mr. [REDACTED] Internment Serial Number [REDACTED] at Abu Ghaib prison between 13 Oct 03 and 2 Nov 04.

About 1506, 27 Sep 04, SA [REDACTED] interviewed 1<sup>st</sup> Lt [REDACTED] Rear Detachment, Headquarters and Headquarter Company (HHC), 1/505<sup>th</sup> PIR, FBNC, who provide a sworn statement detailing his unit deployment location from Aug 03 to Apr 04. ( See sworn statement for details).

Between 1600, 29 Sep 04 to 0900, 30 Sep 04, SA [REDACTED] conducted a canvass interview of the follow individuals assigned to 1/505<sup>th</sup> (PIR) rear detachment. In summary all individuals stated that their main job was to guard detainees. They were not allowed to talk with the detainees, but made sure they had food and water.

## DETAILS

At 0920, 5 Oct 04, SA [REDACTED] coordinated with SSG [REDACTED] S-2 NCOIC, HHC 3/505<sup>th</sup> Parachute Infantry Regiment (PIR), Fort Bragg, NC 28310 (FBNC), who reflect on the S-2's duties while deployed to Iraq. SSG [REDACTED] stated that when detainees were brought to the detention facility at St. Michael, Mohaumodia, Iraq, his duties were to obtain basic information like: age, name, tribe, and if an interpreter was available, marriage status. After the basic information was obtained, SSG [REDACTED] related the detainees would then be interviewed by designated personnel from C Company 313<sup>th</sup> Military Intelligence Battalion (MI BN). When asked if the designated personnel from C Company 313<sup>th</sup> MI BN who conducted the interrogations were black, SSG [REDACTED] replied "NO." SSG [REDACTED] further related that the only other person who would be obtaining basic information from detainees would be SSG [REDACTED] S-2, HHC 3/505<sup>th</sup> PIR, FBNC.

At 1300, 5 Oct 04, SA [REDACTED] interviewed SSG [REDACTED] who reflected on his duties while he was deployed in Iraq. SSG [REDACTED] stated he deployed with D Company 313 MI BN, FBNC, where he operated as an Intelligence analyst in Ar Rimadi Iraq. In November 2003, SSG [REDACTED] stated he was transferred to HHC 3/505<sup>th</sup> PIR, which operated in FOB St. Michael, Mohaumodia, Iraq, because they needed an intelligence analyst to work in the S-2. SSG [REDACTED] related his duties were to obtain basic information from detainees like: age, name, tribe, and if an interpreter was available the marriage status. SSG [REDACTED] further related he never operated in Fallujah, Iraq.

Status: This investigation is closed in the files of this office. No further investigative activity is anticipated.

About 0930, 17 Nov 04, SA [REDACTED] interviewed 1SG [REDACTED] A Co, 1/32 Inf Bn, FDNY, who stated that the current commander had just arrived. 1SG [REDACTED] further stated he had no knowledge of any detainee abuse during his time in Iraq, and that his unit was never assigned to Abu Ghraib, IZ.

About 1400, 22 Nov 04, SA [REDACTED] interviewed CPT [REDACTED] Commander, A Co, 1/32 Inf BN, FDNY, who stated he recently assumed command from CPT [REDACTED] IRTC Operation Group, Fort Polk, LA. CPT [REDACTED] further identified MSG [REDACTED] as the first sergeant of A Co, 1/32 Inf Bn, FDNY, between Oct 03 and Apr 04, while in Iraq.

About 0620, 06 Dec 04, SA [REDACTED] coordinated with SA [REDACTED] and provided a status report on this request. SA [REDACTED] related the request could be terminated based on information from the Commander and First Sergeant.

About 1445, 10 Dec 04, SA [REDACTED] interviewed MSG [REDACTED] who stated A Co, 1/32 Inf, was investigated by 82d Airborne Division (NFI), Fort Bragg, NC, involving two white male soldiers, in Dec 03 to Jan 04. About 0900, 16 Feb 06, SA [REDACTED], this office, coordinated with Mr. [REDACTED] Legal Specialist, Central Criminal Court of Iraq, International Zone, Baghdad, Iraq, who related he did not have any medical records pertaining to Mr. [REDACTED]

About 1100, 22 Feb 06, SA [REDACTED] coordinated with SA [REDACTED], Fort Sam Houston Resident Agency, Fort Sam Houston, TX, who related they had checked the archived detainee medical records and no record pertaining Mr. [REDACTED] was located.

Agent's Comment: The original final report indicated Mr. [REDACTED] alleged he was thrown from a truck while blindfolded. A check of all documents revealed Mr. [REDACTED] did not allege he was thrown from a vehicle. The Operations Officer, 10<sup>th</sup> Military Police Battalion (CID), Camp victory, Iraq, stated this office should remove the allegation from the final.

About 1630, 22 Mar 06, SA [REDACTED] queried the Biometric Automated Tool Set (BATS) which revealed Mr. [REDACTED] brother, Mr. [REDACTED], ISN [REDACTED] (NFI), was released from Baghdad Central Confinement Facility, Abu Ghraib, Iraq, on 20 Apr 2004.

Agent's Comment: Mr. [REDACTED] stated he was assaulted during interrogation at an unknown location. His family members were not present during interrogation and would not have witnessed the abuse.
