CASE SUMMARY

1. On 13JUN03, Special Agent (SA) [REDACTED] was contacted by [REDACTED] 2nd BN 5th MARREGT 1st MARDIV, USMC, Camp Pendleton (CPC), to make a statement regarding alleged war crimes committed by one of [REDACTED] Marines, [REDACTED]. [REDACTED] was concerned because [REDACTED] was overheard bragging about stabbing dead and wounded Iraqi soldiers by retired [REDACTED] while at the Naval Medical Center in San Diego.

2. On 18JUN03, SA [REDACTED] and Reporting Agent (RA) interviewed [REDACTED] and [REDACTED] of Mental Health Services at the Naval Medical Center in San Diego. Both [REDACTED] and [REDACTED] had contact with [REDACTED] when [REDACTED] was at the hospital on the 3rd and 4th of JUN 03. Doctors [REDACTED] and [REDACTED] related several incidents that [REDACTED] had told them. [REDACTED] stated he had been meritoriously promoted to SGT and received a Purple Heart award from the Commandant of the Marine Corps. [REDACTED] related he had a ceremony and parade in his honor at his home town of [REDACTED] where a Congressman took him out to dinner. [REDACTED] reported late to the hospital one morning and stated that he had been assaulted in downtown San Diego the night before and had spent the night at the police station assisting the San Diego Police Department (SDPD).

3. On 19JUN03, RA contacted retired [REDACTED]. [REDACTED] stated that he was concerned that [REDACTED] was suffering from Post Traumatic Stress Disorder.

4. The San Diego County Automated Regional Justice Information System (ARJIS) was queried and no record of [REDACTED] being assaulted or assisting SDPD was located.

5. On 27JUN03, RA was contacted by [REDACTED]. [REDACTED] stated that [REDACTED] command had conducted a preliminary investigation regarding the [REDACTED] wound. The PI revealed that it was possible that the wound was self-inflicted. [REDACTED] was certain that [REDACTED] was not promoted and he did not receive a Purple Heart. [REDACTED] said that to his knowledge [REDACTED] never had the opportunity to return home and attend a ceremony and parade in his honor. [REDACTED] stated that he had the round that was used by [REDACTED]. [REDACTED] said that [REDACTED] command had a HUMVEE door that was apparently modified in order to aid in self inflicting a wound. [REDACTED] was referred to Marine CID to investigate the self inflicted wound. Based on the information above [REDACTED] claim of having stabbed Iraqi prisoners of war is considered

STATEMENT

Place : NCISRA Camp Pendleton California

I, [redacted] USMC, make the following free and voluntary statement to [redacted] whom I know to be a Representative of the United States Naval Criminal Investigative Service. I make this statement of my own free will and without any threats made to me or promises extended. I fully understand that this statement is given concerning my knowledge of information relative to possible Iraqi war crimes committed by a Marine assigned to his unit. [redacted]

For purposes of identification, I am a [redacted] male, born on [redacted], at [redacted]. I am [redacted] with [redacted] eyes, about [redacted] tall and weigh [redacted] pounds. I currently reside at [redacted]. I possess a secret security clearance [redacted]

I am currently the [redacted] of Headquarters and Service Company at 2nd Battalion 5th Marine Regiment, 1st Marine Division. Approximately one week ago, I received information from a courtesy call from a 1stSgt assigned duties at MCRD San Diego, CA. I cannot recall his last name at the moment, but he is a Hispanic Marine. This 1stSgt told me that he had inadvertently received info through his command that a Retired Admiral had talked with the CG at MCRD San Diego and related information regarding one of Marines by the name of [redacted]. [redacted] was apparently receiving pool therapy at the Balboa Naval Medical Center, San Diego, for a shoulder injury that he sustained while participating in the Iraqi war. This 1stSgt related that [redacted] had apparently talked about stabbing dead Iraqi soldiers and killing wounded Iraqi soldiers as well. The 1stSgt related that [redacted] had also mentioned that he had been meritoriously promoted by the Commandant of the Marine Corps from the rank of Lance Corporal to Sergeant. The 1stSgt added that the retired Admiral who overheard [redacted] bragging in the pool area, then took him to see one of the officials at Balboa Naval Medical Center to report his actions. The 1stSgt could not recall who the retired Admiral took [redacted] to see at that time. I believe [redacted] the Marine Liaison at Balboa Naval Medical Center, has a lot of information regarding the situation with [redacted]. I also believe [redacted] civilian physical therapist may have information relative to the information related by [redacted] as well. I do not know the name of [redacted] civilian physical therapist. I believe the majority of the people knowledgeable of [redacted] action will be the occupational/physical therapist at the Balboa Naval Medical Center. I personally do not believe the story [redacted] related to the individuals at Balboa Naval Medical Center. I know that [redacted] while in Iraq, was assigned to the Chaplain's vehicle, which consisted of him, [redacted] the Chaplain, [redacted] the driver and [redacted] the Religious Program Specialist or Chaplain Assistant. [redacted] actually works for [redacted], the Communications Officer for 2/5. I am not sure why [redacted] assigned [redacted] the Chaplain's vehicle as a communicator. I am not sure when [redacted] was injured in Iraq, but I know there are issues with the circumstances surrounding his injury which was a gunshot wound to his shoulder. I believe the story related by [redacted] concerning the shooting was that while everyone in his vehicle was asleep, a lone Iraqi soldier approached the vehicle and shot him as he returned fire and shot the Iraqi soldier. I believe [redacted] contends everyone in the vehicle was asleep at the time of the shooting incident; however, I believe the others related they only heard one gunshot. I am not sure if the incident is being investigated, but I do know that [redacted] has not received a purple heart, which leads me to believe there may be some issues with the shooting incident. [REDACTED] myself. I believe [REDACTED] arrived in Iraq sometime between late Feb03 and early Mar03. I was not there when the incident happened, because I myself was injured and had returned to Camp Pendleton to recover. I can say that [REDACTED] has related a number of stories to different folks over the past few months. I recall an incident where we had to send a duty driver to pick up [REDACTED] in Phoenix, AZ, because he had been kicked off the plane for complaints he had made regarding a potential head injury. The unit Commanding Officer was apprised of [REDACTED] actions and requested further investigation to determine the status of the information related by [REDACTED]. I do not have any additional information to add at this time [REDACTED]

On 18JUN03 at 1330 [REDACTED] USN, [REDACTED] and [REDACTED] Mental Health Services, Naval Medical Center San Diego were interviewed by Special Agents [REDACTED] and [REDACTED] aboard the Naval Medical Center, San Diego. Doctors [REDACTED] and [REDACTED] were advised that they were being interviewed concerning their interaction with [REDACTED] JSMC. Prior to any questions, SAs [REDACTED] and [REDACTED] identified themselves as NCIS Special Agents to [REDACTED] and [REDACTED] both verbally and by displaying their credentials.

[REDACTED] stated that on the 03 JUN 03, [REDACTED] had brought [REDACTED] to the command suite where she had her initial contact with [REDACTED]. [REDACTED] was told by [REDACTED] that in a combat situation they would take a knife and stab wounded and dead Iraqi soldiers because they felt the Iraqis posed a threat. [REDACTED] and [REDACTED] then described several other incidents that [REDACTED] had related to them. [REDACTED] allegedly stated that he had been hand picked to be the chaplain's driver in Iraq because he was the best shot. [REDACTED] allegedly described an incident where he was shooting Iraqi soldiers off a conveyor belt in a cement factory. Allegedly [REDACTED] after being shot by a lone Iraqi fired all his ammo then threw his knives at his assailant. [REDACTED] stated that he had been promoted to Sergeant and had received his Purple Hart from the Commandant of the Marine Corps. [REDACTED] related that a parade and a ceremony had been effected in his honor at his hometown of [REDACTED]. [REDACTED] also related how he had been assaulted in downtown San Diego and how he had assisted a patrolman in apprehending his assailant. b7c

On 04JUN 03 [REDACTED] spent the day with [REDACTED] and administered a 344 question psychological test. [REDACTED] was not able to finish the test because he was fatigued. [REDACTED] stated that [REDACTED] may be embellishing his time in Iraq and the time since he has returned.

On 05JUN03 [REDACTED] was transferred back to his command.

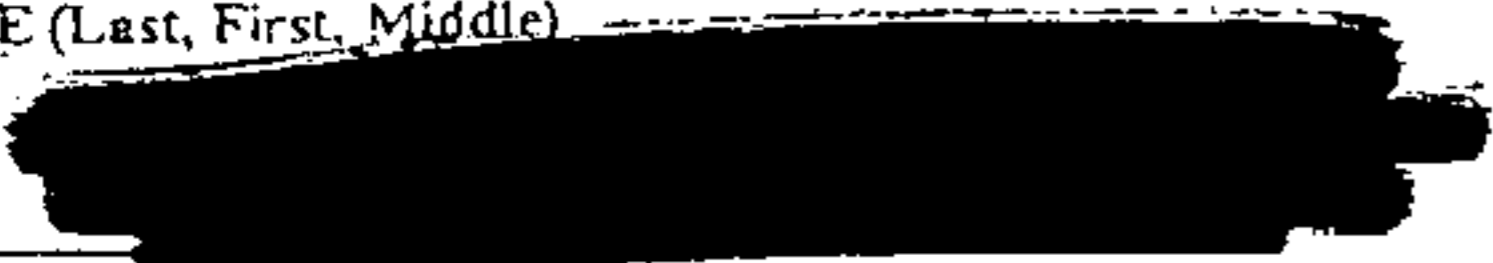
