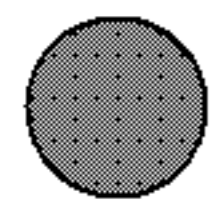

D-021 Joint /Army Doctrine Revision

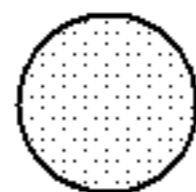
(x) RECOMMENDATION/OBSERVATION

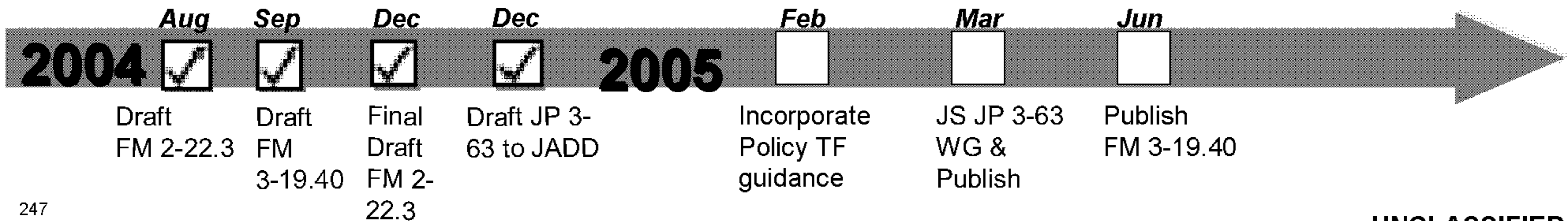
