INVESTIGATIVE ACTION: Preliminary Examination of ISN 693's Body

YEL At approximately 0410, 10Jun06, a preliminary examination of Ali Abdulla H AHMED'S body was conducted by Criminal Investigation Task Force (CITF), Guantanamo Bay, Cuba. V/AHMED, who is Internment Serial Number (ISN) 000693DP, and will be referred to as ISN 693. This examination was conducted at the Camp Delta Medical Clinic, Guantanamo Bay, Cuba. The purpose of this examination was to recover evidence and provide photographic coverage of the body. ISN 693's body was found by Joint Task Force (JTF) Camp Guards to be hanging from his cell block located Camp Delta, Camp #1, Block A5.

(FOUO/LES) ISN 693's body was lying on an orange spinal board which was situated on an examination table. His body was also covered with a blue sheet. ISN 693 is described as male, olive complexion, approximately 67" tall, with black hair and beard. A query of the joint Detainee Management Information System (JDIMS) listed his weight at 165.4 pounds on 05Jun06. ISN 693 was dressed in a Joint Task Force (JTF) issued beige two piece outfit consisting of pants and shirt. His hands were unbound with his arms resting by his side. There was some bruising noted on his right hand. ISN 693's were removed prior to examination. A clear plastic tube was noted a being in ISN 693's left nostril. ISN 693 had a white cloth tied around his waist/stomach area, and a white piece of cloth on top of his chest area.

This white cloth appeared to be part of a sleeve from a white t-shirt.

(FOUO/LES) An examination of the head/neck area noted bruising around the neck consistent with ligature marks. These suspected ligature marks extended from ISN 693's left ear area to his right ear area. These suspected ligature marks were documented via photographs.

(FOUO/LES) An examination of the left inside pocket of ISN 693's top revealed a piece of white 8½ X 11 paper, folded in quarters. This paper was photographed and subsequently removed from the inside pocket of ISN 693's top. The paper was protected for possible latent print identification and it was opened. The Arabic writing on the paper was photographed and seized as evidence. Spiritual Advisor, JTF, Guantanamo Bay, Cuba was at the Medical Clinic and provided an Arabic interpretation of the letter. This letter read, "I did not like the tube in my mouth, now go ahead now and accept the rope in my neck".

(FOUO/LES) The following items of evidence were seized and entered into the NCISRA Guantanamo Bay, Cuba Evidence Custody System under log #011-06.
