on 17 August 2002 at 1950hrs, I was distributing food to all of the detainees on (b)(2) Block. I had just finished handing the last plate of food out that (b)(3):10 USC §130b, (b)(6), (b)(7)(C) had on her tray. (b)(1), (b)(2), (b)(1) Sec 1.4 A (I (b)(3):10 USC §130b, (b)(6), (b)(7)(C) was pissed off because the block guards had put up a cover over his window and had (b)(2) because he was talking to (b)(2) Block. This was directed by the guard commander. When (b)(3):10 USC §130b, (b)(6), (b)(7)(C) handed him his MRE for dinner he refused and became more angry. As I walked out of the block towards the gate (b)(1), (b)(2), (b)(1) Sec 1.4 A (ISN 493 (b)(2), (b)(3):10 USC §130b, (b)(6)) spit in my face. I continued to walk out the gate where I was told by my block commander (b)(3):10 USC §130b, (b)(6), (b)(7)(C) to go to medical and be decontaminated. He had witnessed the incident and then called the guard commander and duty officer. (b)(3):10 USC
