At approximately 0830 hrs. (b)(3):10 USC §130b,(b)(6),(b)(7)(C) and I began to walk through the block and remove extra items from the detainees. (b)(1),(b)(2),(b)(7)(C) (693) had one extra cup in his cell. (b)(3):10 USC §130b,(b)(6),(b)(7)(C) asked the detainee to pass the cup out of the cell and drop it on the floor. The detainee refused. After telling the detainee several times to give the cup to the guard, I closed the feed tray and moved on to the next cell. The detainee then called (b)(3):10 USC §130b,(b)(6),(b)(7)(C) and I back to the cell. When I opened the feed tray to remove the cup, he ripped it up and started to push it through the grates of the cell. Despite the guards, both (b)(3):10 USC §130b,(b)(6),(b)(7)(C) and mine, request to put the cup on the feedtray, the detainee pushed the cup out of the grates and onto the floor.

I, (b)(3):10 USC §130b,(b)(6),(b)(7)(C), WHILE PERFORMING SHOWER AND REC. ACTIVITIES IN (b)(2) BLOCK, (b)(1),(b)(2),(b)(1) Sec (b)(2) 00693 (b)(1) WAS PLACED IN THE RIGHT SIDE REC. AREA. WHILE THE RESTRAINTS WERE BEING REMOVED, I DIRECTED THE DETAINEE THERE IS TO BE NO CROSS BLOCK COMMUNICATION AND NO PHYSICAL CONTACT WITH THE OTHER REC. AREA. ONCE THE (b)(2) WERE REMOVED, HE REACHED THROUGH THE BEAM HOLE AND CLASPED HANDS WITH (b)(2) (ISMA DP) WHO WAS IN THE OTHER REC. AREA. (b)(2) WAS ALSO DIRECTED ABOUT THE NO COMMUNICATION AND NO PHYSICAL CONTACT. WHEN THE TWO DETAINEES CLASPED HANDS THROUGH THE BEAM HOLES, I YELLED "NO" AND TOLD THEM TO STOP. NEITHER COMPLIED SO I DIRECTED (b)(3):10 USC §130b,(b)(6),(b)(7)(C) TO SECURE A WRIST ON EACH DETAINEE TO BREAK THE PHYSICAL CONTACT.
