At approx. 1930 HRS, ON 4 NOV 03, I sent (b)(3):10 USC §130b,(b)(6),(b)(7)(C) to collect CI From (b)(1) (ISN# (b)(2) 000693DP) who had just been put on punishment. (b)(1),(b)(2),(b)(1) had been put on (b)(2) for Failure to follow MP instructions, ~~est~~ from earlier today. (b)(3):10 USC §130b,(b)(6),(b)(7)(C) returned a few minutes later, and stated (b)(2) refused to (b)(2). I then proceeded to cell (b)(1),(b)(2), and ordered him to (b)(2) multiple times and he refused. He said he did nothing wrong and wanted an arabic interpreter. I then notified the SO6 who arrived at approx 1925 HRS. The SO6 then ordered (b)(2) to (b)(2) and the detainee refused stating he did nothing wrong and wanting an arabic interpreter. The SO6 then notified PL1 who arrived at approx 1928. (b)(2) refused to (b)(2) to the PL multiple times, also stating the same two things. The PL then instructed me to ~~not~~ contact the interpreter with out any contact, and escort him off the block to (b)(2) the detainee contacted CO who came on the block at approx. 1955 (b)(3):10 1940. (b)(2) refused. PL1 then contacted CO multiple times when ordered to (b)(2) then refused the CO. The CO then had me turn the water off to cell (b)(2) and step to the bean hole. Contact an arabic interpreter. No contact was made with any interpreter and attempted to the block. The PL, SO6, and (b)(2) block staff then went to (b)(2) and the C.O. left detainee to step to the bean hole. 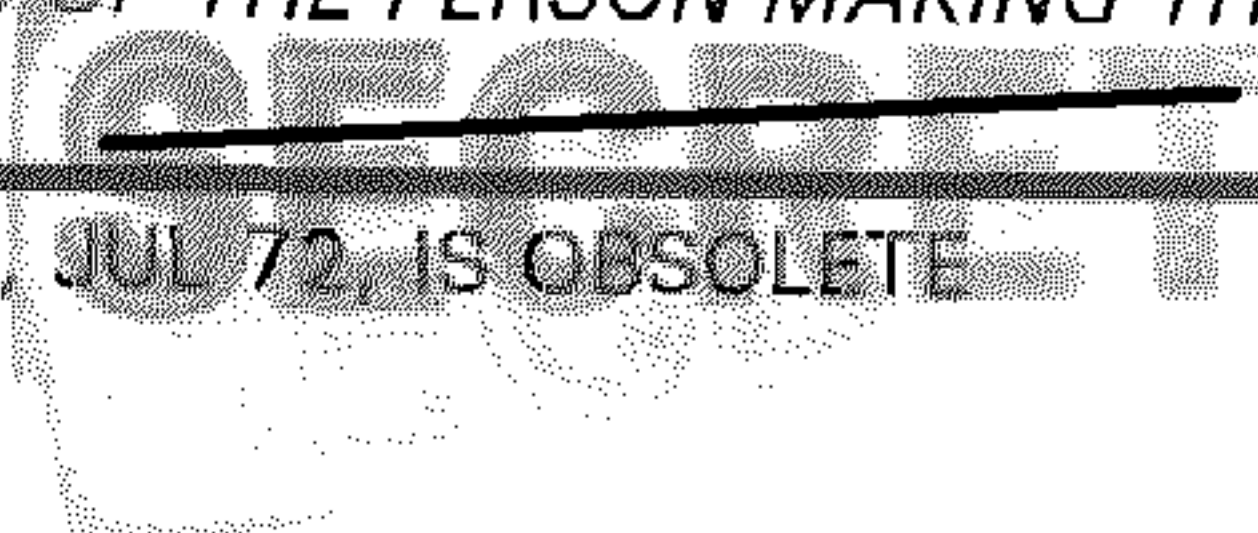
