- 23 scrambled out of Otis in response, but have not
- 24 intercepted. FAA, provide an update? Is FAA in the
- 25 conference? Joint Forces Command provide an update.

- 25 that we reconvene this conference when further information

- 6 air defense emergency at this point. And, NORAD recommends
- 7 that this conference be reconvened when further information
- 8 and unconflicted reports are available. NORAD complete.
