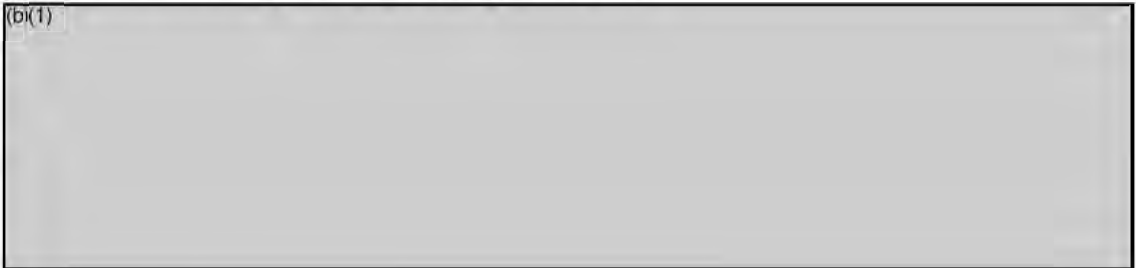
Russia and the Baltic States (U)

Subject: US-Russia Cooperation in the Campaign Against Terrorism

1. (U) Purpose. To inform VADM Doran about ongoing US-Russian military cooperation in the Campaign Against Terrorism.

2. (U) Key Points.

- (U) President Putin has announced a number of initiatives to cooperate with the United States in the campaign against terrorism. It is obvious that he has backed up his words with action; we are experiencing a greater level of cooperation with the Russian military than ever before.

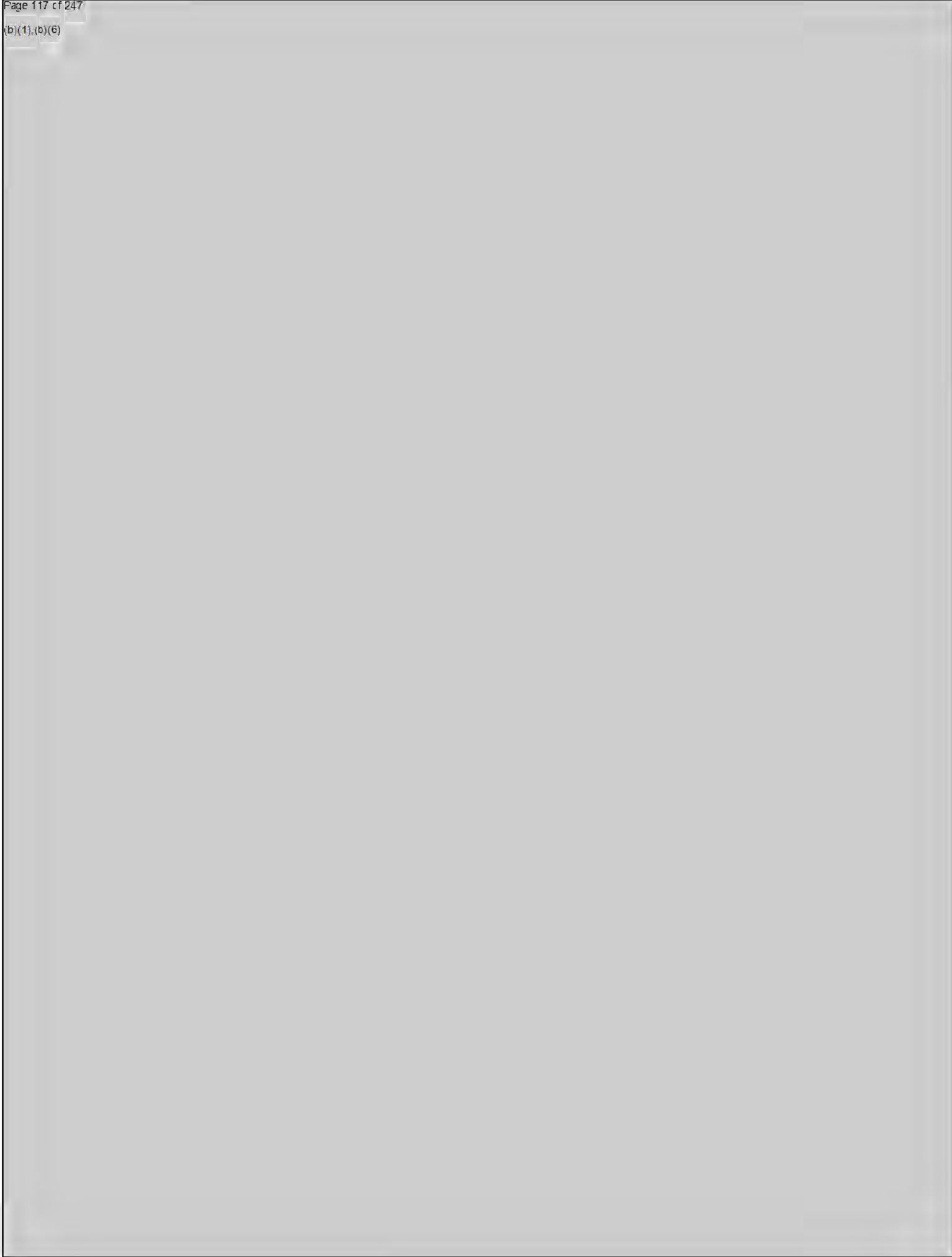

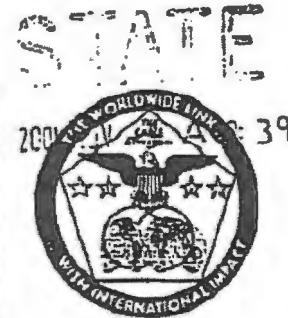

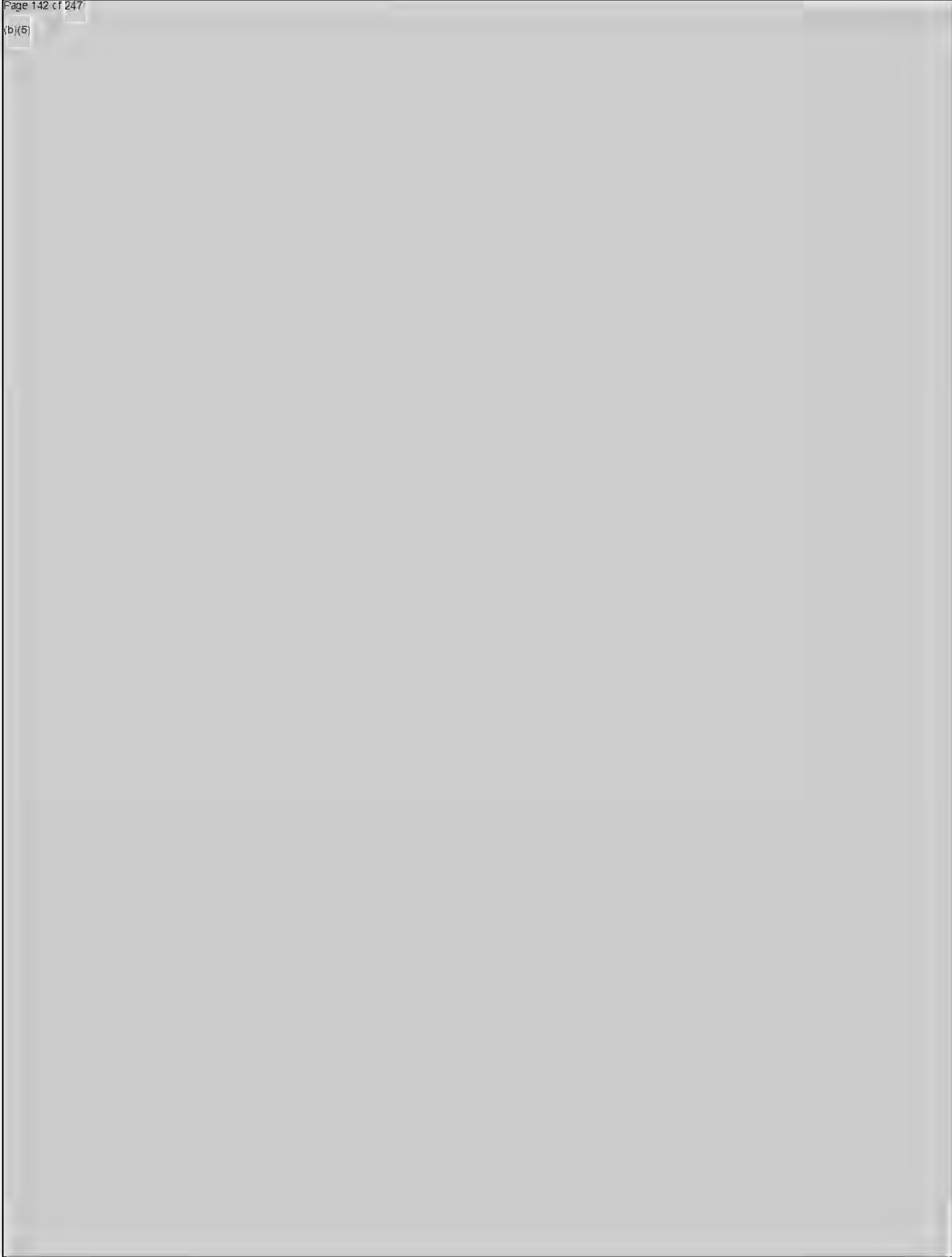
