

2. POST HAS NOT RECEIVED ANY FMF ASSISTANCE SINCE FY 1995. THE FY 2003 FIGURES WILL THEREFORE BE USED AS THE BASIS FOR FORMULATING FY 2004 AND 2005 REQUESTS.

FMF PROJECTIONS FOR THESE LATTER TWO YEARS ARE NOT YET AVAILABLE. IN FY 2002, POST WILL RECEIVE USD 1,144,000 IN IMET FUNDS. FOR FY 2003-5, THE NUMBERS ARE USD 1,258,400, 1,384,240, AND 1,522,664.
