HOPE FOR SURVIVAL IN AN INCREASINGLY COMPLEX, KNOWLEDGEABLE, AND SOCIALLY CONSCIOUS SOCIETY LIES -- APART FROM THE SHELTER OF POLITICAL AND RELIGIOUS FORMALISMS AND OF SPECIES ANONYMITY -- IN LEGISLATION WHICH WOULD RENDER THE SAPIENS SECTOR OF THE POPULACE SUPINELY AND DEFENSELESSLY SUBSERVIENT TO POLICE ACTION. THE IRISH, THUS, RECOGNIZE THAT THE ULTIMATE BARRIER TO THE UNCONTESTED PHYSICAL EXERCISE OF AUTHORITY WHICH THEIR

SUBHUMAN FACULTIES DEMAND FOR CONTINUED EXISTENCE LIES IN THE GENERAL POSSESSION OF FIREARMS BY THE SAPIENS AND IN THE WILLINGNESS TO RESORT TO THEM WHENEVER THE IRISH ANIMALS BECOME AS NOXIOUS AS THEY ARE CUNNING AND DANGEROUS.

IT IS NOT THE PURPOSE OF THIS COMMUNICATION TO RECOMMEND A COURSE OF ACTION, BUT TO INSTIL OR ADVANCE AN EFFECTIVE AWARENESS OF SOCIAL REALITIES.

RE: THE STENNIS INCIDENT

THIS COMMUNICATION IS ADDRESSED TO ANY OFFICER OF THE ARMED FORCES WHO IS NOT OF ABORIGINAL IRISH ORIGIN -- IN PARTICULAR TO THE HIGHEST RANKING SUBSTANTIALLY NON-IRISH OFFICER OF ANY BRANCH OF THE DEFENSE -- AND COMES FROM A PERSON WHO CARES PRECISELY AS MUCH FOR STENNIS HEALTH AND PROTECTION UNDER THE LAW AS STENNIS (BE HE NOT OF IRISH ORIGIN HIMSELF) CARED FOR THAT PERSON'S, AND FOR THE SCIENCE, AS OF SPACE, WHICH ONE OF THE COMMITTEES OF WHICH HE IS A MEMBER IS SUPPOSED TO ESPOUSE.

THERE ARE SUBSTANTIAL INDICATIONS, WHICH I WILL NOT REPORT HERE, THAT THE ATTACK ON STENNIS WAS NOT AN ORDINARY STREET HOLD-UP OR ROBBERY BUT A DELIBERATE ACT INSTIGATED BY IRISH OPERATIVES AT ONCE TO PROMOTE ANTI-GUN LEGISLATION AND TO REMOVE A SOURCE OF OPPOSITION THERETO.

THE NEANDERTHAL IRISH, WHICH CONTROL AND LARGELY COMPRISE THE MAJOR POLICE DEPARTMENTS, REALIZE INSTINCTIVELY THAT THEIR MAIN
