2.C. OPERATIONAL PREPARATION OF THE ENVIRONMENT (OPE). OPE IS

THE CONDUCT OF ACTIVITIES IN LIKELY OR POTENTIAL AREAS OF OPERATIONS TO PREPARE AND SHAPE THE OPERATIONAL ENVIRONMENT. COMBATANT COMMANDERS CONDUCT OPE TO DEVELOP KNOWLEDGE OF THE OPERATIONAL

ENVIRONMENT, ESTABLISH HUMAN AND PHYSICAL INFRASTRUCTURE, ESTABLISH INFLUENTIAL ACCESS POINTS, AND FOR GENERAL TARGET DEVELOPMENT. OPE ACTIVITIES INCLUDE, BUT ARE NOT LIMITED TO: PASSIVE OBSERVATION; AREA FAMILIARIZATION; SITE SURVEYS; MAPPING THE INFORMATION ENVIRONMENT; OPERATIONAL USE OF INDIVIDUALS; DEVELOPING NAR CAPABILITIES; USE OF COURIERS; DEVELOPING SAFE HOUSES AND ASSEMBLY AREAS; POSITIONING TRANSPORTATION ASSETS; AND CACHE EQUIPMENT RECOVERY.

- 2.D. ADVANCED FORCE OPERATIONS (AFO). AFO ARE CONDUCTED TO REFINE THE LOCATION OF SPECIFIC, IDENTIFIED TARGETS AND FURTHER DEVELOP THE OPERATIONAL ENVIRONMENT.
