



4.A. (U) Funding.

4.A.1. (U) The military departments, USSOCOM, and participating defense agencies will fund all costs incurred as a result of military operations under this order and will report incremental costs through their respective Military Department or agency comptrollers to the Defense Finance and Accounting Service (DFAS) in accordance with DoD Financial Management Regulation (FMR) 7100.14-R, Volume 12, Chapter 23.

4.A.2. (U) Logistics support to foreign forces may be provided on a reimbursable basis pursuant to an applicable acquisition and cross-servicing agreement or, when appropriately approved, pursuant to applicable statutory authority for non-reimbursable support.

4.A.3. (S/REL USA, FVEY) The SecDef has designated operations under this order as a "contingency operation" as that term is defined in Section 101(a)(13) of Title 10, U.S. Code.

4.B. (U) Public Affairs Guidance. USAFRICOM, in consultation with the Chief of Mission, OJCS(PA), and OSD(PA), will maintain an active public affairs posture for direct action in Somalia. Unless operational considerations dictate otherwise, DoD will acknowledge all of its direct action operations, disclose the results in a press release, and dispute any false or inaccurate claims of collateral damage.
