SUBJECT: Minutes of the Non-Proliferation PCC (U)

The following decisions were reached at a meeting of the Non-Proliferation PCC chaired by Assistant Secretary of State Richard A. Clarke on December 14, 1990. (U)

1. Each agency shall designate an attorney to a Commerce-chaired legal committee to decide on the need for, and begin drafting of, a law or regulation providing sanctions against U.S. citizens knowing participation in foreign CW and missile programs. Terms of reference should be circulated early the week of December 17. ~~(S)~~
2. CBW Working Group shall distribute a list of dual-use CBW goods, services, and technology by December 21. ~~(S)~~
3. The MTCR Annex Review Committee will submit its draft lists of items, countries, and projects of concern to the PCC for approval by December 21. ~~(S)~~
4. Department of Commerce will circulate draft regulations interagency regarding chemical plants with CW potential by December 21. ~~(S)~~
5. Department of State, with intelligence community input, will circulate a draft list of CBW and missile countries, projects, organizations, etc., of concern by December 17. ~~(S)~~
6. Department of Commerce shall circulate draft regulations for requiring licenses for the 50 Australia Group warning-list precursors by December 31. ~~(S)~~
7. Department of Commerce shall circulate a draft regulation requiring license for export or exporter "knows or is informed" by Commerce that export may be destined for a CBW or missile project interagency by December 31. ~~(S)~~
8. Each PCC Subcommittee shall create a Sanctions Working Group, which shall hold an organizational meeting by early next week and provide a list of proposed countries or persons to be sanctioned to the PCC by December 31. ~~(S)~~
9. Department of State will submit an interagency-cleared memorandum to Scowcroft notifying him of the establishment of the chartered groups as per NSD 53. ~~(S)~~
10. The milestone plans for the implementation of the new export control measures shall be amended to include multilateral efforts to widen adherence to such measures the week of December 17. ~~(S)~~
11. Department of State will contact the Australian Embassy the week of December 17 to coordinate on the Australian chart showing countries and controls in the CBW field. ~~(S)~~



12. Department of State will chair a group (including INS and Justice) to analyze import of changes in U.S. immigration laws for nonproliferation policy. ACDA shall supply a memorandum on how this interaction functions in the nuclear field. The State-chaired group will work a view toward drafting regulations implementing the Immigration Act of 1990. Work will commence in January. ~~(S)~~

13. Commerce will circulate a draft regulation and foreign policy report on extending foreign policy controls by December 19. ~~(S)~~

14. The PCC shall take up the issue of supercomputers in January. ~~(S)~~

In addition, the Department of Defense shall draft a memorandum analyzing the effect of existing and proposed re-export controls for dual-use items on U.S. nonproliferation objectives, and setting for the options for PCC consideration by January 7.
