SUBJECT: Response to State on Non-Proliferation Approach to
East European Governments (U)

The paper outlining an approach to East European governments on
missile and chemical weapons non-proliferation is to be commended
for its thoroughness and timeliness. NSC concurs with the
general approach, with the following additions:

With respect to Bulgaria and Romania, we recommend that the
offer of a follow-up briefing team from Washington should
await the scheduled elections and the formation of new
governments.

In the initial demarche to the East Europeans, there should
be a general statement of our broad non-proliferation
concerns, and of our continuing efforts to engage other
countries in the endeavor to stem proliferation. It should
also solicit the East European government's views on the
problem.

The demarche should be made to the East Europeans, where
appropriate, as soon as possible.
