SUBJECT: Iraqi National Congress (INC) Information Collection Program (ICP) in FY 04

You asked for comments and recommendations regarding the future of this program.

- Major General Dayton's memorandum (Tab B to Vice Admiral Jacoby's memorandum) states the high value of the ICP to the efforts of the Iraq Survey Group (ISG). The ICP has also produced other significant actionable information.
 - The ICP gives us access to the work of INC interrogators and analysts who bring native Iraqi insight to their tasks.
 - In light of the shortage of cleared interpreters in Iraq, this access has enhanced value.
- In the current unsettled circumstances in Iraq we should not cut our ties to a highly productive intelligence source.
- Vice Admiral Jacoby's suggestion that the contract be extended for six months, rather than a full year, would provide flexibility and control.
- [REDACTED] notification to Congress should include a briefing that describes the payoff from Congress' investment in the ICP, based on the facts reported by MG Dayton.
