SUBJECT: Payment of Free Iraqi Force (FIF) Salaries using Emergency and
Extraordinary Expenses (E³) Authority *(S)*

- *(S)* I recommend you sign the attached memorandum that increases the Chairman of the Joint Chiefs of Staff's E³ limitation by \$300 thousand (Tab A). This increase is necessary to ensure FIF volunteers are paid on time.
- *(S)* This assumes that you approve USD(Policy)'s recommendation to use E³ authority for this purpose (Tab B).
- *(S)* Department of State (DoS) has agreed to pay up to \$2.3 million of FIF salaries out of Economic Support Funds. However, DoS has not yet submitted the congressional notification required to transfer the funds to DoD.
- *(S)* Since it appears the transfer of Economic Support Funds from DoS will be delayed, the use of E³ authority will ensure funds are available for the first pay day on February 15, 2003. If DoS transfers the funds by February 12th, the use of E³ authority will not be required.
