~~(S)~~ We need conceptual clarity on what the post-27 January case against Iraq will consist of, and I am not sure we have it yet. My concept is as follows:

~~(S)~~ In addition to the false declaration of 7 December, there are five elements in the necessary demonstration of non-cooperation:

- what UNMOVIC might find at inspected sites;
- what UNMOVIC challenges Iraq to disclose (e.g., mobile BW) whose location we do not know;
- results of the interview process (or lack thereof);
- Iraqi denial and deception, of which there is mounting evidence; and
- information we put out independently (as per the ISP memo) to demonstrate Iraq's overall policy of lying about its WMD,

~~(S)~~ We are already seeking to assist UNMOVIC in the first two categories. We need to prepare our declaratory policy in the last three categories:

- If the interview process breaks down, we need to prepare our explanation of why it happened:
 - In a police state, you can't get the truth.

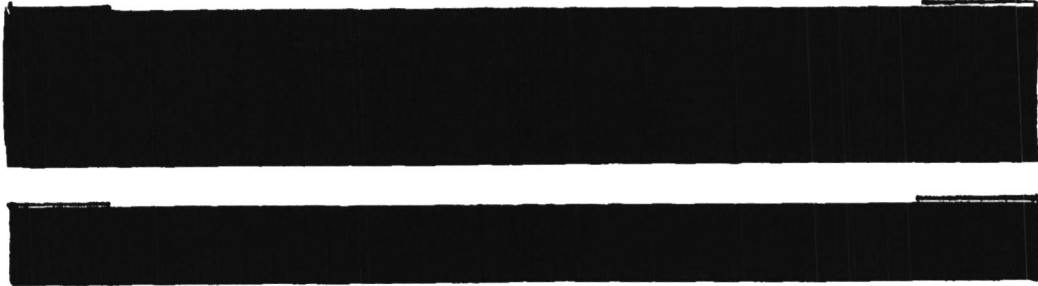
