CORRECTLY POINTED OUT THAT THE NRRC MESSAGE IN QUESTION WAS
IN FACT ONLY A CONSOLIDATED LIST COMPILED FROM EARLIER
LISTS WHICH THE DUTCH GOVERNMENTS HAD ACCEPTED. POST MAY
DRAW FROM THE FOLLOWING ADDITIONAL INFORMATION IN
RESPONDING FURTHER TO APPROPRIATE DUTCH OFFICIALS.
