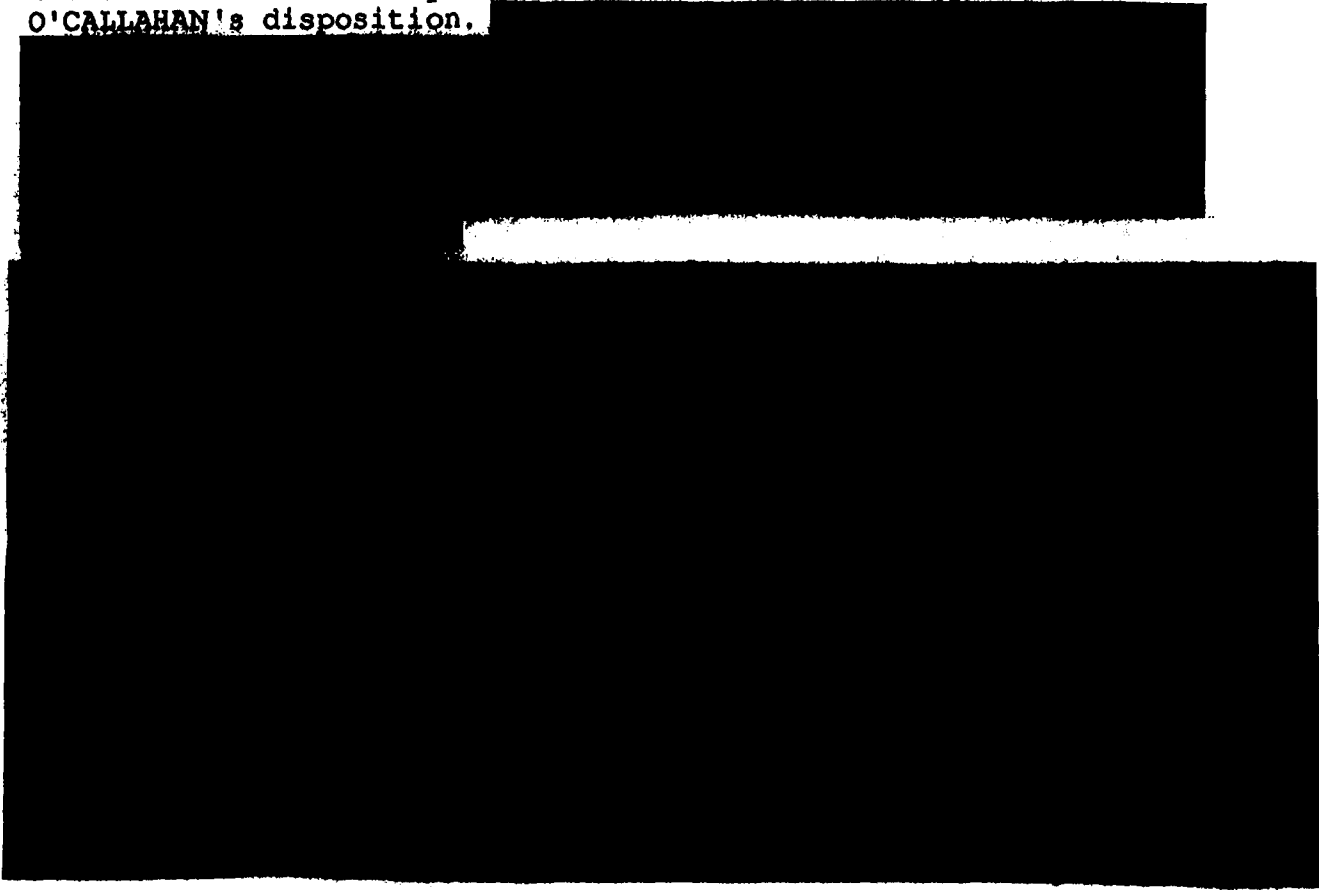
SUBJECT: Pakistan: Leased Ships and F-16s (U)

(U) In 1988, Navy leased eight BROOKE/GARCIA class frigates and a repair ship to Pakistan. The ships were transferred on short-term leases timed to expire when the amortized value of the ships fell below their salvage value. Navy planned to renew the leases at no cost and for perpetuity. One lease, on the former USS O'CALLAHAN, expired in January 1991; the remainder expire in 1993 and 1994.

(U) We have been advised by General Counsel that the O'CALLAHAN lease cannot be renewed because of the Pressler Amendment and that Navy should be directed to arrange for O'CALLAHAN's disposition.

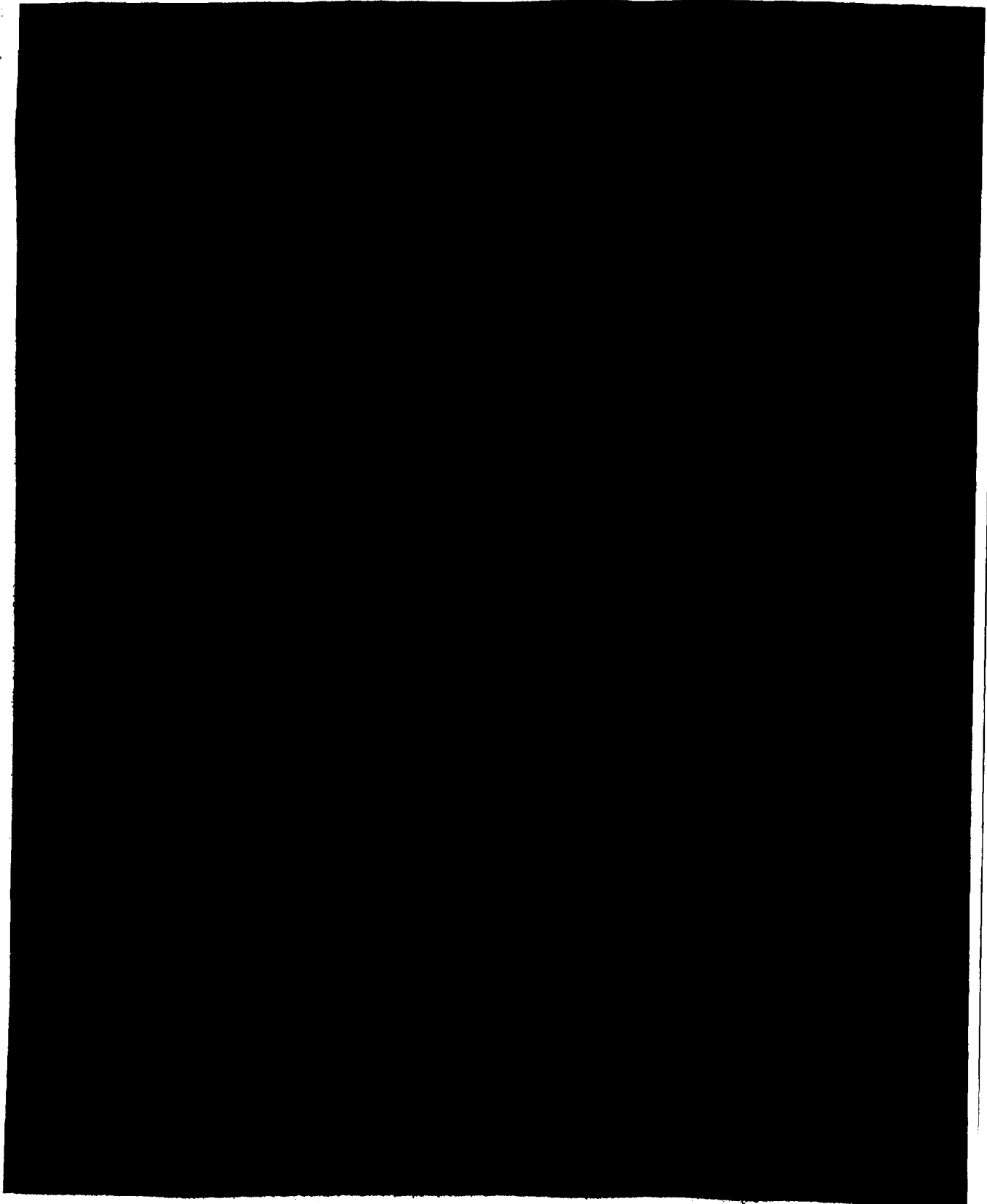

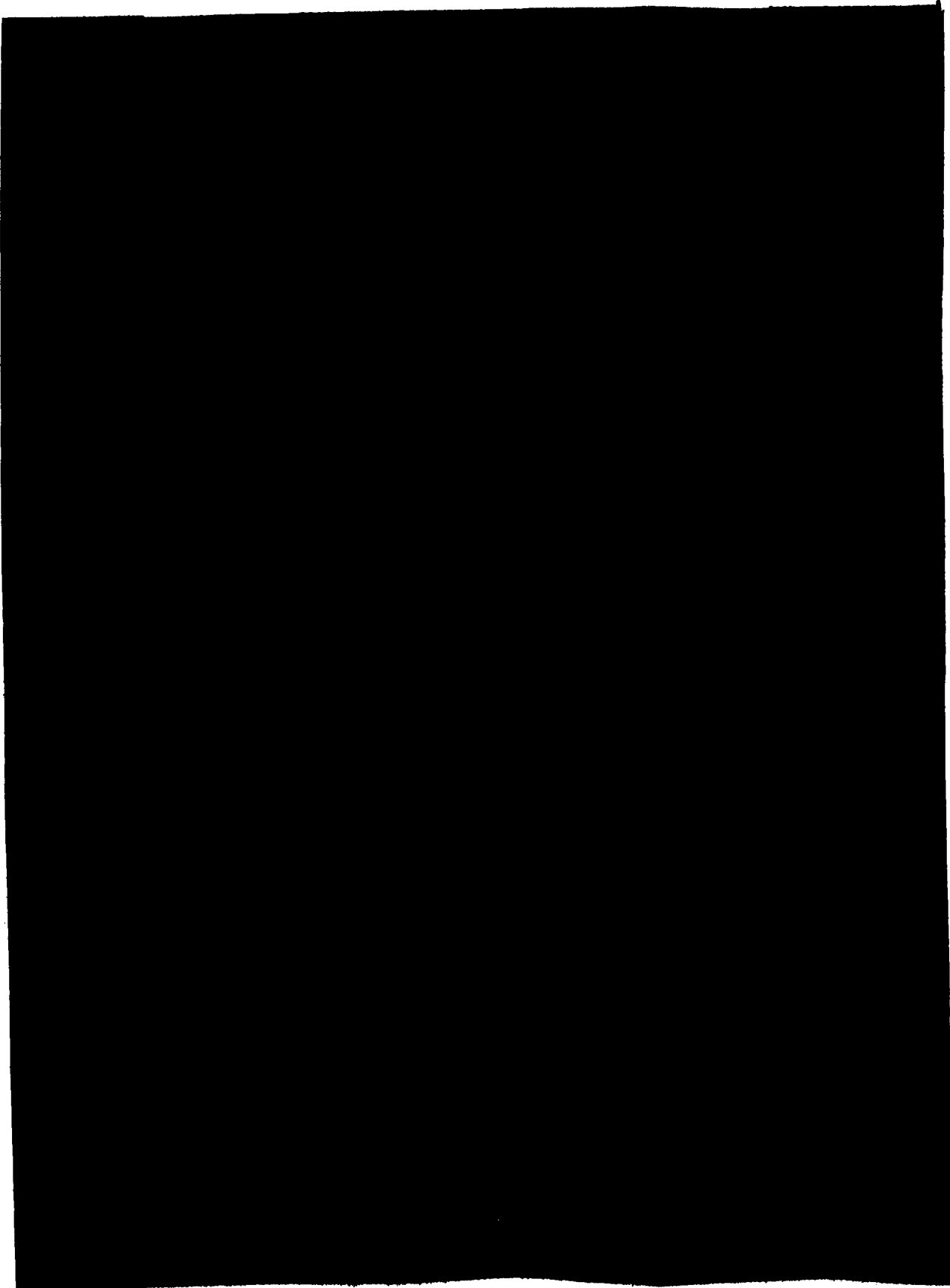

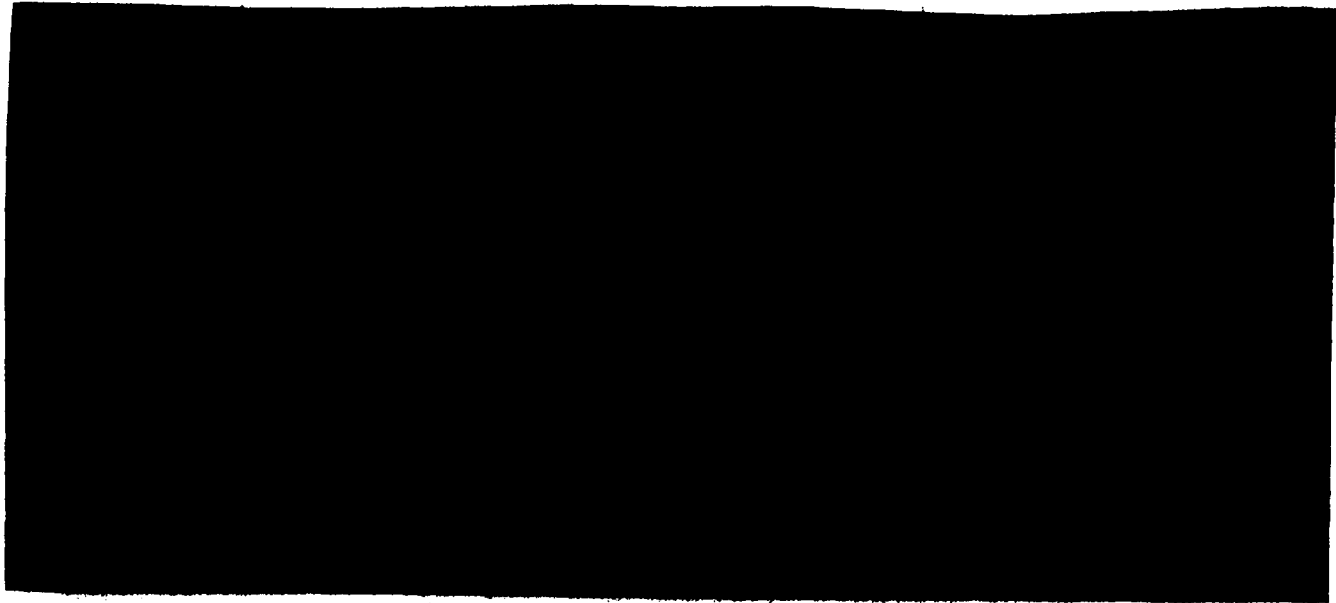
