PURPOSE: To propose plenary meeting between SECDEF and Afghanistan President Hamid Karzai on 14 or 15 June. 19 MAY 2004

DESCRIPTION:

- President Karzai is *state Dept* coming to US to attend G-8 meeting in Georgia, and to see President Bush (see attached briefing).
- Also meeting with SecState, NSA Rice, AG Ashcroft (exact schedule still TBD).
- This is President Karzai's first US visit since Feb 03.

DATE/TIME: 14 June, or early on 15th (possible breakfast).
