SUBJECT: REQUEST FOR EXECUTIVE AGENT SUPPORT

Gen. (ret) Abdul R. Wardak, 1st Deputy Minister of Defense of Afghanistan, will visit the United States 18-25 July 2004 to hold a Counterpart Visit with the Deputy Secretary of Defense and to meet with members of Congress.

We request that you appoint an Executive Agent to assist with arrangements for this visit. This visit will be funded using Policy travel funds and ORF funds.

Deputy Minister Wardak and his delegation are scheduled to arrive in Washington, DC on July 19. He is scheduled to meet with the Deputy Secretary of Defense on July 21. His delegation will also meet with members of Congress. The entire delegation will depart Washington, DC on July 25. Exact details of the visit are currently being coordinated with the appropriate offices.

Deputy Minister Wardak will be accompanied by five official delegates and two interpreters. Lodging, local transport, meals, and security will be required.
