I AM ALSO VERY ANGRY, AS I ASSUME HE IS, ABOUT THE MISREPRESENTATION OF WHAT TOOK PLACE IN OUR NEW YORK MEETING.

2. ~~000~~ ON THE MATTER OF CONSULTATIONS, HOWEVER, AS I RECALL, YOU WENT IN TO SEE KIM ONE WEEK BEFORE THE MOST RECENT PRESIDENT'S LETTER ARRIVED AT THE BLUE HOUSE. I SHARE YOUR FEELING THAT IT MIGHT HAVE BEEN USEFUL TO PROCEED MORE SLOWLY, BUT I DO THINK WE GAVE THEM A REASONABLE AMOUNT OF TIME.

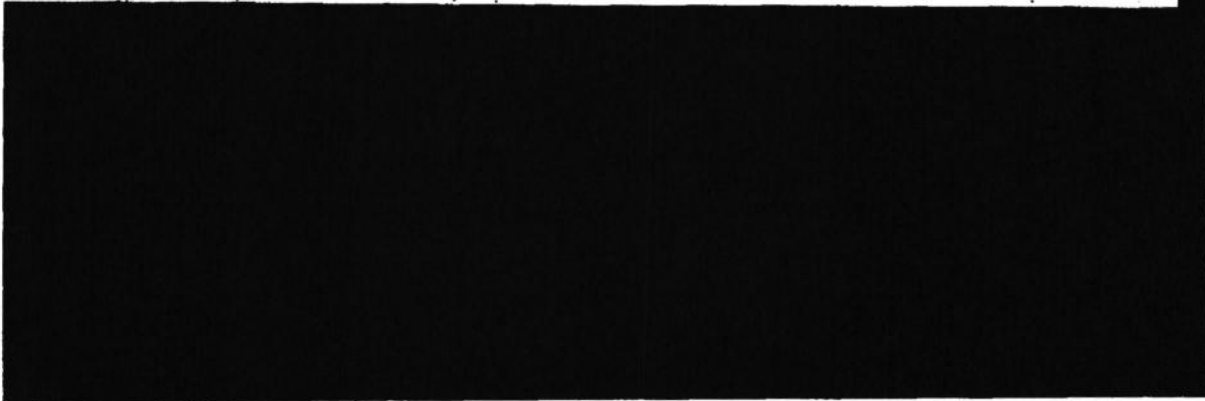
ALTHOUGH WE DO NOT BELIEVE "COMPENSATION" IS NECESSARY, WE DO TAKE SERIOUSLY ANY SIGNAL THAT COULD BE ERRONEOUSLY INTERPRETED BY BOTH THE NORTH AND THE SOUTH REGARDING THE STRENGTH OF OUR COMMITMENTS AND WE BELIEVE THERE ARE A NUMBER OF CONVENTIONAL STEPS THAT WILL NOT ONLY REINFORCE DETERRENCE BUT ALSO INCREASE THE PRESSURE ON NORTH KOREA TO DEAL WITH THE NUCLEAR PROBLEM. ALTHOUGH THERE IS LITTLE I CAN TELL THE KOREANS AT THIS POINT, WE ARE WORKING TO GET A PACKAGE TOGETHER BY THE TIME OF THE SCH/RCH, AND IF WE DO, WE CAN TRY TO GET SOME INFORMATION OUT TO KIM RIGHT BEFORE THAT.

5. PLEASE CONVEY TO KIM MY REGARDS AND MY SENTIMENTS REGARDING THE LEAK. PLEASE ALSO LET HIM KNOW THE DIFFICULTIES
