OF BRIGHT LIGHT READ-OUT LISTS AF LT. ERIC JAMES HUBERT AS
MIA AFTER MAY 12, 1970 F-4D MISSION AT COORDINATES YA 817936
(NORTHEAST TIP OF CAMBODIA).
2. WE WILL, OF COURSE, BE UNABLE TO PROVIDE MISS HUBERT
ANY INFORMATION OTHER THAN THAT CARRIED IN BRIGHT LIGHT
READ-OUT AND BELIEVE SHE WILL BE UNABLE TO ELICIT ANY
INFORMATION WHATSOEVER FROM KHMER BECAUSE AREA IN WHICH HER
BROTHER'S PLANE DISAPPEARED WAS NOT UNDER GKR CONTROL
EVEN BEFORE OUTBREAK OF WAR. THE AREA IS SO DISTANT FROM

REQUEST WASHINGTON ACKNOWLEDGE TELEGRAM AND ADVISE CONGRESSMAN WILSON AND MISS HUBERT THAT ALTHOUGH HER VISIT IS UNLIKELY TO PRODUCE ANY INFORMATION HERE SHE IS WELCOME AND WILL BE AFFORDED ANY ASSISTANCE WE CAN GIVE. WOULD APPRECIATE ANY OTHER DETAILS WASHINGTON OR NKP MIGHT HAVE ON THIS PARTICULAR CASE INCLUDING FURTHER INFORMATION HE MIGHT SHARE WITH MISS HUBERT SHOULD SHE CALL AT EMBASSY.
