SUBJECT: Afghan Prison Refurbishment (U)

- In the message at Tab A, Ambassador Khalilzad elaborates on ideas for a counternarcotics strategy that he discussed during your trip to Afghanistan.
- One of the points he raises is a need to build and refurbish a prison, namely Pol-I-Charki Cell Block B.
- You asked us to work with Embassy Kabul to determine the best option for accomplishing the refurbishment.
- Embassy Kabul has determined that the refurbishment will be funded through the Department of State's Bureau for International Narcotics and Law Enforcement Affairs and the United Nations Office of Drug Control Policy.

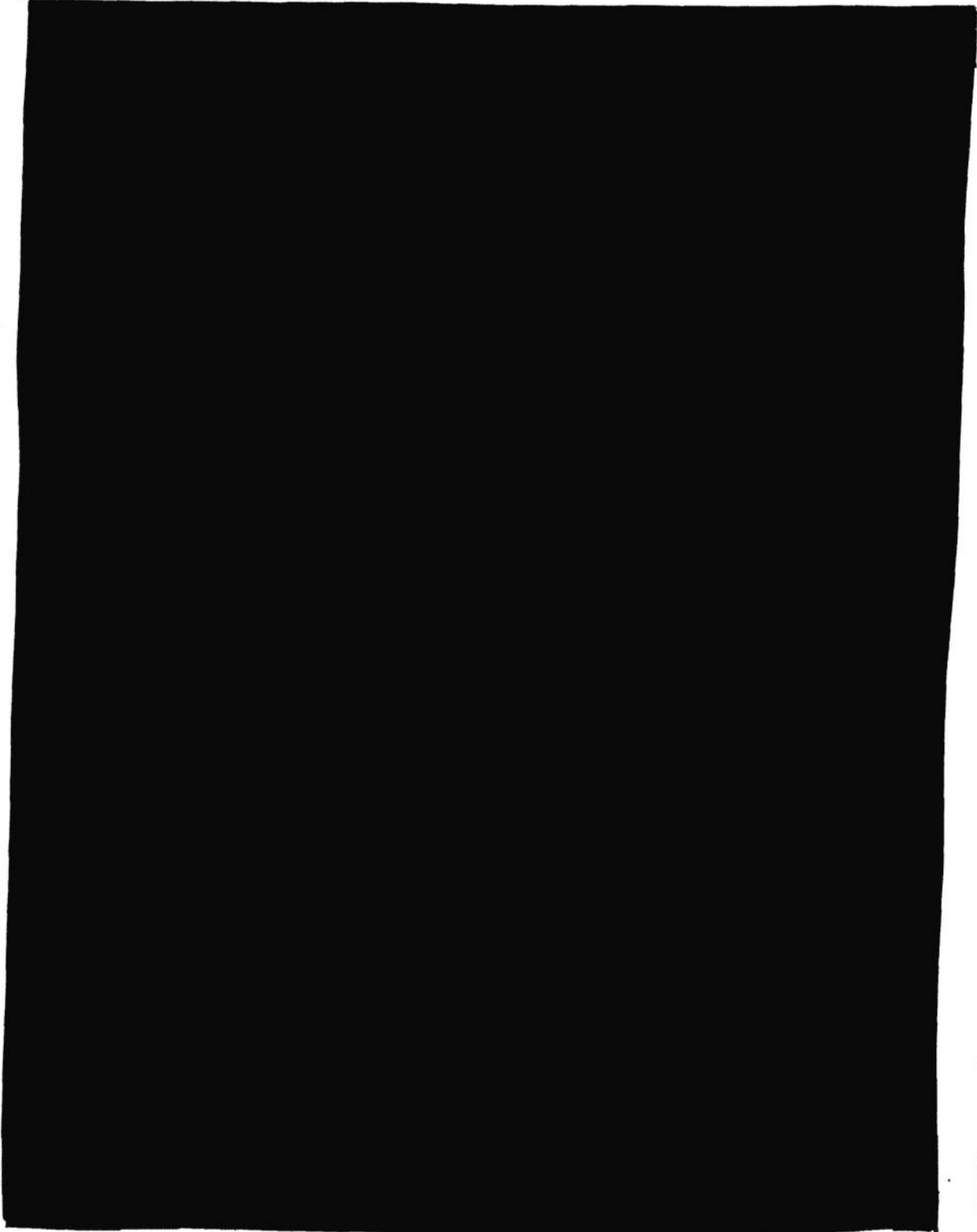

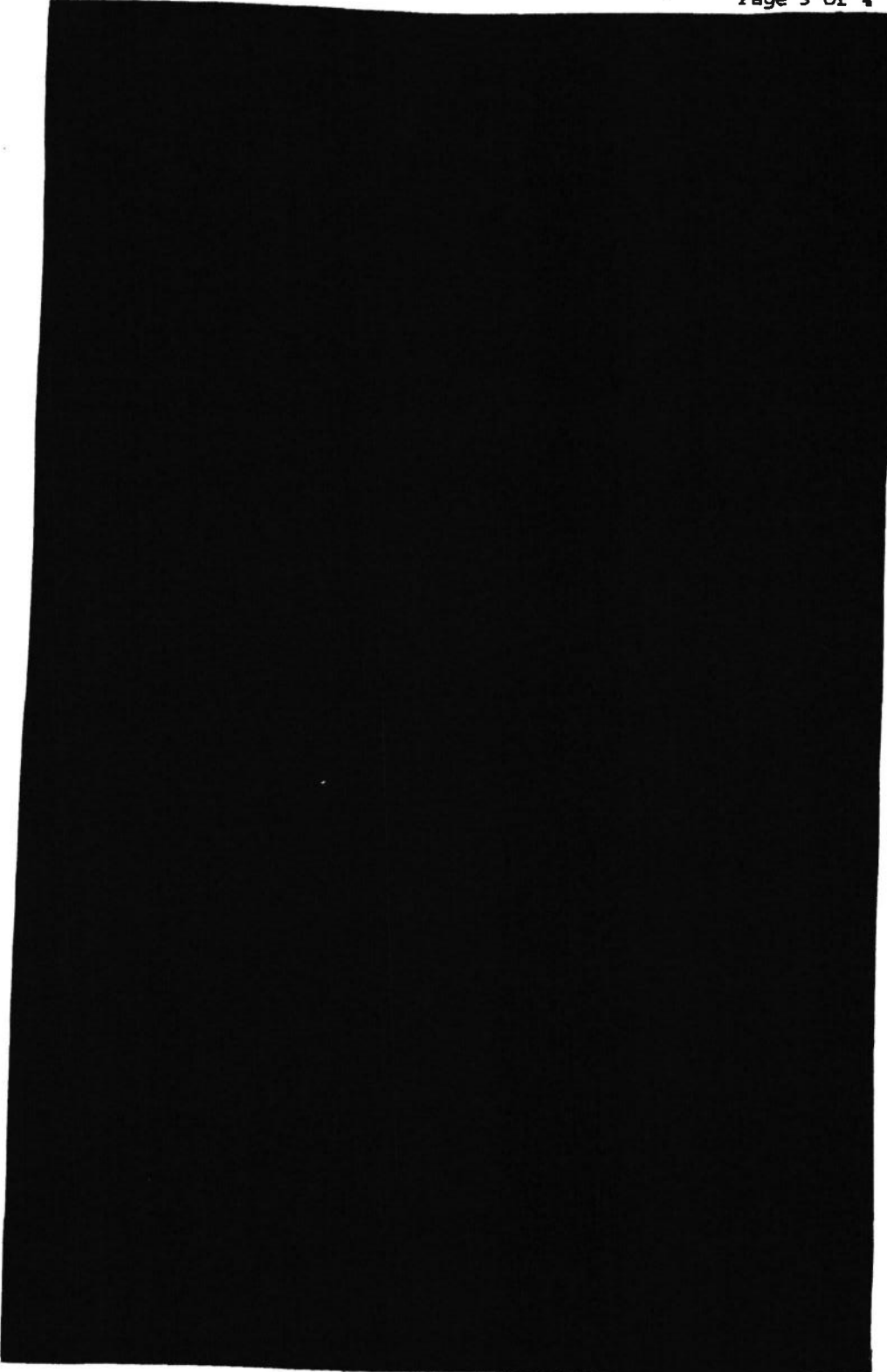
